DECLAMATIONS RULES AND SCORING

- 1. Declamation competition is for persons out of high school, up to age 30, unmarried.
- 2. Any number of participants may enter from each church.
- 3. The declamation must be a memorized speech, 3-5 minutes, either self-written or from the Rally Literature.
- 4. No written materials are allowed during competition.
- 5. Each participant must provide three copies of their written declamation; one for each Judge.
- 6. Three Judges from outside the rally are selected by the host church. These Judges can be the same ones judging the Youth Choir.
- 7. Judges are seated in separate areas of the church and scores are not compared.
- 8. One Judge will be selected by the host church to sit in the front to serve as prompter for the participants.
- 9. The Declamation Score Sheet will be completed by each Judge for each participant.
- 10. The Judges' scores will be entered on the Declamation Summary Sheet to obtain the final score and determine the winner.
