- 2. Exterior Materials & colors- A paint pallet is available and must be used. To receive approval; sample colors must be attached to the form and 12x12 inch' squares of the selected colors must be painted on the garage door. Sample of roof tiles should be put in the front of garage door for inspection by the ARC committee for approval. See ARC Standards, section B for more details.
- **a.** If approval is granted, <u>it is not to be construed to cover approval of any County or City Code Requirements.</u> A building permit from the appropriate building department is needed on most property alterations and/or improvements.
- **b.** As a condition precedent to granting approval of any request for a change, alteration or addition to an existing basic structure is that the applicant, their hires and assigns thereto, hereby assume sole responsibility for the repair, maintenance or replacement of any such change, alteration or addition. AND SOLEIL PROPERTY MANAGEMENT, ET AL, ARE NOT REQUIRED TO TAKE ANY ACTION TO REPAIR, REPLACE OR MAINTAIN ANY SUCH APPROVED CHANGE, ALTERATION OR ADDITION, OR ANY STRUCTURE OR ANY OTHER PROPERTY. THE UNIT OWNER AND ITS' ASSIGNS ASSUMES ALL RESPONSIBILITY AND COST FOR ANY ADDITION OR CHANGE AND ITS FUTURE UPKEEP AND MAINTENANCE.
