#### **Discussion Points and Resolutions:**

#### 1. Document Review and Purpose:

- The current iteration (Version 2.1.3.2) of "The Black Flag: Blueprint for Global Expansion and Social Transformation" was reviewed after two days of styling, formatting, and recalculating mathematical components.
- The document is deemed crucial for presentations to potential lenders and investors and could serve as supporting evidence in ongoing litigation to demonstrate fiscal damages and operational hindrance caused by withheld assets.
- No vote was taken on its use as an exhibit, as this requires a separate convergence.

# 2. Approval for Presentation:

 A unanimous vote confirmed that the document is acceptable for presentation to potential lenders and investors if the opportunity arises in the coming week.

## 3. OA and Stable Release Candidate Status:

- The metrics and calculations within the document must undergo Quality Assurance (QA) review.
- If no changes are required, this version will be considered a **stable release candidate**.

- If minor discrepancies are identified in the equations, a patch update will be issued.
- If a decision is made to include formulae as an appendix, this would constitute a build update.
- QA and approval of the math are prerequisites for proceeding with the development of a pitch deck and rehearsed presentation.

#### 4. Website Publication Consideration:

- The possibility of publishing the document on the website was discussed. While it could attract funding, it may also create a **security vulnerability** if released before funding is secured.
- A future convergence will be called to vote on this matter.

## 5. Timeline for Next Steps:

 Math verification and approval are expected to be completed over the weekend or early in the week, as potential investor meetings are anticipated on **Monday**, **Tuesday**, and **Thursday**.

#### **Resolutions:**

- 1. The document (Version 2.1.3.2) is approved for presentation to lenders and investors pending math verification.
- 2. QA review of the metrics will determine its status as a **stable release candidate**, **patch update**, or **build update**.
- 3. A separate convergence will decide on its use as an exhibit in litigation and the publication strategy for the website.
