STANDARD VISITATION SCHEDULE

EXHIBIT "A"

The non-custodial parent shall have reasonable and specific visitation as follows:

2. HOLIDAYS: Alternating holidays, with the non-custodial parent to have the child(ren) with him on Memorial Day Weekend, Labor Day Weekend, Thanksgiving holidays (6:00 p.m. on the ________ immediately preceding Thanksgiving until the Sunday immediately after thanksgiving at 6:00 p.m.), and New Years's Day (Dec. 26th at 12:00 p.m. until January 2nd at 6:00 p.m.) in even-numbered years, and on Easter holidays (12:00 p.m. on Good Friday until Easter Sunday to 6:00 p.m.), Independence Day (weekend if applicable) and Christmas (6:00 pm on December 17th until 12:00 p.m. Dec. 26th), and during Spring Break in odd-numbered years. The custodial parent shall have the reverse holiday schedule.

3. SPRING BREAK: The non-custodial paren shall have the child(ren) with him for the week of spring break (Monday through Friday); in addition to regular weekend visitation in odd-numbered years. The child(ren) shall spend the week of spring break with the custodial parent in even-numbered years.

4. MOTHER'S DAY AND FATHER'S DAY: The mother shall always have the child(ren) with her on Mother's Day Weekend and the father shall always have the child(ren) with him on Father's Day Weekend.

5. SUMMER VISITATION:

(a) The non-custodial parent shall have the child(ren) with him for two nonconsecutive two-week periods during the summer months. Unless the parents can agree otherwise, said two-week periods shall be the last two full weeks in June and the last two full weeks in July.

(b) The non-custodial parent shall have the child(ren) with him from 6:00 p.m. the Friday after school is out for the summer to 6:00 p.m. the Friday before the last week of summer vacation. What is contemplated here is that the custodial parent will have the child(ren) with her for the first and last weeks of summer vacation.

(c) The non-custodial parent shall have the children with him for the entire month of July each year, said visitation to commence at 6:00 p.m. on June 30^{th} and conclude at 6:00 p.m. on Jul 31^{st} each year. Custodial parent will have weekend visitation on the 2^{nd} and 4^{th} weekend of the

month of July.

6. OTHER VISITATION: The non-custodial parent may visit at all other reasonable times and places as agreed to by the parties. That each party shall alternate visitation with child(ren) on child(ren)'s birthday each year with the non-custodial parent having said children in odd-numbered years.

7. TELEPHONE VISITATION: The non-custodial parent is entitled to reasonable weekly telephone contact with the child(ren).

8. ITINERARY: A general itinerary shall be provided for the other parent whenever the children are taken out of town for longer than a weekend. This information shall include an address and telephone number.

9. TRANSPORTATION: Transportation to facilitate visitation shall be provided by the non-custodial parent.

10. WAITING: The custodial parent has no duty to wait for the non-custodial parent to pick up the child(ren) longer than thirty (30) minutes of the set or agreed upon time.

11. RULE 8.06: Each party shall comply with Rule 8.06 of the Uniform Chancery Court Rules by keeping the other informed of his or her full address, including state, city, street, house number, and telephone number, if available. As long as any of the child(ren) remain minors, the parties shall notify each other and the Chancery Clerk of Lauderdale County, in writing, of any change of address within five (5) days of making such change. The notice shall be marked with this court file number. Both parties are ordered and directed to file a Rule 8.06 notice with the Chancery Clerk of Lauderdale County with their current information no later than ______. Each party shall mail a copy of this notice to the other party.
