Normally, in this space, I would update you on the fantastic projects we've worked on in the past few months and highlight any hot topics that need addressing. Instead, I'd like to use this space to ask you all a question: Why did you join Backcountry Horsemen of California? Was it to meet new, like-minded equine enthusiasts? Was it to learn new skills for riding, camping and packing in the backcountry? Was it to volunteer to help maintain trails and equestrian campgrounds? I can say these are all of the reasons I joined the BCHC Top of State Unit in 2018 when I moved back to the area after living in Nevada, Louisiana and Texas for more than 25 years. I didn't plan on becoming the Newsletter Editor or becoming President of this Unit. I've enjoyed these leadership positions, but they are time-consuming and challenging at times. I've taken on other roles within this Unit when chairpersons stepped down, which has also led to a bit of burnout.

I was one of the lead organizers of the 2025 Rendezvous in Corning, and I took great pride in helping plan that event. However, when the event arrived, my involvement as a "volunteer" felt more like being an "employee", courtesy of the treatment received by the BCHC State Executive Leadership in attendance. That experience made me think differently of BCHC and our overall mission. We were under great pressure to make Rendezvous a big money-making event; the educational aspect of the event seemed to be a lower priority. My enthusiasm for BCHC has diminished since April and I've made the decision to step down as President of this Unit after five years in this role. I'm confident that someone within our membership will step up and help keep this Unit going strong in 2026. I plan to continue in several of my current roles, including helping build our relationship with the Klamath National Forest and local trail stewardship non-profits. I think we can continue to do great work in our area forests. I just want more time to enjoy this work, riding and hiking on these beautiful trails.

Thanks to Robert, John and Alan for helping with handing out the cards during the ride. We couldn't put on a group ride like this without our volunteers on the ground.


