Payment Method: To confirm and secure your flight reservation, the full cost of the flight, including any applicable call-out fees, must be paid at the time of booking. **Credit Card:** The total amount will be charged when you book the flight. **Cash:** Please bring the full amount along with your completed Booking Form to our office, PRIOR TO YOUR FLIGHT, during regular business hours. Please note that flights are not considered booked and confirmed until we receive both the completed and signed Booking Form and the full payment. **Business Hours:** Monday - Friday 8:30 a.m. to 4:30 p.m. CST.

Gift Certificate Policy: Gift Certificates are valid for one (1) year from the date of purchase. Please inform us at the time of booking if you plan to use a Gift Certificate. The Gift Certificate must be presented to Interstate Helicopters upon arrival for your flight. If a Gift Certificate is not presented, the flight will NOT be honored, will NOT be refunded to the purchaser, and the flight cannot be rescheduled. **NO EXCEPTIONS.**

Cancellation Policy: If you cancel your flight at least one (1) business day before the scheduled flight, you will receive a refund minus 10% of the total cost of the booked flight. This fee covers the costs incurred by Interstate Helicopters for arranging your flight. If you cancel your flight less than 24 hours before the scheduled date and time, no refund will be issued. **How to Cancel:** Call our office during normal business hours and request a flight cancellation. If no one is available to receive your call, please leave a message to cancel the flight. Be sure to include your name, as well as the date and time of your flight. You can also cancel via email by replying directly to the confirmation email you received after booking your flight. **No-Show Policy:** If the flight is not cancelled and no message or email is received, the full amount of the booked flight will be charged.

Block Payment Refund: All block payments are **NON-REFUNDABLE**. Should you decide to cancel or discontinue your training, any remaining funds will be retained as a credit on your account. These credits must be utilized within a period of 12 months from the date of inactivity, after which they will expire.

Cleaning/Damage Fee & Lost Items: You are liable for any damage or excessive cleaning required due to actions by you. This includes, but is not limited to, additional cleaning, repairs, or replacement of items damaged or altered by you. Please note that all helicopters are non-smoking. Interstate Helicopters is not responsible for any items lost, stolen, or left in the helicopter.

Disclosures: All students will be given a safety briefing prior to the start of the flight. Students are encouraged to contact us immediately if they are experiencing any symptoms of easily transmissible illnesses to discuss rescheduling the flight. Student's weight must be included on the booking form as weight limits apply. Prices are subject to change without notice. Interstate Helicopters is obligated by Federal Law (14 CFR §91.17) to refuse services to any person(s) who appear to be intoxicated or who demonstrates by manner or physical indications that they are under the influence of alcohol and/or drugs. Such person(s) shall not have their flight rebooked or refunded. **TSA Compliance and Disclosure Requirements:** Pursuant to 49 C.F.R. §1552.19, individuals subject to Transportation Security Administration (TSA) security threat assessments must provide complete, accurate, and truthful information. Any instance of fraud, falsification, misrepresentation, or omission of a material fact may result in: (a) Criminal penalties, including fines and/or imprisonment, under applicable Federal laws such as 18 U.S.C. §1001 and 49 U.S.C. §46301; and/or (b) Denial of a TSA security threat assessment; and/or (c) Other enforcement or administrative actions, including proceedings under 49 C.F.R. §1540.103.
