Payment Method: To confirm and secure your flight reservation, the full cost of the tour must be paid at the time of booking. **Credit Card:** The total amount will be charged when you book the flight. **Cash:** Please bring the full amount along with your completed Booking Form to our office, PRIOR TO YOUR FLIGHT, during regular business hours. Please note that tours are not considered booked and confirmed until we receive both the completed and signed Booking Form and the full payment. **Business Hours:** Monday – Friday 8:30 a.m. to 4:30 p.m. CST.

Gift Certificate Policy: Gift Certificates are valid for one (1) year from the date of purchase. Please inform us at the time of booking if you plan to use a Gift Certificate. The Gift Certificate must be presented to Interstate Helicopters upon arrival for your tour. If a Gift Certificate is not presented, the tour will NOT be honored, will NOT be refunded to the purchaser, and the flight cannot be rescheduled. **NO EXCEPTIONS.**

Cancellation Policy: If you cancel at least one (1) business day before the scheduled tour, you will receive a refund minus ten percent (10%) of the total cost for the booked flight. This fee covers the costs incurred by Interstate Helicopters for arranging your tour. If you cancel your tour less than 24 hours before the scheduled date and time, no refund will be issued. **How to Cancel:** Call our office during normal business hours and request a tour cancellation. If no one is available to receive your call, please leave a message to cancel the flight. Be sure to include your name, as well as the date and time of your tour. You can also cancel via email by replying directly to the confirmation email you received after booking your tour. **No-Show Policy:** If the flight is not cancelled and no message or email is received, the full amount of the booked tour will be charged.

Weather Conditions Policy: The safety and satisfaction of our customers is our top priority. Due to the unpredictable nature of Oklahoma weather, we have established the following policy for our helicopter tours. **Weather Cancellations:** If weather conditions are deemed unsafe for flying, we will notify you as soon as possible. Safety is our primary concern, and we will not operate tours in adverse weather conditions. **Rescheduling:** In the event of a weather-related cancellation, we will make every effort to reschedule your tour at a time that is convenient for you. **Refunds:** If rescheduling is not possible or if you are unable to find a suitable time, we will provide a full refund of your tour payment.

Ferry Time: The flight time commences when the helicopter departs from Interstate Helicopters and concludes upon its return. Please be aware that weather conditions may impact the planned flight duration. Any flight time exceeding the pre-paid time will incur additional charges, which will be billed to the customer post-flight.

Off-Airport Landing: A non-refundable \$125.00 fee is required for the evaluation of any off-airport landing sites. This fee will be credited towards the total flight cost and must be paid before any services are rendered. Written permission from the landowner is mandatory for all off-airport landings and must be submitted to our office at least fourteen (14) days before the scheduled flight.

Cleaning and Damage Responsibility/Lost Items: You are liable for any damage or excessive cleaning required due to actions by you or your passengers. This includes, but is not limited to, additional cleaning, repairs, or replacement of items damaged or altered by you or your passengers. Please note that all helicopters are non-smoking. Interstate Helicopters is not responsible for any items lost, stolen, or left in the helicopter.

Disclosures: All passengers will be given a safety briefing prior to the start of the tour. Passengers are encouraged to contact us immediately if they are experiencing any symptoms of Covid and/or other easily transmitted illnesses to discuss rescheduling the tour. Passenger weights must be included on the booking form as weight limits apply. Prices are subject to change without notice. Interstate Helicopters is obligated by Federal Law (14 CFR §91.17) to refuse services to any person(s) who appear to be intoxicated or who demonstrates by manner or physical indications that they are under the influence of alcohol and/or drugs. Such person(s) shall not have their flight rebooked or refunded.
