ON PRIVACY:

The Online Energy Society is a community of people, all of whom are not in Christine Sumner's or Christine Sumner Coaching & Hypnosis's direct control. As an Online Energy Society member, I will endeavor to keep confidences of others with the hope that others will mutually respect my confidentiality.

• ONLINE ENERGY SOCIETY MEMBERSHIP—Online Group Classes and Activities

This informed consent for membership to the Online Energy Society at Christine Sumner Coaching & Hypnosis contains important information about attending online group classes and activities using your smart device or computer.

Christine Sumner Coaching & Hypnosis uses electronic communications to connect with individuals or groups using interactive video and audio communication. Although there are many benefits of this service there are risks. For example:

- Issues related to technology: Both parties are responsible for technical competence. There are many issues that may occur and will impact the Online Energy Society group classes and activities at Christine Sumner Coaching & Hypnosis.

MANDATED REPORTERS

MEMBER PARTICIPATION IN ONLINE ENERGY SOCIETY CLASSES AND ACTIVITIES:

Participant desires to become a member of the Online Energy Society at Christine Sumner Coaching & Hypnosis and understands and agrees that:

- 1. Participation in the online activities and groups at the Online Energy Society at Christine Sumner Coaching & Hypnosis is entirely voluntary, and is not a required condition of membership, notwithstanding that such activity may utilize the premises or facilities owned by, occupied by, or under the control of Christine Sumner Coaching & Hypnosis. Membership to the Online Energy Society at Christine Sumner Coaching & Hypnosis is a month-to-month membership where the Participant pays \$6.99 a month to access online groups and activities. This offer has no monthly commitment.
- 2. Christine Sumner Coaching & Hypnosis makes no representation as to suitability of any recreational and/or physical activity relative to the participant's physical condition and abilities, or the suitability or adequacy of any premises, facilities, equipment, or instruction used in connection with such activities.
- 3. Participant has been advised to consult their physician, or other healthcare professional, before participating in any physical activities and to follow their physician's, or other healthcare professional's advice with respect to such activities.
- 4. Participant will not drive or operate heavy machinery while participating in the Online Energy Society classes.
- 5. The Online Energy Society class *Imagery & Healing Break* utilizes Reiki. Participant understands that Reiki is a simple, hands-on technique that is used for stress reduction and relaxation. Participant understands that Reiki can be used online and sent remotely. Participant understands that Reiki practitioners do not diagnose conditions nor do they prescribe or perform medical treatment, prescribe substances, nor interfere with the treatment of a licensed medical professional. Participant understands that Reiki does not take the place of medical care. Participant understands that Reiki does not treat mental disorders as defined by the American Psychiatric Association. Participant understands that Reiki is not a substitute for counseling, psychotherapy, psychoanalysis, mental health care or substance abuse treatment, and participant will not use it in place of any form of therapy.
- 6. <u>Indemnification</u>. The parties hereto shall use their best efforts to take such actions as may be necessary or reasonably requested by the other party hereto to carry out and consummate the transactions contemplated under this Release.
