

## AGREEMENT FOR POLICE SERVICES

THIS AGREEMENT is made and entered into on this \_\_\_\_\_ day of \_\_\_\_\_, 2026, by and between the **City of Celina**, an un-chartered municipality, 225 N Main Street, Celina, Ohio 45822 (hereinafter "City") and the Celina City Schools 585 E. Livingston St. Celina, Ohio 45822 (hereinafter "Celina Schools").

### WITNESSETH:

WHEREAS, the City operates, manages and controls a full-time police department for the purpose of providing public safety; and

WHEREAS, the Celina Schools is in need of on-site law enforcement services for certain events throughout the school year; and

WHEREAS, during these events, both parties agree it would benefit from the presence of law enforcement officers; and

WHEREAS, additional on-duty law enforcement officers will be needed to fulfill the needs of the Celina Schools at direct cost of the City; and

WHEREAS, the Celina Schools is willing to reimburse the City for its costs to have police officers assigned to be present at the described events.

NOW, THEREFORE, in consideration of the mutual promises hereinafter contained, IT IS AGREED AS FOLLOWS:

1. The Celina Police Chief shall schedule and assign police officers as needed to be present on-site at the Celina Schools events on an event-by-event basis.
2. The officers shall report on station for duty and, once assigned to the event, report in with Celina Schools designated representative.
3. The City shall supply the officers and necessary related equipment and/or vehicles, to facilitate their assigned duties on-site of the Celina Schools event.
4. The Celina Schools shall reimburse the City for the cost of assigning officers at the employee rate per current employee and City of Celina contract including fringe benefits payable to the City of Celina.
5. The number of officers assigned for coverage will depend on the type of event and will be determined on an event-by-event basis by agreement between Celina Schools and the Chief of Police.
6. At no time shall the police officers be considered employed by the Celina Schools. They will perform their duties under the command of the Celina Police Chief.

7. It is understood and agreed that there may arise an occasion where the assigned police officers must leave the site of the special event to assist other responders in an emergency situation. Celina Schools will not be charged for any time a responder is absent from the special event site.
