- Bill #1187 is moving forward, it would legalize side-by-sides on roads
 - Legislation has been proposed for local municipalities to override PENNDOT to open roads for ATVs
- Gov. Shapiro supports opening more roads for recreational driving and ATVs
- Jeff Snyder (PAOHV) was forming a board for the Council of Governments (the DCNR wants out) to manage trails
- NOHVC is having a workshop at AOAA Oct. 25
 - OHM Catawasa ride postponed

- Bedford County is doing a feasibility study to connect to western Maryland
