❖ 40-year Anniversary LVATV

- **Cliff Strauss** was the first president of the club and was in attendance
Cliff provided the history of the club.
- LVATV was established April 10, 1985, a year later it was incorporated.
- LVATV consisted of 42 members and 2 dealer sponsors
- In three years, the club was the largest ATV club in the US (800) members
- A monthly newsletter was sent out by mail to all the members.

❖ FRO Clean up Rides

4. Legislative Report- Bill Ritting

- three work groups were set up to organize a council that is trying to set up a multi-regional organization to run trails instead of the DCNR
- we can set a table up for PAOHV June 8
- Volunteer Trail Ambassador Program applied for a 25k grant
- Polaris granted \$10,000 to PAOHV
- the pilot program will finish in 2026 to expand trail opportunities
- there is a proposed legislation to make side by sides street legal
