5. Legislative Report- Jack Clark – 1st approved by Cathy, 2nd by Rose.

- ❖ three work groups were set up to organize a council that is trying to set up a multi-regional organization to run trails instead of the DCNR.
- ❖ -Jack is involved with the One Voice

One Voice is a conduit between off-road industry professionals, grassroots clubs, and organizations that offers industry specific resources, experience, and knowledge of stewardship efforts across the country.

The One Voice team has over 80 years of combined professional experience, from industry to managing associations.

Leveraging that experience, One Voice offers counseling and consulting services to explain industry funding opportunities, and how to apply for these opportunities, for project work including updating trail signage, safety projects, staging areas, trailhead amenities, trail stewardship and cleanup efforts, and much more ~ all at **no cost** to you or your club!

If you are an off-roader and are seeking opportunities for your club to make a difference in the community. If you care about the future of motorized recreation and believe that trail stewardship is the key to protecting your access and right to ride,

- ❖ Catawissa Recreation Area (Old Paragon ATV Park) – Need survey of trails, beside ATVs & Side by Side's, Dirt Bikes and Jeeps till have access. Online shows construction will tentatively begin in 2025.
- ❖ The pilot program will finish in 2026 to expand trail opportunities.
- ❖ PA Trails Foundation – PA Trails Foundation promotes safe and courteous off-road recreation through educational programming it also seeks to invest funds in building or enlisting public trail systems by investing in capital improvements.
The foundation was awarded a grant (of \$34K from Dept of Conservation & Natural resources this grant is a 3-year grant for the purchase of an ATV simulator, trailer, ATV, and other installments as needed. Once fully operational the simulator will be transported to multiple venues including public riding areas & schools.
