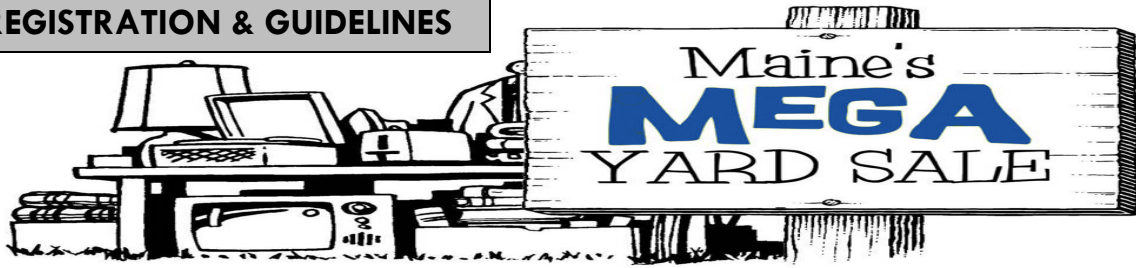

- The sale itself is located at the **Farmington Fairgrounds, 292 High Street, Farmington, Maine.**
- **Booths will be assigned based on registration date.** If you would like to be assigned a booth next to someone else, or want a specific location, specify that information on your registration form, and we will do our best to accommodate your request.
- **THERE IS NO SMOKING PERMITTED AT THIS EVENT OR ANYWHERE AT THE FAIRGROUNDS.**
- Tables, tents, umbrellas, canopies, etc. will NOT be provided at the event—each vendor must bring their own as needed. Your registration fee reserves a 10x12 space (inside) or a 12x12 space (outside) ONLY. You MUST set up within your allotted space. If your items overflow beyond your allotted 12x12 space, you will be required to move your items to remain within your allotted space or pay for an additional spot (if available).
- There is limited access to electricity, but it may not be easily accessible from your table. Be sure to contact Dory Diaz at dory@fcanimalshelter.org if you need access to electricity and neglected to indicate that on your registration.
- Direct sales, craft vendors, and food trucks are permitted.
- When arriving, vendors will use the Maple Avenue fairgrounds entrance. There will be several volunteers and workers directing traffic and vendors.
- No proof of registration is required on arrival. Volunteers will have lists of registered vendors and their assistants.
- Upon your arrival, FCAS Staff/Volunteers will direct you to your assigned selling space.
- All vendors must comply with directions from FCAS Staff/Volunteers at all times.
- **Vendors will have from 6 AM - 7 AM to complete set up of your assigned space.** FCAS cannot assist with unloading, so make sure to bring adequate help to unload your items. **All set-up must be complete by 7:30 AM,** and all cars must be moved to the vendor parking area within the fairgrounds by that time. **NO EXCEPTIONS.**
- To ensure our shoppers' safety, no vehicles will be allowed within the sale area between 7:30 AM and 2pm. Shoppers purchasing large items that cannot be moved by hand should be directed to pick up their items at 2pm. **NO EXCEPTIONS.**
- **Please do not bring any guns, bows, arrows, crossbows, knives, or weapons of any kind.** These items are not permitted to be sold at Maine's Mega Yard Sale.
- **Registration fees are non-refundable.** Refunds will not be provided if you are unable to attend the event.
