DID YOU KNOW??


On July 9th, Kris Keane Ferguson had a birthday! And to celebrate – she tried something she’s never done before! Here is her story in her own words.....

On a relatively chilly 57-degree morning at 9:00 AM, Pam Swigart, Marty Scheel and I set off to swim from my house, which is in the cove at one end of Woodbeck Lake to the Jessups, which is directly across from our house. 2022 FISH PLANT UPDATE

Update from Don Hoogerhyde - Fish Plant Committee Lead

On Thursday July 21st, I received a call from one of our fish farms, that the Smallmouth Bass we ordered were for ready planting. We originally planned to pick them up, but due to issues with packing the fish, we decided to have them delivered.

They were delivered on Friday July 22 and **500** 3"- 4" Smallmouth Bass were released at the Kindy boat launch. It will take a few years for these fish to mature and be legal, so please **release** them if you catch them. Our goal is to hopefully have a self-sustainable population of Smallmouth Bass and that can only happen if they are **released**.

We are still planning to plant Walleye this fall. I should get more information on the date in the coming weeks.

MICHIGAN'S LOONS

AND RESPONSIBLE WATERCRAFT USE

The Common Loon – known for its haunting calls and striking black and white breeding plumage, uses a number of these lakes for its summer nesting grounds. Watercraft operators are naturally drawn to these lakes and often come into close contact with loons. Responsible watercraft use will help ensure that both humans and loons continue to share Michigan's lakes.



Common Loons are large, goose sized, black and white diving birds that spend their summer on open freshwater lakes and winters on the seacoast. They feed mostly on fish. They are 2-3 feet long, weigh 8-10 pounds and have a wingspan of 4-5 feet.

EXCEPT for a few isolated southern Michigan lakes (ours is one of these exceptions!!) Loons in Michigan nest only in the upper ½ of the Lower Peninsula and the entire Upper Peninsula. It is estimated that Michigan has fewer than 500 nesting pairs of Common Loons remaining in the state, and perhaps considerably fewer. The Common Loon is a threatened species in Michigan. Nests are usually made on small islands or quiet bays, coves and inlets. They are especially vulnerable to personal watercraft entering these critical areas.

The nesting season in May and June is the loon's most Critical Time, and loons are not like ducks and geese, which have large broods. Loons lay only two eggs, which both parents take turns incubating for 28-29 days.

Loon Parents leave if watercraft come within 150 yards of the nest, leaving the eggs without warmth or protection. They then become vulnerable to predators. **If disturbed often, loons abandon the nest.** A pair may re-nest if it isn't too late in the season, but they only have two chances.

Michigan Common Loons Continued.....

- Loon chicks rest, feed and grow in and around their territory during the months of June, July and August. **They are not waterproof!!** They need to be able to climb up on their parents' backs to stay warm and dry. When watercraft come close, parents leave their chicks to defend their territory.
- Young chicks are very buoyant and can't dive quickly to get out of the way. They can be run over.
- Chicks tire easily. The presence of watercraft causes them to keep swimming instead of feeding and resting. This can weaken them, affecting their ability to survive.

HOW TO BE RESPONSIBLE, AWARE AND SHOW YOU CARE!!!

1. If you see a loon "dancing" straight up out of the water – and slapping with its wings, it is urgent that you move away. You are in their territory.
2. Loons give a warning call too. Their distress call sounds like a laugh. Listen for and heed this call. It means "Please move away!"
3. Keep in mind canoes slip quietly into nesting areas and can startle loons off nests.
4. Fishing boats – especially bass and pike anglers – spend lots of time in waters perfect for nest sites. Watch for them!
5. Speed Boats that send waves crashing onto the shoreline can drown young chicks!
6. Personal watercraft can easily run over loons and chicks without realizing they are even there.

REMEMBER! Enjoy Loons from a distance. Listen to their calls. Remember they need space and solitude. And report harassment of Loons to the DNR at 1-800-292-7800.

From the kitchen of Mindy H!

LABOR DAY ZUCCHINI BREAD

Labor Day is the time of the year that gardens everywhere unleash their zucchinis. We shred ours up and make loaf after loaf of zucchini bread for our Labor Day family reunion. (See photo, page 105.) Like the banana bread on page 254, you can make zucchini bread, muffins, or donuts.

Makes 1 loaf, 12 muffins, or 12 donuts

2 cups whole-grain flour (we use 1 cup whole wheat flour and 1 cup oat flour)

1 teaspoon baking powder

½ teaspoon baking soda

½ teaspoon cinnamon

1¾ cups shredded zucchini, lightly squeezed in a dish towel to remove some of the water

⅔ cup 100% pure maple syrup

1 teaspoon vanilla extract

Preheat the oven to 400°F. Line a loaf pan with parchment paper (or get out a nonstick muffin pan or nonstick donut pan).

In a bowl, combine the flour, baking powder, baking soda, and cinnamon. In a large bowl, combine the zucchini, maple syrup, and vanilla and stir. Mix the dry ingredients into the wet.

Pour the batter into the lined loaf pan (or divide among 12 muffin or donut cups). Bake the loaf for 30 minutes (or the muffins or donuts for 15 to 18 minutes), until golden brown on top. Serve warm.


