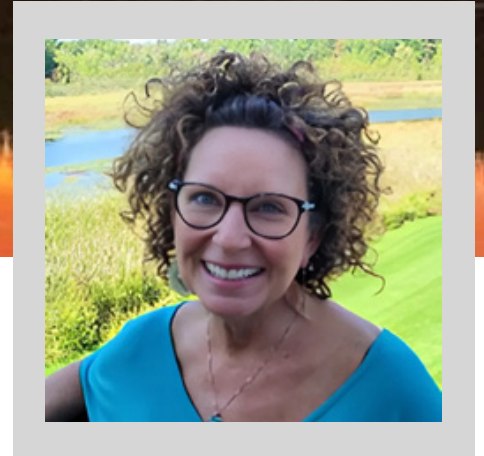
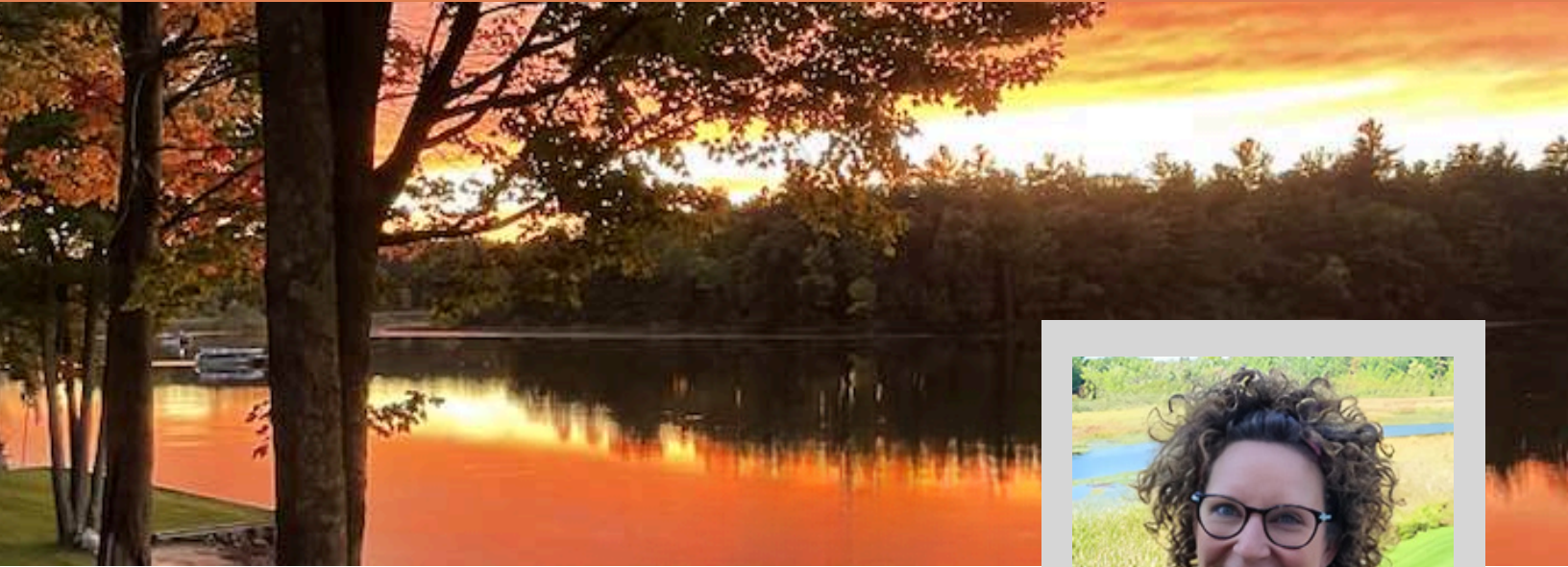

### HELLO FRIENDS & NEIGHBORS!

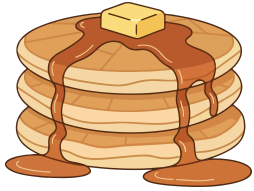

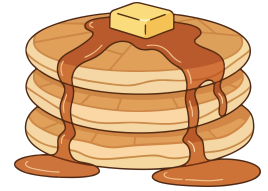
