Mike & April Petersen and Frugthaven Farm...a love story



By now most of us have seen the Old Klackle's Orchard transformed into Frugthaven Farm. But the story behind our neighbors on Horseshoe Lake is a love story like no other!!

We all know April from her lovely Boutique **Pink+Frillos** on the corner of Lincoln Lake Road and McClain St. But as I watched the Old Klackle's Orchard transform into Frugthaven Farm – my curiosity got the best of me. I had to get the story behind April and Mike and their new venture.

A love story: April Welder and Mike Petersen grew up in the Greenville area. April's family owned (and still do) a farm in Sheridan and Mike's family owned Petersen Oil. They dated briefly in High School before April left for Central Michigan University. Five years passed before they would see each other again. April took a job right out of college in Hilton Head, SC, and on her way out there stopped at the Danish festival in Greenville to see friends and have a bit of fun. Mike was there at the beer tent and spilled a drink on her girlfriend – and a year later they were married!! It could not have been anything but destiny for the two!

In 2000 they built the first house in Horseshoe Estates and welcomed home their two children – Morgan (18) and Mia (15). April was crafty and loved to create beautiful jewelry and crafts. Mike set up a craft room in the basement for her and April sewed, painted furniture and made various crafts that she sold. She ended up taking over more and more space in the basement – until it was overrun with all her beautiful creations.

New Adventures: The old Rees' Party Store had been sitting vacant and Mike was thinking it might work as a workshop for April. Finally, a "for sale" sign went up. Mike suggested they buy it as a workshop for April – more to get her the space she needed and out of the basement space she had clearly outgrown. They put in a bid, and a week later had the keys! It seemed like destiny stepped in – again – and it was meant to be! Pink+Frillos was born.

Originally slated to be open only once a month for sales, April soon realized she needed to be open more to sustain the business and opened the shop 2-3 days a week - and eventually 4. When she found she couldn't keep up with the inventory, she realized it was so much easier to buy and sell cute merchandise than to have to spend hours creating it! Word of mouth has traveled far and wide and people stop by from all over the state on their way to cottages in the area to visit. The boutique is busier than ever!

Impulse Buy: Fast forward to the spring of 2019 when Mr. Klackle decided to retire, and Klackle's Orchards went up for auction. Mike was watching the auction live at the request of his father in law, who thought it might be good farmland to buy. It appeared all tracts up for bid were getting a lot of activity and prices were rising - except tract 1 – the Farm market, event center and acreage covered with pumpkins and apples. Mike, on a hunch, mentioned to April "*Maybe we should bid on this?*" April laughed and said "*NO!..what would we do that for??*" But after talking to his Dad, and agreeing it was a good investment,

Mike and April decided to place a bid. By 6:30 they were the owner's of 75/80 acres of land referred to as Tract 1!

The thought of reselling the land for profit quickly left their minds and instead they started dreaming of what they could do with this property that had been a landmark in Greenville for so long. Mike had sold Petersen's Oil and thought this would be a great retirement project. They had a vision of a Boutique Orchard that would provide a cozy gathering space as well as be a simple orchard destination for families and friends - and encompass a comfortable event venue.

The name for their new dream was developed from Frugthave, which is Danish for Fruit and garden. (Mike's great-grandpa came over from Denmark and seeing how Greenville is home to the Danish Festival it made sense to have a Danish name). April had thought Greenville was in need of a coffee shop and so they decided to put in a Kaffebar complete with Madcap coffee, smoothies, donuts and bagels – at the front of the Market. A total facelift has been given to the outside of the market, remodeling of the inside Kaffebar is done and they have plans for so much more!



Their dream – their vision - includes a Fresh Market with locally grown meats, cheeses, produce, dairy, a full bakery and fresh flowers! A tavern at the back of the main structure called “The Cidery” will include indoor seating as well as an outdoor patio with fire pits with cozy seating and featuring select wines, locally brewed beer and cider – for a wonderful place for families and friends to meet and socialize.

The large building to the west of the Market will soon hold Pink+Frillos (yes, it is moving!) and that will give them almost twice the square foot they have now. They have renovated the smaller barn for Weddings and events and working on renovating the larger one now. Both will be available three seasons of the year. The outside will still have the old-fashioned orchard to stroll through, take pictures, or just for families to have a picnic in the Orchard.

IF you haven't stopped by yet – please do! Stop and say Hello to April and Mike. Grab a cup of coffee and a donut and take a look around! These are our neighbors and they are helping Greenville grow and become a wonderful place to visit as well as live! The Kaffebar is open Monday thru Friday, 6:00 a.m.-5:00 p.m. and Saturday 7:00 a.m.-5:00 p.m. Sundays they are closed for a much-needed day of rest. Randy, Jamie, Bobby & Jacob Badgerow on Banks Lake


Plus fur babies Kyle & Waffles

Boat and Jet Ski Issues

WCLA Board members and lake representatives received numerous complaints this summer regarding boat and jet ski activity on our lakes. Specifically – those that were dangerous to others and/or property. This is a reminder that the Woodbeck Chain of Lakes Association (WCLA) cannot police the water and have no jurisdiction to stop this type of activity. There's still a few more weeks left to enjoy the lakes this season, so please be mindful of your lake community. ***IF you see dangerous/illegal activity*** please:

1. Identify the individual(s) that are engaging in the activity by videotaping it. Make sure you get close enough pictures or videos so it is easy to identify the craft or the person(s) responsible.
2. Call the Kent County Sherriff's department and share the video or pictures. The number is 616-632-6100.

It is important to know what is illegal and what is dangerous before calling. Make sure you read up on the rules here: <https://www.boat-ed.com/michigan/handbook>

We want to keep our lakes safe and fun for all, but we also want to be good neighbors and friends. If you can resolve the issue with your neighbors before calling the Sherriff – it is always best to do so.

6th Annual WCLA Golf Outing August 1, 2020 – Candlestone Golf Course and Resort – WINNERS!


**OUR 2020 WCLA GOLF OUTING, 4-person scramble, WAS




