Water Levels: Have you noticed the water levels seem lower? We checked into it with Joel Morgan, Senior Engineer with Kent County Drain Commission. He reassured us that although they are low, they remain above the established legal lake elevation set by the Circuit Court. The water continues to flow as it should over the weir structure located on the North end of Half Mile Lake. Water levels will vary depending on the time of the year and climate changes, so we will see this from time to time. We will continue to monitor this closely and address it further if anything changes.

Update from the Independent Bridge Committee: The survey indicated a strong interest in raising the bridge. The committee plans to move forward with an official vote. Watch for it to come out soon via email or regular mail. They will also be getting bids from Kent County Road Commission so the total cost will be known. They will be having a second Town hall meeting soon to give updates to questions previously asked and to address new questions. Got Deer??

Deer are beautiful to watch and they certainly have a right to live near us, but when they start destroying the gardens you have labored over it can be annoying! They have a right to live near us, so the best course of action if you have a deer problem is to adjust your practices.

No plant is 100% deer proof. If deer are hungry, they will eat anything that looks slightly green. However, there are many Michigan native plants that are resistant to deer browsing because of texture, aroma and/or flavor.

Since we live in an area with a high population of deer, in addition to planting deer resistant plants you can also use an organic natural deterrent around the perimeter of your garden. Products like "Plant Skydd" or "Liquid Fence" utilize predator urine, dried blood, and other scents to repel deer, ground hogs, rabbits, etc. (Note: I have tried most of these and I am not endorsing the use of any specific product.)

Now the title really should say "Who Doesn't have Deer?" I hear things like this often from folks in the area: "Every time I plant a garden the deer devour it!" OR "I love seeing the deer in my yard, but I don't like the way they eat everything!" If you have visited my nursery most likely you noticed the miles of deer netting covering everything. I have found it to be the best protection and easy to apply, and really it is not that noticeable.


If this is you, here is the good news: there are many native plants that are resistant to deer browsing! Deer do not like the smell, taste, or texture of these plants! And, Fall is the perfect time to add native plants to your landscape, here is a partial list of deer resistant plants that are available from my nursery. 🌿

Remember: Native plants do not need as much water and **they need no pesticides** or other toxic chemicals. Once established, they require less care and their long roots soak up water, clean some toxins, and help with erosion and soil compaction. Many native plants support multiple beneficial insect species and birds.

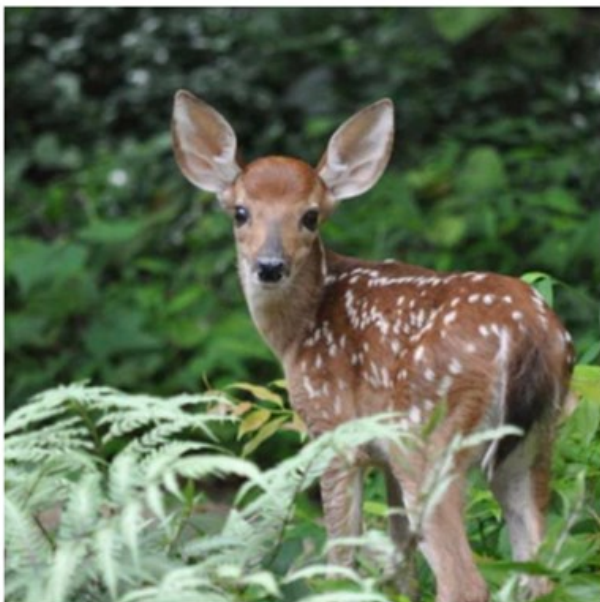

NatureArt Woodworking

One of our very own on Woodbeck Chain of Lakes will be in this year's

Artprize in Grand Rapids.

Fred has lived on Horseshoe Lake for over 18 years. He has been doing Intarsia since 1998 when he retired from 35 years at CSAA and picked up a scroll saw to create beautiful Intarsia wooden wall hangings. This rare 15th century art form is created by selecting different types of wood, such as Western Red Cedar, Aspen, Poplar, Maple, Walnut and Hickory using its natural grain patterns and colors to create the different colors in a mosaic pattern. Each piece of wood is then individually cut, shaped, and sanded before fitting them together like a jig-saw puzzle, gluing them to a piece of plywood backing and framed to shape the final product. Sometimes, additional pieces of plywood are used to raise areas of the pattern to create more depth. Once together, a final layer of finish is applied and the project is complete.

EGLE permitting restrictions, national holidays, and/or weather conditions may influence the timing of treatments throughout the 2024 season. PLM treats each lake according to a schedule or season plan, established with the cooperation of your lake association, lake board or residents on the lake. The treatment schedule is approximate. Please watch your shoreline for the posting of the 8.5x11 inch, yellow or green signs. The signs will indicate the date of the treatment, the products used, and any restrictions on the use of treated water for swimming, watering lawns, etc. The property owners in this area are planning to have the waters chemically treated to control lake weeds and/or algae. This notice is being circulated in accordance with Department of Environment, Great Lakes and Energy (EGLE) procedures. Below is a list of herbicides that **may** be applied to the lake and the associated use restrictions. On the day of treatment, signs will be posted along the shoreline within 100 feet of treatment areas that indicate what products were used and specific water use restrictions that apply:
