

Marlene Q.

In May 2019, for the first time in decades, I attended the Alumni Association's Annual Brunch. In spite of my decades of AA attendance after in-patient treatment, I had not ever attended the event. Back in the day, there was an annual alumni gathering usually around the holiday season in December and held at a downtown hotel ballroom which was filled to capacity with hundreds of grateful recovering people.

Over the years, the event has morphed into a springtime *Annual 11th Step Brunch*. The attendance is much smaller but gratitude filled the room and it was apparent as I entered the Brennan Center, greeted by the sweet aroma of breakfast, that recovering people at Fairview/U of M still relish the benefits of good food.

Marlene Qualle, Director of the Alumni Association, was also this year's guest speaker. Marlene's decades of Alumni stewardship has survived the multiple changes of hospital administration and the chemical dependency treatment center's evolution. After her welcome, she shared her story of recovery which began on March 6, 1976 at St. Mary's Rehabilitation Center. Prior to treatment, she had worked as Vice President of an advertising agency. A career which later became the basis for a popular TV program, *Mad Men*. Marlene fit right in. Driven and straight talking, her drinking "buddy" just happened to be the President of the company.

Because of the drinking, her husband had asked her to leave and she was shame-filled about being a "drunk mother." She reached her bottom after that first Christmas alone and admitted she needed help. The emotional pain and loneliness was so intense that she felt like she was an alien from "outer space." She insisted for some unknown reason that her treatment had to be at St. Mary's. With the help of a psychologist, she was admitted to the Mental Health unit and later transferred to the Rehab Center. Her resolve to get "sober" was immediately tested by having a roommate who had killed her own husband. After reaching an acceptable understanding with her roommate, Marlene settled in and started her treatment. She remembers the orientation staff person responding to the details of her drinking with "So you only *think* that you're an alcoholic?" Apparently her counselor had a more definitive impression.

She completed in-patient treatment and established a strong aftercare schedule attending AA, Alanon, and Growth Group meetings every day of the week for two years. She quit her job and her former boss started attending AA. She got a sponsor and remembers getting on a plane and having the attendant ask over the intercom "Will those on board who are friends of Bill W please raise their hands." Five hands were raised and she knew whom she could talk to about her efforts in sobriety while in flight as the beverage cart passed down the aisle.

Her Higher Power was another matter. Being introduced to the *Big Book of Alcoholics Anonymous* while in treatment, it seemed to Marlene that "God" was on every page. At home surrendering, but not believing in God, she locked the door to her bedroom, even though she lived alone, so no one would see her, got on her knees and prayed "If there is a God...help me!" She immediately felt the power of the 11th Step i.e. *Sought through prayer and meditation to improve our conscious contact with God as we understood Him, praying only for the knowledge of His will for us and the power to carry that out.* Marlene said that "the Grace of God lifted me from my desire to drink."

The power of the 11th Step of AA is always available to those who are serious about sobriety: "God help me with" A good friend of hers from Long Island reminded her that as a sponsor to others in AA she was like a spiritual pipeline in that the "spirit runs through you." It was apparent in the Brennan Center that morning in May that Marlene had not only attained and maintained her own sobriety, but had helped many others to find their way and deeply inspired and touched us with her journey in recovery. This year's *Annual 11th Step Brunch* ended with the song by Judy Collins, *Amazing Grace*, as had those banquet hall celebrations so many years ago, amid tears of gratitude and joy.

A Short History of the Treatment Center

Among the thousands of people who have gone through Chemical Dependency Treatment here, there is an inside joke: "What was the name of the Treatment Center when you were in treatment?" The original treatment center was started at St. Mary's Hospital in 1968 by Dr. George Mann, an anesthesiologist at the Hospital. It was called St. Mary's Rehabilitation Center and was the first hospital—based addiction treatment program in Minnesota. He retired as the Treatment Center's Director in 1998 and started another innovative, affordable residential addiction treatment program in Wayzata, named The Retreat. Dr. Mann, also a member of Alanon, wrote a book entitled *Recovery of Reality: Overcoming Chemical Dependency* in 1979. His wife, Marion C. Mann, a member of AA, served as a family counselor for many years at St. Mary's Rehabilitation Center.

The Sisters of St. Joseph of Carondelet, who had founded St. Mary's Hospital in Minneapolis in 1887, continued to administer and staff the hospital until 1986 when they sold it to Fairview Hospital which was an adjacent neighbor. In 1997, Fairview Hospital merged with the U of M Hospitals. And in 2018 the University of Minnesota Medical Center became the flagship for the Hospital with the addiction treatment program still named the Fairview Chemical Dependency Program.

Dr. Mann who had dedicated his life to helping alcoholics and addicts recover and revolutionized CD treatment in a way replicated across the country and the world, died February 7, 2012 at age 88. Marion, his wife of 63 years, died five weeks later at age 90. Their legacy lives on in all whom they helped recover from addiction here and elsewhere.
