Minutes for A.A. at Fairview Riverside Board of Trustees Meeting February 11, 2018

Summary

- 1. **Trustees Elections 2018.** Bruce and Jim are making flyers for Trustees' mailboxes. Each AA meeting should send a representative to participate in our elections and to attend our monthly meetings. Each group's trustee member is your direct connection with our AA functions at the Riverside facilities.

- A. Secretary's Report: Lynn read the December minutes. The December minutes were approved.
- *B. Treasurer's Report:* Bruce submitted the Final 2017 Income Statement. We had a \$21 surplus. Contributions 2017 (\$4,914.65) remained close to the same as 2016 (\$4,928.31). Expenses stayed about the same from 2016 through the end of 2017. In 2017, we doubled our contributions to AA service organizations (\$1500 in 2017).

We start 2018 with a prudent reserve of approximately \$2000.

Contributions per member have gone down to approximately \$1 per meeting. This is hypothesized in part to be due to the reduction in General Meeting inpatient census and patients who attend non-AA meetings.

• Bruce wants to review how many squads existed in 2013 vs. 2017. Our goal is to understand our history and perhaps learn from it.

A theory too is that we have seen an increase in treatment centers locally and a shift to opioid (CA, NA, etc.) recovery.

- Bruce wants to know if Squad 51 is meeting.
- Jim M. asks for an analysis of attendance by meeting. For example, how to account for the drop in General Meeting attendance.
