Aliens Are Here, and You Should Care By Burk Stringfellow

"I happen to be privileged enough to be in on the fact that we have been visited on this planet, and the UFO phenomenon is real, although it's been covered up by our governments for quite a long time." - Edgar Mitchell, 6th man to walk on the moon. 2009.

Aliens are here, and you should care. This thesis is based upon four assumptions:

- 1. Intelligent aliens exist in the Universe.
- 2. Some of these aliens are not inhibited by what us humans know as Special Relativity.
- 3. They want to be here.
- 4. You have everything to gain.

The first is not hard to defend: There are about 100 billion stars per galaxy and 2 trillion galaxies in the observable universe. If intelligent life can manifest near our star, we're guessing it can also near others.

Special relativity is often cited as the greatest factor in limiting interstellar travel due to the vast distances between stars. According to Einstein's theory, as an object approaches the speed of light, its mass effectively becomes infinite, requiring infinite energy to accelerate further. This makes achieving or exceeding the speed of light impossible with our current understanding of physics.

However, history has shown that what seems impossible in one era becomes commonplace in another, as our understanding of the universe evolves.

Some say we're in the midst of a fourth "Copernican revolution", of which there will be many:

1st: The Earth is not the center of the Universe (1543) 2nd: Our Sun is not the center of the Universe (1920) 3rd: The Universe is expanding (1960)

Now, with a greater understanding that we don't know what dark matter (holds galaxies together), or dark energy (pushes galaxies apart), actually is, I think it's safe to say we don't know shit. Hence the fourth.

Supposedly, this stuff constitutes 95% of all mass-energy in the Universe. With respect to dark energy, we are completely clueless about what exactly empty space is - apparently it's not empty and is expanding at an accelerated rate.

Current math and physics tell us that at the center of black holes and the Big Bang there's infinite density, which is not physically possible per current math/science. String theory, after fifty years of occupying our greatest minds with intense investigation and development, has failed to unite gravity and the three particle forces. And finally, though certainly not comprehensively, we still don't know what exactly the electron is! It's simultaneously both a particle and a wave and does some pretty wild stuff.

What is the electron trying to tell us? This crazy little bugger, via quantum entanglement, proves to us that the universe "is not locally real," i.e., objective reality does not exist. In other words, if a tree falls in a forest and no one's there to hear it, it didn't make a sound, for the experience of sound doesn't exist independent of observation. It also tells us that things can instantaneously influence other things light years away (if they are indeed separate things).

I.e., the electron is trying to tell us that we must start thinking outside the traditional spacetime box if we're ever to understand that which is knocking on our front door—aliens.

Gödel's Incompleteness Theorem states that "in any consistent formal system that is capable of expressing basic arithmetic, there are propositions (or statements) about natural numbers that cannot be proved or disproved within the system." This has been extrapolated by really smart people, like Nobel laureate Roger Penrose, to mean that any formal system cannot prove its own consistency. And I, though might be inferring too much here, take this to mean something like, "Physics can't be used to prove the correctness of physics."¹

So, what might be more fundamental to the universe than space-time?

A zeitgeist growing in popularity among both philosophical and scientific communities is the notion that spacetime itself emerges from something more fundamental, like some sort of consciousness substratum. Eastern philosophies, successful experiments in parapsychology, remote viewing, near-death experiences, and even the hard science of quantum physics all tell us that consciousness is not just an emergent property of the brain but could instead be a fundamental aspect of reality itself. Rather than being confined to individual minds, consciousness might pervade the entire cosmos, acting as the ground from which physical reality unfolds. If consciousness is the true foundational field on which these UAPs play, we'll have to update our first principles.

All things considered, wouldn't you agree that it's quite ridiculous to acknowledge how little we know on one hand, yet insist on the finality of Special Relativity on the other? If our civilization persists, won't Einstein's cosmic speed limit prove to be no limit at all?

Given that the universe is at least 13.8 billion years old, if anything intelligent out there is older than us, it's way older—old enough to completely supersede our science in this reality, and probably even old enough to supersede our reality itself.

Finally, though don't throw out the above logic baby with the following bathwater, the evidence (physical, instrumental, material, and eyewitness) is undeniably overwhelming. Below, I've aggregated examples I feel to be the most compelling:

1. Navy Encounters: The U.S. Navy has documented multiple encounters with unidentified flying objects exhibiting capabilities far beyond any known technology.

- a) 2004 (USS Princeton and USS Nimitz): The USS Princeton tracked a Tic-Tac-shaped UFO on its SPY-1 radar for weeks, observing extraordinary movements such as descending from 80,000 feet to near sea level in under a second. Pilots CDR David Fravor and LT Alex Dietrich were dispatched to investigate, capturing video evidence and providing corroborating eyewitness accounts. Radar operators aboard the USS Nimitz confirmed the same anomaly, highlighting a phenomenon still completely unexplained.²
- b) 2015 (USS Theodore Roosevelt): Over a decade later, similar phenomena were recorded by Navy pilots from the USS Theodore Roosevelt. Pilots, including LCRD Ryan Graves, captured the GIMBAL and GOFAST videos using FLIR cameras. These objects displayed rapid acceleration, abrupt directional changes, and no observable heat or propulsion signatures, further corroborated by radar data and pilot testimony.³

2. The Travis Walton Abduction Case (1975): is the most convincing abduction case of all time, due to the thorough police investigation that ensued during his five-day disappearance, after his crew stated they saw him struck by a bright beam of light under a hovering object in the forest. Over the years, Travis and his six crew members have taken a total of thirteen polygraph tests, each indicating "no attempt to deceive."⁴

3. The Ariel School Encounter (1994): in Zimbabwe is the most compelling eyewitness alien encounter to date. During a morning recess, sixty-two schoolchildren claimed to have seen one or more UFOs and experienced telepathic communication with its beings. Harvard psychologist Dr. John E. Mack interviewed the students and found their testimonies very credible. In addition, burnt marks from one of the craft were found in the grass, and a teacher later admitted witnessing a saucer take off. Their story hasn't changed in 30 years, nor have they sought attention.⁵

4. The Roswell Incident (1947): A local rancher, Mack Brazel, reported mysterious wreckage on his property to the local sheriff, who in turn reported it to the authorities at the nearby Roswell

Army Air Field (RAAF). Under the direction of the base commander, the RAAF issued a press release on July 8, 1947, stating that they had recovered a "flying disc." Shortly after, Air Force General Roger Ramey recanted, stating it was a weather balloon. From 1947 to today, there have been multiple reputable eyewitnesses, many who've shunned attention throughout their life, affirming the original account. A second crash site, located 40 miles from Brazel's ranch, was discovered shortly after by a firefighter who responded to the scene. He recalled seeing a large disc embedded in the ground, with several small, non-human bodies nearby. U.S. Air Force pilots. Oliver Henderson and Marion Magruder, and Sgt. Melvin Brown also reported witnessing alien bodies.^{6 7}

5. Cattle Mutilations: Cattle mutilations continue to baffle investigators due to their inexplicable nature and recurring patterns. The animals are often discovered with surgical-like incisions, missing organs, and no trace of blood at the site—factors which defy explanation through natural predation or common human activity. Eyewitness accounts sometimes report strange lights or unidentified flying objects near these incidents, fueling speculation about extraterrestrial involvement. Despite decades of investigation by ranchers, law enforcement, and federal agencies, and significant financial losses suffered by farmers, no one has ever been held accountable, making cattle mutilations one of the most enduring unsolved mysteries.⁸

6. Exotic Materials: There are at least twelve cases of people possessing exotic materials that have been independently verified to have isotopic ratios and physical properties that:

- Cannot be reproduced on Earth with current technology.
- Do not align with any known natural processes, either on Earth or elsewhere in the universe.
- Exhibit clear hallmarks of intelligent engineering.

See post essay for all 12 such cases. Most of these materials currently have known locations. We should have our best scientists examine them to make definitive determinations one way or the other!

7. Recent "drone" activity: Between November 2024 and January 2025, more than 5,000 drone and unidentified aerial phenomena (UAP) sightings were reported across the United States, with at least 60 occurring directly over critical infrastructure such as nuclear plants, military bases, and energy facilities—most heavily concentrated along the East Coast.⁹ Despite the incredible number of sightings and heightened attention from federal agencies, not one launch or landing was ever detected—an astonishing reality given the advanced surveillance capabilities of the

U.S. military/intelligence communities and considering that these 'drones' had captured global attention.¹⁰ They emitted no radio frequencies, evaded radar and targeting systems, ignored electronic warfare attempts, and maneuvered with a persistence and agility that defied conventional drone behavior.¹¹,¹² Many vanished into bodies of water or simply went dark mid-flight. Even more baffling were the dozens of sightings of "<u>plasmoids</u>"—glowing, plasma-like orbs with no apparent physical structure—raising further questions about the true nature of what was being observed.¹³ The complete lack of any recovered materials, downed drones, or credible origin points has deepened the mystery of what's become one of the most unexplainable aerial phenomena waves in recent history. Watch as we never hear about them again.

Government cases:

- Of the 12,618 cases our government investigated between 1952 and 1970 via Project Blue (which was set up specifically to debunk), 701 remain totally unexplained.¹⁴

- Of the cases Advanced Aerospace Threat Identification Program (AATIP) investigated from 2007 to 2012, data has not been released.¹⁵

- Of the 144 cases the UAP Task Force examined, from 2004 - 2021 (80 of which involved observations with multiple sensors), only one was identified with high confidence, leaving 143 unexplained.¹⁶

- Of the 1600+ cases AARO has investigated from 2022 to today, 900+ still remain unexplained.¹⁷

It's interesting to note how the more our technology improves, the harder it is to explain away these phenomena.

In addition, many prominent whistleblowers of unquestionable integrity and pedigree (like many astronauts and global leaders) have made some amazing claims. See post essay for a summary of those. Also, see veteran UFOlogist, Dr. Steven Greer's newly launched Disclosure Project Intelligence Archive (DPIA) for over 112 top-secret military and corporate whistleblowers, government records from the US and other nations, and details about 151 classified black sites.¹⁸

But once again, to the more important point of pure logic: Team Alien needs just one of these phenomena to be true, whereas Team No-Alien must perform all sorts of mental gymnastics to

explain them all away. This point is truly the death blow to Team No-Alien. Only one of these phenomena needs to be true! Yet believing Team No-Alien means accepting that all these cases—thousands of eyewitnesses and hundreds of reputable whistleblowers—are just what? Fabrications? People trying to get famous or make money? Misunderstandings? Yes, indeed, many cases are exactly that. Let's even go so far as to assume most of them are that—unremarkable. The gravity of this point is that they *all* must be! This makes the likelihood of relevant alien activity in our reality a near mathematical certainty.

Decades of philosophical progress have been lost due to our dead-ending ourselves on that one first question: Are they real? It's prevented us from asking the far more important questions: Why are they here? What does this mean for humanity? Can we benefit from them? We've been so caught up in whether there is even a curtain that we've failed to ask what's behind it. What if there's something that might help us?

Before I get into why you should care about all of this, allow me to address the two most common criticisms against Team Alien.

1: The Fermi paradox: "The apparent contradiction between the high probability of the existence of extraterrestrial civilizations and the lack of evidence for, or contact with, such civilizations."

No such contradiction exists: there is indeed ample evidence as mentioned above, but factions of our government have suppressed evidence of extraterrestrial life for multiple reasons. The top one being that they can't explain it themselves, which entails many different fears and insecurities. As Admiral Gallaudet puts it, they "don't want to share that kind of information because it reveals weaknesses in our ability to monitor and protect our airspace."¹⁹ There's also the fear of significantly disrupting markets, or religions.

The evidence, however, abounds. The evidence is so overwhelming that if this were a court case, it'd be a slam dunk. And governments can indeed suppress evidence and keep secrets. See the Manhattan Project or Bletchley Park & Enigma Code as just a couple examples of many. The government has, in the past, used things like strict compartmentalization, legal mechanisms (NDAs), disinformation campaigns, pysops, and even force to keep humanity's greatest secret.

In the words of Luis Elizondo, "Most Americans would be shocked to learn that the Pentagon's very own Public Affairs Office openly employs a professional psychological operations officer as the singular point of contact for any UAP-related inquiries from citizens and the media. This is unacceptable."²⁰

Finally, the scientific community has been employing a double standard. Yes, the legendary Carl Sagan said, "extraordinary claims require extraordinary evidence." But given recent revelations, I propose we consider the thesis that aliens never violate the cosmic speed limit to be the more

extraordinary claim - that encounters are actually swamp gas, optical illusions, or weather balloons, that thousands of eye witnesses and whistleblowers are all lying or wrong - to be the more extraordinary claim. Such would also be more consistent with Occam's razor—the principle that states the best answer is usually the simplest, defined as the one requiring the fewest assumptions. The simplest explanation is that we are not alone in the Universe and that our science is relatively primitive.²¹

2. "If they're so advanced, how is it that they'd come all the way here just to crash?" One popular theory is that these crashes are intentional and are often referred to as "donation sites." It's also possible that no alien 'lives' are lost, as they may actually be advanced forms of clones, AI, or something else.

They're doing this to sequentially ease us into disclosure—a process known as sensitization. This gradual approach may be a way of preparing humanity psychologically for the reality of their existence without causing major disruption.

This process of sensitization also helps explain some of their ambiguous behavior. For instance, their apparent reluctance to establish direct contact, their selective appearances to individuals or small groups rather than large ones, and the sporadic nature of sightings all leave room for skepticism and a gradual adaptation to their presence.

If you were an advanced alien race wishing to make first contact with a vulnerable species, how would you approach it?

Why you should care.

We very well could be sitting on a winning lottery ticket that is soon to expire. If we don't act soon, the disclosure movement could remain mired in denial, like it has for past generations, fading into the background years past our lifetime. Don't you want to be around for first contact? Let's force disclosure now and cash in on that ticket.

The Ticket:

Ben Rich, the head of Lockheed Martin's super-secret Skunk Works division, said during a lecture at UCLA in 1993, "We now have the technology to take ET home." Later, when questioned about his statement, he provided answers and explanations that made it clear he was entirely serious.²²

Israel Haim Eshed, former head of Israel's space security program, in 2020 stated that the U.S. government has been in contact with aliens and that both sides have an agreement to keep

their presence hidden until humanity is ready. He also claims that some species share advanced technology with us.²³

Luis Elizondo, the former head of AATIP and David Grusch, National Reconnaissance Office Representative to the UAP Task Force, have both indicated that the U.S. government currently possesses advanced technologies of non-human origin.²⁴,²⁵,²⁶

There are numerous reputable sources suggesting we may already be in possession of alien technology. Some even speculate a treaty already exists between humanity and these advanced beings.²⁷ As far-fetched as this may sound today, it's time to take such claims more seriously. The potential benefits could be enormous. For instance, Dr. Greer often highlights declassified government documents and extensive witness testimony (<u>see his archive</u>) that hint at the existence of limitless, near-free energy in addition to possible medical technologies.²⁸

Of course, all of this could be mere speculation. A well-funded disinformation campaign would certainly have you dismiss such ideas outright. But what is undeniable is the overwhelming evidence that aliens are real and are visiting us. Accepting that premise compels us to seriously investigate these more extraordinary, yet well-founded claims.

Christopher Mellon, former Deputy Assistant Secretary of Defense, argues that "a successful reverse engineering program might bring about a revolution in energy, transportation, and materials technologies."²⁹ With the U.S. now battling a \$37 trillion debt, all ideas should be on the table.

Unlimited free energy would eliminate energy costs for households, businesses, and industries, fundamentally altering economic systems. The cost of living would drop dramatically. Pollution and greenhouse gas emissions would plummet, mitigating climate change and leading to cleaner air, water, and ecosystems. With reduced reliance on resource extraction, habitats could recover, biodiversity could increase, and environmental restoration projects could thrive.

National security folks often emphasize the immediate risks these beings pose, such as frequent airspace violations, near air collisions, and manipulating our nuclear missile control panels.³⁰ While these are all serious issues indeed, they pale in comparison to the missed opportunities in failing to develop our next-gen technologies. That being said, even if you remain unconvinced concerning the possibility of us learning from them or their technology, you must at least concede that the national security implications alone should make this the Department of Defense's top priority: a foreign adversary developing these technologies first could render our entire arsenal obsolete.

In addition, by intentionally demonstrating their capabilities without displaying hostile intent, they show not only that they are non-threatening, but also that they wish to communicate something to us. How dumb must we be to ignore them! Failing to hold our elected representatives accountable—or worse, avoiding the conversation out of fear of ridicule—is tantamount to turning a blind eye. We must talk about this more openly. Each of us can significantly contribute to the disclosure movement simply by bringing it up in conversation. Those willing to go slightly further, please acquaint yourself with just a couple paragraphs on where we are politically today:

Despite over half of Americans believing in visits from intelligent aliens, along with countless claims from witnesses and whistleblowers over the decades, Congress has only recently taken action.

It's been the testimonies from Elizondo, Grusch, Navy pilots, the landmark 2017 *New York Times* <u>article</u>, and advocacy from the late Senate Majority Leader Harry Reid that have collectively elevated the issue within American politics.

In July 2023, Senator Chuck Schumer introduced the UAP Disclosure Act as an amendment to the National Defense Authorization Act (NDAA) for Fiscal Year 2024, with bipartisan support.

In summary, the Senate version called for:

1. The establishment of an independent Review Board composed of nine members with expertise in areas such as science, constitutional law, and whistleblower advocacy, while safeguarding the board's independence from government and military influence.

2. UAP records should be disclosed by default unless a compelling reason to withhold them is demonstrated.

3. A phased timeline to declassify UAP records, requiring government agencies to release certain documents by set deadlines.

4. Enable the government to use eminent domain to acquire UAP-related intellectual property from private entities or defense contractors (giving compensation).

5. Enhanced protections for whistleblowers.³¹

Then it went to the House, where Mike Turner (Chairman of the House Intelligence Committee) and Mike Rogers (Chairman of the House Armed Services Committee) gutted it. What actually passed into law:

1. Nope - Existing government offices like AARO received expanded oversight.

- 2. Nope Records disclosed on a case-by-case basis.
- 3. Nope Timeline left to the discretion of the DoD.
- 4. Nope Contractors are "encouraged" to share their IP, but not mandated.

5. Kinda - Clear channels were established for UAP related whistleblowers and extended to civilians, but not much different from what already existed.³²

In summary, greater authority was given to AARO. Unfortunately, however, AARO is trash. AARO does more gaslighting than a five-ton filament powered by an F-350 power stroke diesel.

AARO Director Dr. Sean Kirkpatrick has done nothing but exclaim statements like, "We have not found any evidence to support the idea that these phenomena are extraordinary in nature or originate from sources outside our planet," or AARO has not uncovered any evidence to support the existence of secret government programs involving UAPs or non-human technology."³³

Of course, he always omits the fact that for many of these confounding phenomena, they have no evidence to support the idea that they *are not* extraordinary in nature. Elizondo, who previously led the Pentagon's AATIP program, has publicly criticized AARO's lack of transparency and accountability, suggesting that it is obstructing genuine efforts to disclose information about UAPs.³⁴ David Grusch has similarly refused to engage with AARO, citing concerns over their unwillingness to seriously investigate UAP incidents, even alleging that AARO is part of a broader effort to suppress the truth about government-held knowledge of extraterrestrial technologies.³⁵ (However, The new director, Dr. Jon T. Kosloski, has signaled a potentially more transparent and open approach moving forward.)

Now, why would Rep. Mike Turner, of Ohio's 10th Congressional District, want to block the bill? Some speculate it could be linked to the 10th being home to Wright-Patterson Air Force Base (WPAFB), the National Air and Space Intelligence Center (NASIC), and several aerospace companies. NASIC is responsible for analyzing foreign air and space threats, while WPAFB

serves as a crucial hub for defense and aerospace research.³⁶ There is also speculation that the Roswell wreckage and bodies may have been taken to WPAFB for examination and may still reside there.³⁷

Why would Rep. Mike Rogers, of Alabama's 3rd Congressional District, want to block the bill? Some speculate it could be linked to the 3rd being home to Radiance Technologies, which specializes in high-tech solutions in areas related to defense, aerospace, and missile systems.³⁸

These Reps must have some sort of hidden agenda. Otherwise, why gut nearly all the important provisions in the UAPDA? Why prevent the sharing of IP or the disclosure of old records if there's no there there? The answer: there's a there there.

On May 12, 2025, a public hearing on UAPs will be held by the House Oversight Committee, led by Rep. Anna Paulina Luna. Prior to the hearing, a classified SCIF briefing will take place on April 29. The hearing will feature testimonies from witnesses with direct knowledge of UAP-related activities, with Grusch and Elizondo advising the Committee. The event promises to shed new light on UAPs and potentially catalyze a major shift in public understanding.³⁹

Why are they here?

Since the dawn of time, alien beings have helped shape Earth and its life forms. This blue-green sphere, teeming with life provides the optimal environment for some type of free-will model testing, while also nurturing the rise of consciousness as the ultimate expression of universal connection.

I believe that, though still maintaining agency, we are their laboratory, with the added benefit of consciousness propagation. But said agency has gotten us to this point. With only three-hundred thousand years of being a species (against billions), like dry ice in a frying pan, we've sizzled to a point of near extinction.

Whether it be our nukes, ceaseless wars, germ manipulations, melting polar ice caps, mass extinction of species, or a rain forest on fire, this experiment has gone off the rails.

The Amazon rainforest is experiencing intensified fires due to a prolonged drought, pushing it toward a critical tipping point. With 18-20% of its cover already lost, experts warn that exceeding 20-25% could have irreversible consequences.⁴⁰ Overfishing and pollution have led to a 50% loss of global coral reefs since 1950. As habitats for 25% of marine species, coral reefs are vital to ecosystems now under threat.⁴¹ According to a 2019 UN report, approximately 1 million plant and animal species face extinction within the next few decades. And according to the World Wildlife Fund, between 1970 and today, populations of monitored wildlife species have decreased by an average of 73%!⁴²

Perhaps the increase in alien visits is a response to humanity setting its own laboratory on fire. I can't help but wonder: are they here to help us put it out?

On September 16, 1994, two small gray beings in "tight black suits and big eyes" landed near the Ariel School in Zimbabwe and telepathically communicated warnings to the children about the harm humanity is causing to the planet: "I think they want people to know that we're actually harming this world,' said one girl with blond pigtails, 'and that we mustn't get too technologed.' Another child added, 'It was like in the world, all the trees would just go down and there would be no air and people would be dying.'"⁴³

Although contact has already begun, disclosure could be delayed for decades if we don't actively demand it. Many years from now, you will be asked, "What did you do when the Greatest Awakening began?" Did you sit on the sidelines in silence, contributing to the further delay of disclosure? Or did you speak up, take action, do something to help raise our collective consciousness?

We are on the brink of a historic shift—one that will redefine everything we know. Something incredible is unfolding, but achieving full transparency depends on our collective voice. Though it may be hard to believe that we could be the generation to usher in a new epoch in human evolution and planetary healing, we must embrace this new reality. It's time to wake up, care, and take action for disclosure.
