Property coverage

Builder's risk

Liability coverage

Additional insured

Required by contract agreement or permit. We offer blanket additional insured status for those from whom you lease the premises where you conduct your business, or equipment related to your business; also, to those for whom you perform work if your contract requires it.

Construction projects – general aggregate per project

A separate aggregate limit applies to each of your projects.

Contractor's amendment of pollution exclusion – job sites

Offers liability coverage for sudden and accidental bodily injury and property damage to tangible property that occurs when a contractor accidentally pollutes a job site.

Primary and noncontributory – contractors

We provide primary and noncontributory coverage to an additional insured, helping you comply with construction contracts that often require this coverage.
