- 2. All Vendor/Booth Renters must be fully set up and present during show hours.
- 3. All Vendor/Booth Renters are responsible for their property and show inventory during and not during show hours. Although security will be provided, National Collectors Xpo, LLC and the Greater Columbus Convention Center are not liable for any stolen, lost, or damaged property. The booth/table renter assumes the responsibility of his/her own insurance coverage.
- 4. No Dealer or Vendor will sell any fake or questionable autographs or property such as cards, memorabilia, watches, toys, sneakers etc. If National Collectors Xpo, LLC believes that a vendor/booth renter is selling or promoting any property that has questionable authenticity, you will be asked to remove the material from the show. Failure to remove said questionable material within one hour of a formal request by National Collectors Xpo, LLC will result in forfeiture of your booth space as well as banned from future shows.
- 5. Payment must be made in full to reserve your booth/table(s)/cases.
- 6. No refunds for Vendor/Booth rental, tables, or displays will be given except In the extremely rare circumstances that could result in the event of an act of God, such as tornado weather or war that damages or shuts down the venue (Greater Columbus Convention Center, or government shutdown because of medical epidemic, National Collectors Xpo will have the discretion to provide a full refund or a credit for a future show.
- 7. National Collectors Xpo, LLC is not responsible for any lost, damaged, misplaced or stolen items in any way.

- 8. The re-sale or transfer of tables is not permitted.
- 9. All tables must be covered. Dealers must provide their own table coverings for the show.
- 10. Badges will be supplied for dealers and must be worn during set up, show hours, as well as take down.
- 11. Dealers are expected to dress and conduct themselves in a professional manner always.
- 12. National Collectors Xpo, LLC reserves the right to establish any additional Rules, Policies and Procedures.
- 13. We want all dealers and attendees to have a wonderful experience, I agree to be friendly and professional.
- 14. I am at least 18 years old.
- 15. I hereby release National Collectors Xpo, LLC and the Greater Columbus Convention Center from any and all liability for any loss, damage, or injury I may incur while participating in the show.
