**President's Comment:**

- 1. On going talks with ELS Management we need to exercise patience. New ceiling windows are installed.**

**Linda Johnson, is the new system WIFI dependent? Dave, no it is not.**

**T. Dobbs 04-J, only 500 homes paying for.**

**M. James 55-K, I believe we should by the new system.**

**S. Gielow 11-M, in 2012 we didn't have half the stuff we have now. ELS just won't pay for things we need.**

**31-A are the residents here paying the pass thru tax for the missing homes. ELS should be responsible for the vacant lots. Dave G, I will check with management & get back with the resident.**

**L. Lindquist 54-H, I am the FMO rep & if you would like information or to signup please contact me.**

**M. James 55-K, the pond behind my home is full of scum & overgrown with grass. Dave G, management, has been working with the company.**

**J. White 35-I, can we encourage ELS to have a scooper to clean the ponds & not depend on chemicals.**

**E. White 35-I, I think the ponds look great.**

**T. Dobbs 04- J, the reason ponds are kept to lower level is so they don't flood homes. The front ponds receive their water from Pine Lakes.**

**M. James 55-K, the pond water on Spyglass is used to water the golf course. Can we send ELS the bill for the new sound system. We keep spending money that ELS should pay. Dave G, we can't make ELS pay for equipment & HOA only spend on things the community needs.**

**B. Brown 04-G, received letter from ELS stating a fee of \$12.00 Joshua Tree would weed trim yards. Dave G, the HOA, does not support this as it is a change to our prospectus & every resident would be charged even if didn't want service. We will have a discussion in January when majority of residents are here.**

**F. Janvrin 30-C, at night golfcarts & bikes are on the road without lights. Is there a way to make residents have lights on? Dave G, I will have to check with management on that issue.**

**ML Quevedo 02-L, we used to have weed trimming for \$7.00 & HOA took it away. Pond scum is health issue & we should notify the will be health dept.**

**S. Winter 34-E, what is the plan for home replacement. Dave G, we will be getting 4 new homes then 9 more after. Cost of**

**new homes will be between \$194,000.00 to \$204,000.00. Lots in the center of cul sac's missing one unit won't be replaced.**

**G. Olbrich 22-G, read complaints about D. Gregson r/t Informer. Dave G. stated if he had a complaint with him or board discuss after meeting.**

**C. Alhert 36-K, 1<sup>st</sup> the ponds look beautiful. Can we tell residents to stop delivery of the Free Press. Shouldn't the residents have a vote on weed trimming. Dave G, we will discuss in January & vote on issue.**
