Why support Boys & Girls Clubs?

Because when you do, you give kids like Ariana a chance.

In kindergarten, Ariana (featured on our cover) knew she was different. When she was 5 years

old, Ariana was diagnosed with Vitiligo, a skin condition characterized by a lack of melanin, causing white patches on the skin. Vitiligo is also associated with autoimmune issues and Ariana suffers from severe food allergies that can trigger additional problems with her skin. In school, kids stared at her "funny" skin and wondered why she couldn't eat all the foods they could eat. As a result, she became quiet and kept to herself, lacking confidence to make friends.

In fourth grade Ariana joined the Boys & Girls Club. It was a safe place for Ariana. She made friends at the Club and for the first time in her life she found a place where she felt accepted by her peers. Slowly but surely, thanks to the encouragement from Club staff, Ariana began to develop more confidence in herself. The Club helped foster her love of the arts, specifically painting and dance. These became outlets where Ariana could express her emotions surrounding her condition.

In eighth grade, Ariana joined the Keystone Club, a Boys & Girls Club national program focused on building teen leadership skills with a focus on community service. Shortly after, she was named Keystone President! Then, in 2019 she was awarded a \$10,000 dance scholarship to Allen University! The little girl who was once shy, unsure, and kept to herself was now a confident young woman who was part of a family and accomplishing things she never dreamed possible!

When schools were abruptly closed in March, Ariana, joined a group of teens working daily at the Club during the COVID 19 crisis to help create virtual program content for members. She remained involved in Keystone Club, participated in daily teen discussions surrounding the pandemic, racial unrest, and the social and emotional effects of such turbulent times. When the Club re-opened for Summer Camp in June, Ariana worked alongside her fellow teens to host "fun Friday," an in-Club carnival complete with water slides, snacks, dance competitions, and relay races. As a reward for her hard work and dedication to the Club, Ariana was selected by her Teen Director to go on her first ever airplane ride thanks to a donated aerial tour through Daniel Field!

Graduation day came and Ariana admitted it just didn't feel special, a drive through ceremony wasn't what anyone had planned. But the Club was there to help her through hard times once again. The Club held its own graduation ceremony for Club seniors and invited younger Club members to celebrate the seniors' accomplishments. Then, a generous Club supporter stepped up to provide new laptops for each graduating senior and Boys & Girls Clubs of America CEO, Jim Clark, met with the seniors to commend them on their achievement and share some words of advice as they prepared to leave for college. Ariana's smile through her tears of joy touched everyone in the room and was a true testament to the love and support thousands of kids find at Boys & Girls Clubs each year.

Today Ariana is attending Savannah State as a Liberal Arts major. She is living on her own, making new friends and continuing to make her mark on the world. We are so proud of Ariana and the Club will forever be marked by her enduring spirit and journey to success.

COMMITMENT TO OUR DONOR-INVESTORS

Boys & Girls Clubs of the CSRA is committed to intentional best practices in nonprofit governance, and the Board of Directors, in its role as community stewards, takes this commitment to heart. It is only through a transparent and ethical relationship between our donor-investors, our membership, our staff, and all of the CSRA that we can fulfill this commitment and implement our mission. Through their Duty of Care, our Board of Directors, acting as trustees of resources invested in the Boys & Girls Clubs of the CSRA, uses diligence, care, and skill. They are familiar with the organization's finances and activities, and participate in its governance. As such, finances are reviewed monthly in-depth by a Finance Committee. This review includes line item comparison of monthly and year-to-date budget versus actual, monitoring of the Balance Sheet, and a summary 4-6 month Cash Flow Statement with corresponding accounts payables and receivables listed. This is supported by a secondary review of finances by the Board of Directors in its' entirety that includes a classification comparison of monthly and year-to-date budget versus actual, Cash Flow Statement and Balance Sheet. Two signatures are required on all checks, with supporting documentation attached for approval. Each year, as an affiliate of Boys & Girls Clubs of America, a full audit is conducted which includes a rigorous risk assessment of accounting and financial reporting systems. In addition to our regular annual audit, a comprehensive A-133 audit is also done on our large programs. Once again in 2020, this resulted in an unmodified, or clean, opinion on our 2019 financial statements with NO FINDINGS. The Boys & Girls Clubs of the CSRA is happy to make available to any member of the public a copy of our financial statements upon request. The Form 990 filing for the organization can be found on guidestar.org. There you can review the most current Form 990. In an effort to maintain transparency, you can also find all of these documents on our website: www.bgccsra.org. The Boys & Girls Clubs of the CSRA maintains a strong, layered segregation of duties for financial controls that ensures no less than four individuals are involved in any single transaction. This process includes an individual to input the transaction in a timely manner, a separate individual to review the transaction for mistakes, errors or fraud, another person to approve the transaction, and finally one last individual to substantiate the transaction to ensure it is utilized as intended in the carrying out of the mission for the organization. 

SIX WAYS WE

MEASURE SUCCESS



1. FORMULA FOR IMPACT ASSESSMENT

Our Formula for Impact Assessment helps our Clubs assess and improve the quality of our programs in order to deepen our impact on the youth we serve. The assessment is used as an annual action plan to guide staff in achieving positive outcomes and maximum program results.



2. KEY PERFORMANCE INDICATORS

Key Performance Indicators allow us to measure our programs and operations in 21 different areas including: strategic growth, impact, financials, resources, and board engagement. These indicators allow us to compare our organization to other Boys & Girls Clubs across the nation and give us the ability to track our performance over time.



3. CHILD SAFETY ASSESSMENT

Our annual Child Safety Assessment measures the efficiency of our policies and procedures in 50 different areas. We focus our safety assessment on transportation, technology, facilities, hazards, emergency response, insurance coverages, and daily operations.



4. NATIONAL YOUTH OUTCOMES INITIATIVE

Commonly referred to as NYOI, the National Youth Outcomes Initiative, provides measurement indicators on our strategic outcome areas of Academic Success, Healthy Lifestyles, and Good Character & Citizenship. The NYOI reports on indicators related to our members' overall Club experience and utilizes a member data tracking system along with survey data to benchmark our Clubs' impact both locally and nationally.



5. ANNUAL FINANCIAL AUDIT

Our Annual Financial Audit is conducted by a licensed certified public accountant who analyzes our financial transactions, procedures, and activities in order to asses the fiscal soundness of our organization.



6. BGCA ANNUAL REPORT

The Boys & Girls Clubs of America Annual Report is a comprehensive analysis of the organization as a whole. The report gives us 60+ pages of data related to our programs, Club attendance, board activity, financial activity, resource development, personnel, and operations.

WHAT IS YOUTH OF THE YEAR?

Youth of the Year is a national year-round program focused on the development of Boys & Girls Club members as community leaders. The program begins at the local level as Clubs select their Youth of the Month and then nominate finalists to compete for the title of Boys & Girls Clubs of the CSRA Youth of the Year. Candidates for Youth of the Year are evaluated on a number of criteria including academic performance, service to the community and Club, public speaking, and essay writing. Presenting sponsor Barney's Pharmacy awards a \$2,500 scholarship to the Boys & Girls Clubs of the CSRA youth who wins the competition. The Youth of the Year winner is also given the opportunity to compete with other Club members at the state, regional, and national levels with the potential to earn additional scholarships and meet the President of the United States.

HOW DO WE CELEBRATE OUR YOUTH OF THE YEAR CANDIDATES?

This year's finalists went before a panel of judges made up of CSRA leaders and BGC supporters including Beth Pollock, Mark Doyle, Bill Geiger, and Maria Jenkins. During the judging process our youth gave speeches for the panel, submitted multiple essays, and worked their way through coaching sessions and interviews with our judges. After the final round of judging, youth were scored on their performance across all categories and a winner was selected- to be announced on the big night.

On February 11th 2020, Barney's Pharmacy sponsored the Youth of the Year Celebration, to bring community members, Club supporters, and Club youth together. Our Youth of the Year candidates, finalists, their families, friends, and a room full of community members gathered to hear about our outstanding youth over a meal generously donated by Chris Cunningham of WifeSaver Restaurants. Over the course of the night, candidates were recognized for their achievements, finalists were given the opportunity to speak about themselves and their Club experience and Kevin Stalker of Sarasota County, shared his own club experience and journey from a Club kid to a graduate of Duquesne University thanks to a full scholarship from his Boys & Girls Club.

The event culminated with the announcement of the winner and a \$2,500 scholarship check from Barney's Pharmacy to the Boys & Girls Clubs of the CSRA Youth of the Year winner, Haley Evans. Whaley went on to represent the CSRA placing in the top 6 for the State. Haley was been a member of the Boys & Girls Clubs of the CSRA for seven years. She participated in a summer internship program at Augusta University, spoke at the GREAT Futures Celebration with Deion Sanders in July and aspires to become a psychologist.

Boys & Girls Club's evening dinner service is a vital part of club programming. We recognized that despite club doors being closed in March, this service had to continue. COVID-19 meal service included door-to- door delivery of breakfast and lunch every day, and a grab and go evening dinner at 5 Clubs for families 7 days a week. From March through August of 2020, our organization served over 25,000 meals in the CSRA. We partnered with the Richmond County School System to provide breakfast and lunch to families in our community. Every morning, our Club staff delivered a healthy breakfast and lunch door to door for families in need of meals. Parents were also able to call a hotline to schedule meals for next day delivery. At 5pm, families would stop by one of five Club sites to receive free to-go dinners.

INNOVATIVE ONLINE CLUB ACTIVITIES

In April, we created and launched **#BGCFROMHOME**, a brand new interactive way for members and families to engage with the Clubs on a daily basis remotely (via our website, our Facebook page, and our new YouTube channel), and a platform for us to continue offering GREAT Futures Academy programming virtually. In addition to providing instructions through videos, the Club sent activity packets to each Club member, complete with all supplies needed to complete the virtual activities. Through the new website, Club members can access a daily routine that includes activities in academic enrichment, healthy lifestyles, good character & citizenship. Plus virtual field trips and fun family activities. Our **#BGCFROMHOME** program includes:

- READING CAFÉ Virtual story time to reinforce literacy.
- STAY SMART Help with assignments from school and virtual tutoring by certified teachers.
- POWER HOUR Extra help with assignments, intended to improve math, reading and science.
- VIRTUAL DANCE STUDIO Videos by our Club's dance instructor to help get kids moving!.
- CLUB CONNECTIONS Activity videos and resources centered on Academic Success, Character, and Healthy Lifestyles to keep members engaged and reinforce positive relationships. Club staff and other familiar faces create the videos to keep members connected with their Club.
- WEEKLY FAMILY CHALLENGE Instructional videos and activities that promote family engagement. Parents can submit videos of their family doing the activities and win prizes!
- **REFLECTION TIME** A time where we encourage families to reflect on the day and have open dialogue for positive parent/child communication.
- VIRTUAL FIELD TRIP Fun virtual "field trips" posted weekly for the entire family to enjoy!

SUPPORT FOR MENTAL HEALTH

Boys & Girls Club believes that a child's social and emotional health during a time like this is just as critical as his/her education. We've provided support through partnerships with professional counselors to help kids deal with the stress of these uncertain times. Additionally, we offer parent resources such as guidance on daily routines, family activities, and virtual tutoring to assist with daily school lessons.

Following graduation in May Bryan wants to focus on bringing technical and skilled labor programs to youth in his community. OVER 98% OF BGC SENIORS GRADUATE FROM HIGH SCHOOL WITH A PLAN FOR CONTINUED EDUCATION, WORK, OR MILITARY SERVICE.

HERE'S WHY IT MATTERS: The Alliance for Excellent Education recently reported the best economic stimulus for a community is a high school diploma in the hands of its young people. The dropout rate has reached epidemic proportions, especially among students exhibiting two of three risk factors including low socio-economic status, minority ethnic status, and single female headed household status, in short, the youth most in need of our Clubs. Without a high school diploma, young people are far more likely to spend their lives periodically unemployed, on government assistance, or cycling in and out of the prison system. In today's knowledge based economy, high school dropouts are not the only ones affected when they choose to drop out.

70% OF TEEN MOTHERS EVENTUALLY DROP OUT OF SCHOOL. SINCE 2009, NO REGULARLY PARTICIPATING BGC MEMBERS HAVE BECOME PARENTS.

HERE'S WHY IT MATTERS: Lower local, state, and national tax revenues are the most obvious consequences of higher dropout rates; even when dropouts are employed, they earn, on average, \$8,000 less annually than high school graduates and they pay less in taxes. State and local economies suffer further when they have less-educated populaces, as they find it more difficult to attract new business investments. Simultaneously, these entities must spend more on social programs when they have lower educational levels.

NOT A SINGLE BGC MEMBER HAS ENTERED THE JUVENILE JUSTICE SYSTEM AS A FIRST TIME OFFENDER IN 11 YEARS.

HERE'S WHY IT MATTERS: Most youth who enter the juvenile justice system do so at considerable cost to their futures and their communities. Taxpayers pay an average of \$90,000 to incarcerate a young person for one year in a detention program, and the social and personal ramifications of incarceration are steep. Not only is incarceration expensive, but recidivism rates among youth are shockingly high and many establish the anti-social attitudes and relationships while incarcerated that place them at risk for a life-time of criminal behavior. Risk factors that indicate a child may become delinquent are easily identified and include academic failure, peer delinquency, and lack of supervision. BGC programs help young people address the issues that are prevalent in their communities and among their peers in constructive ways and avoid risky behaviors all together.


