# JCGC 2025 Annual Championship Terms of Competition

### Eligibility

Must be a member of Jackson County Golf Club (JCGC); and must have played in a minimum of **SEVEN** sanctioned JCGC tournaments since **October 1, 2024**; and must complete and submit the required entry form along with **\$110.00** fee to any Board Member by **July 28, 2025** 

#### **The Competition**

The competition will consist of 36 holes played on two consecutive Mondays at Junaluska and Springdale Country Club on **August 18 and 25**, respectively. Players must complete all 36 holes to be eligible for prizes.

Players must register with the Coordinator and the Pro Shop (sign in for a cart) in the Pro Shop by 45 minutes prior to the first scheduled tee time of the day. Players' names will be placed on carts to facilitate registration. Greens Fees will have been paid by the club. In the event of cancellation for any reason, the Committee will determine the alternate time, date and location, and inform all registered players.

All players must attend a Players' Meeting in the vicinity of the entry to the Pro Shop at 15 minutes prior to the first scheduled tee time for the day.

The first Tee Time shall be **9:00 a.m. on August 18<sup>th</sup> and 9:30 a.m. on August 25<sup>th</sup>**. (weather permitting) with others to follow at intervals determined by the Committee.

Play will be Stroke Play following USGA Rules as modified by then current JCGC Local Rules.

Players will choose their preferred set of tees as declared on their entry form and must use those tees for the entire 18 holes selected.

Net Score (net of current playing handicap) champions will be determined with prizes awarded for each.

In the event of a tie for first place for Net or Gross Score, a Scorecard Playoff shall be used to determine the winner. The winner shall be the player with the lowest gross or net score (as appropriate) for the last nine holes, then if still tied, the prior nine holes, and so on. If still tied, then a hole by hole low net score Scorecard Playoff will be used beginning with the 36<sup>th</sup> hole and working backwards.

## **Player Groups**

Group pairings will be determined in advance by the Committee. (Indicate cart partner on Entry Form)

Each group will be assigned a Captain from among the Group by the Committee. Captains will meet at 20 minutes prior to the first scheduled tee time of the day in the vicinity of the entry to the Pro Shop. The Captain is responsible for determining the answer to any rules question. The Captain is also responsible for enforcing Pace of Play standards, including limiting search time for a ball to **three (3) minutes**.

The drivers of the carts in the Group shall each maintain scorecards for the group. Following completion of the round, the drivers shall total the score for each player and resolve any differences between the scorecards. The drivers must sign the scorecard to be turned in.

Completed scorecards are to be deposited in the JCGC scorecard box located near the green of the last hole of the tournament.

#### **Results and Presentation of Awards**

Results of the Tournament and Awards shall be provided by the Committee at the annual meeting and banquet on September 11th.

Prizes to be awarded:

**For Low Net Score:** 1st, 2nd, and 3rd for Overall and each nine hole course in accordance with JCGC award practices based on playing handicaps and the allotted pool for each tournament.

**Low Gross Score:** 1<sup>st</sup> only. (Same person cannot win both low and gross – Net Score will take precedence.)

Closest to the Pin: (CTP) holes will be 5,9,11 & 15 at Junaluska and all par 3's at Springdale.

**Skins:** will be determined by lowest gross score on each hole.
