CHRISTMAS FOR THE LAMBS

Earlier in November, founder of "When I Ministries", FGCI Ordained Minister, Sister Reta Steele Dyson of Osceola, Missouri, went home to be with the Lord. Even after her passing, Sister Reta still had a mission to complete.

Beginning in 1993, Sister Reta answered the call set out in scripture to visit those in prison, and took this ministry very seriously. Every Monday night she would meet with both men and women prisoners in the local Federal Holding Facility, for Bible Study and prayer. She very rarely missed, even in times of sickness.

Over the years she began the Christmas for the Lambs project, in which she sent gospel based gifts and cards to the children and loved ones of those incarcerated. Year after year, she completed this important project and as it grew to surrounding jails and prisons, she had to enlist help. It is amazing to see the impact that Sister Reta had in growing the Kingdom of God...uncountable souls came into the saving knowledge of Jesus Christ!

As her health declined this past year, her focus was getting gifts out to prisoner's families, sending the message that they were loved this Christmas. With the help of Sister Debbie Ferguson, (FGCI Exhorter) and her local church family, Christmas for the Lambs was once again completed, with over 300 gifts and cards sent out in 2018. This is evidence of true calling of God, a work that continues even in our absence! Please be in prayer for the continuation of this ministry.
