**POLICE:** Written report submitted. Chief Nydegger informed the board that our new officer Kenny Kissel has completed training and graduation and is now on patrol. Nydegger also commented on two training days for the officers.

**TIF:** Trustee Snyder informed the board that all TIF letters of support of taxing bodies have been received and forwarded to Gwen at Jacob and Klein, who composed a letter on our behalf. Snyder has forwarded the letter to appropriate representatives and hopes to get in a bill this Spring and passed through the General Assembly. If the extension is granted, the TIF program would continue to 2033, payable to 2034. There has been no word on the status of the OSLAD grant application.

## **COMMITTEE REPORTS**

**UTILITIES:** Superintendent's written report submitted. Superintendent Kemp discussed problems with the lagoon flooding, resulting in a report being filed with the IEPA. Trustee Sndyer stated she was approached by a representative of CUSD #16 regarding a problem that has taken place over the last six to nine months at the school in which corrosion is appearing on the exterior of the copper pipes containing hot water, which have been replaced three times in the last six months. Cameron Jones will look into the problem.

Cameron Jones from Benton and Associates updated the Board on the ongoing projects:

-Birch Street Water Main Extension- Railroad permit agreement should be approved tonight. We are waiting on easements.

-Waste Water Treatment Plant- Jones stated we have approximately eight or nine bidders on the list. A pre-bid meeting and site visit will be held tomorrow, Thursday, January 16, 2020 at 2:00 p.m. at the New Berlin Village Hall. Jones will have an addendum Friday or Monday and February 11<sup>th</sup> is open bids. After the EPA reviews, Jones anticipates about May to be able to award and move forward.

-South Sangamon Water Commission- SSWC has a modem but still needs a Verizon Data card in order to obtain a login for Superintendent Kemp, which will allow Kemp control at the water tower. SSWC has not responded to the Board's requests for information from October. Jones will re-send second letter tomorrow.

**MOTION:** For approval of Resolution 01-20, A Resolution Approving and Authorizing the Execution and Delivery of a Standard Pipe License Agreement with Norfolk Southern.

**STREETS AND PARKS:** Superintendent's written report submitted. Flags were removed after the holidays. The Veteran's Memorial has a light that needs repaired.

Trustee Snyder commented on available grants due in March for bike trails but Snyder said we would not be applying at this time.

**FINANCE:** Trustee Neuman reminded the Board that the fiscal year was coming to an end soon and will time to prepare the budget for FY2021.

Trustee Morris expressed interest in budgeting for a Comprehensive Plan, which has been discussed in past years. Trustee Snyder stated that plans had begun at one time and she will follow up to see if that service is currently being offered through the Regional Planning Commission or if a basic plan should be completed online.

While thinking of next year's budget, Morris also reminded the board of discussions to hire an outside firm to review Village Ordinances, which has been budgeted for previously.

**HEALTH AND SAFETY:** Numerous vehicles at a single residence was discussed. Also discussed was an awning in the downtown area that needs repaired.

**PERSONNEL:** Mayor Krall and Attorney Brokaw opened a discussion regarding the salaries of the Village Board. Brokaw stated that the Treasurer and Clerk positions in New Berlin were underpaid compared to other municipalities. Mayor Krall would also like the Board to be paid after each meeting, instead of twice per year.

**MOTION:** To amend Personnel Ordinance 20-01, An Ordinance amending Section 1-3-1 of the Village Code of the Village of New Berlin, Illinois Relating to Salaries of Village Officials for the following items:

- 1. Section 5 effective 5-1-2020, the beginning of FY 2021 and upon publication as required by law.
- 2. Section C Village Clerk \$4500.00/year or \$375.00/month and \$50.00 for each special meeting.
- 3. Section D Treasurer \$4500.00/year or \$375.00/month and \$50.00 for each special meeting.
- 4. Trustees will be paid monthly instead of twice per year.
