

NEW BERLIN ZONING BOARD OF APPEALS

AUGUST 28, 2008

The New Berlin Board of Appeals met on August 28, 2008 at 7:00 p.m. to review the proposed amended ordinance relating to parking of semi trailers, travel trailers and commercial vehicles.

Chairman Berry opened the meeting at 7:00 p.m. with the call for roll. Members Rhodes, Hatfield, King, Gorsich and Sweet answering present. Member Cantrall was absent.

Minutes of the July 14, 2008 meeting were read and approved as read with a motion by Member Rhodes and seconded by Member Hatfield. Motion passed.

OLD BUSINESS - The Ordinance amending certain provisions of the New Berlin Code of Ordinances pertaining to parking of semi trailer, travel trailers, and commercial vehicles has been revised and sent back to the Zoning Board of Appeals for review and to make a recommendation to the New Berlin Village Board. It was opened to the audience for discussion with no comments being made. After discussion, the Zoning Board of Appeals made the recommendation to the New Berlin Village Board to adopt the Ordinance as amended. The change was to Section 2, Paragraph E to add "within a six (6) hour period" after fifteen (15) minutes. A motion was made by Member Sweet and seconded by Member King to make the recommendation as amended. Motion passed unanimously.

NEW Business - An Ordinance Amending Provision of the New Berlin Code of Ordinances pertaining to the Plan Commission was presented for Zoning Board approval. Steve Frank, Mayor, was present to request the Zoning Board of Appeal members serve as members of the newly created Planning Commission. Members would serve simultaneously on the Board of Appeals and Planning Commission. The members of the Zoning Board agreed to serve in both capacities.

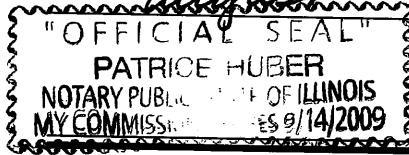
