VETERANS BRICK PAVER ORDER FORM

VETERANS BRICK POLICY

- Named person must be a Veteran, living or deceased, of any branch of the United States Military: Army,
 Marine Corps, Navy, Air Force, Coast Guard, or Merchant Marines; serving during peacetime or wartime in
 any conflict. Exceptions to this policy will be made on a case by case basis. Contact the Village of
 New Berlin for details.
- Male or female veterans may qualify to have their name added to the New Berlin Veteran's Memorial. There will be no restrictions for residency on veterans. This general policy is an attempt to be inclusive rather than exclusive for determining names on the Veterans Memorial.
- 3. An individual must hold an honorable discharge or a discharge under honorable conditions, such as medical, family emergency, etc. or be currently serving to qualify for a name to be added to the memorial.
- 4. If such person subsequently is discovered to have had a less than an honorable discharge, his/her name shall be removed immediately. No refund will be given and additional charges for removal may be charged.
- 5. For individuals serving more than one enlistment or branch of the Armed Forces of the United States of America, the last enlistment must meet the same qualifications as stated in Item #3.
