TIF: Dave Barrow from Concrete Ink addressed the board regarding repairing and resurfacing the concrete in the downtown area. Attorney Brokaw advised any bids received should include prevailing wage. Mr. Barrow will meet with Mayor Krall to examine the affected area and discuss specifics. TIF funds could be used for this project.

The Jacksonville organization has discontinued the bottle caps recycling program. Please turn in all bottle caps before March 31, 2019.

Eckley Lawn Care submitted a quote of \$3300.00, 12 monthly installments of \$275.00 beginning May 1, 2019 through April 30, 2020 to mow and trim Wabash, North and Corbett Parks and the Village sign at the west end of town to be paid from TIF funds.

Ameren has set three poles in the downtown area on the south side of the street. One light is operational and there are three others left to light. Solar lighting for the north side of the street was again discussed.
