Finance— Written Treasurer's Report. Clerk Lakamp shared research resulting in overpayment letters to trustees that will be forthcoming by an item identified in the Audit. There is a need to contact Locis for a few financial items. Review of items Amanda Lazzara, Deputy Clerk, learned in Locis. Discussion that online payments offered no financial checks and balances. Treasurer Libben is working on balancing January 2025.

Utilities— Written report. Water Superintendent did not attend the Water Conference due to illness. Discussion of Water Superintendent time off. Door hangers are out, and good progress is being made on collecting delinquent water accounts. There is a potential SRF grant for the replacement of the Terminal Lift Station. The initial estimate is \$550,000-\$750,000 per engineer to fix if the lift station goes down. In addition, if it goes down the system will not work. SRF Grant has a loan application, which is due on March 31, 2025, and is the same program as used in upgrading the wastewater plant.
