What we do		
How does Red Cedar protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards, encryption, secured files and building.	
	Red Cedar trains its advisers on the proper handling of personal information and requires companies that help provide services to you to protect the confidentiality of personal information they receive.	
How does Red Cedar collect my personal information? Why can't I limit all sharing?	 Federal law gives you the right to limit only: Sharing for affiliates' everyday business purposes – information about your credit worthiness Affiliates from using your information to market to you Sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law. 	
What happens when I limit sharing for an account I hold jointly with someone else?	Your choice will apply to everyone on your account – unless you tell us otherwise.	
Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. • Our affiliates include companies with a common Red Cedar Advisory, Inc. name.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. • Red Cedar does not share with nonaffiliates so they can market to you.	
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • Red Cedar does not jointly market.

Why?	Financial institutions choose how to share Client's Information in accordance with the law. Federal law requires Red Cedar ("Firm") to explain to the Client how we collect, share and protect Client's data/personal information.
