**MASKS REQUIRED AT ALL TIMES FOR VENDORS
We will have courtesy masks available for vendors.**

SETUP AND COVERAGE: All dealers must be uncovered by opening time and must stay open during the full public hours.

VENDOR SPOTS: Location assignments are at the discretion of the Promoter. Each spot is 10 x 10 and however many tables you choose to set up underneath.

PERMITTED ITEMS: Guns, Swords and Bayonets, Gun Co. Advertising, Flasks, Gun Books, Cartridges, Gun Parts and Accessories, Knives, and Military Items, Fishing Equipment, Blowguns, Martial Arts Weapons, Hunting Gear, Related Clothing. All ammunition must be in sealed containers. Smokeless powder is limited to 20lbs in 1lb containers and Pyrodex is limited to 5lbs in sealed containers. No reloading or gunsmith work allowed.

PROHIBITED ITEMS: Food products, Coins, Jewelry, Rocks, Cameras, Black Powder, If in doubt, please ask. Loaded firearms, clips or magazines are not permitted at the show.

CONDUCT: Dealers (and the public) are prohibited from soliciting purchases from the public in the parking lot, front entrance, snack bar area, and firearm check-in areas. Unprofessional conduct; unethical business practices; or violation of local, state, or federal laws; are due cause by the Promoter for removal from this Show, and refusal in future shows.

WRISTBANDS: Wristbands will be distributed during set-up and must be worn at all times. Remember, you are liable for anyone you request a wristband for.

CANCELLATIONS: Cancellations must be received in writing no later than 14 days prior to the Show.

PROMOTOR CANCELLATION: If the promoter must cancel the event due to Covid-19 restrictions or weather, vendors will receive a full refund, minus paypal processing fees, for their spots.

GUN TIES AND TAGS: All firearms must be unloaded, tied to prevent firing and the magazines removed. A supply of tags will be issued for you to tag firearms sold to the public. All walk-in firearms will be tied and tagged.

SECURITY: We will have Private Security throughout the show however: Neither the Cheshire County Fish & Game, the City of Keene nor Cleared Hot Events(the Promoter) is responsible for loss, or damage to the dealer's merchandise. The dealer specifically agrees to defend and hold harmless Cheshire County Fish & Game, the City of Keene, NH and Cleared Hot Events (the Promoter) from all claims for bodily injury and/or property damage arising out of the dealer's participation in the show.
