25 NOW, THEREFORE, the Court hereby ORDERS as follows: the Petitions for Recall
against Director Meghin Margel and Director Tim Clark are hereby DISMISSED with

1 prejudice and the Court orders that the Charges and Recall Ballot Synopses not be submitted to
2 Washington voters.
