Previous Meeting Minutes and Officer Reports:

As this is a special/emergency meeting of the E-Board, no minutes or reports will be reviewed/accepted

Purpose of Special/Emergency E-Board Meeting:

Commander Pat Sharpe opened the special/emergency meeting by announcing the resignations of Finance Officer Geno Darcy and Office Manager Debbie Wurtz, both effective February 13, 2025.

Post Adjutant Jeff Rogers then provided an update on the current status of resignations, vacancies, and appointments.

Commander Pat Sharpe recommended **Mike Cray** as Interim Finance Officer and **Keith Hines** as Interim Judge Advocate. With no objections raised, Commander Sharpe called for a motion to recommend both appointments to the General Membership at the next meeting on March 6, 2025. **Don St. Pierre** motioned to recommend Mike Cray as Finance Officer and Keith Hines as Judge Advocate, which **Jeff Conlan** seconded. **Motion passed.**

In review:

This special/emergency meeting addressed key leadership transitions within Post 186. Commander Pat Sharpe announced the resignations of Finance Officer **Geno Darcy (effective February 13, 2025)** and Office Manager **Debbie Wurtz (effective February 13, 2025)**. The Board also acknowledged the prior resignations of **Commander Don St. Pierre (effective February 1, 2025)** and **1st Vice Commander Lester Snyder (effective February 10, 2025)**, along with other vacancies.

To ensure continuity, the Executive Board approved a motion to recommend the appointments of **Mike Cray as Interim Finance Officer** and **Keith Hines as Interim Judge Advocate** to the General Membership for final approval on March 6, 2025.

Furthermore, to facilitate the transition of financial authority, **Commander Pat Sharpe will present these meeting minutes to the bank** to finalize the transfer of the Post's bank accounts. This action will officially **remove Don St. Pierre, Eugene Darcy, and Lester Snyder** as authorized representatives and **replace them with Pat Sharpe, Tom Moriarity, and Mike Cray.**
