I agree that my child will abide by the rules of the North Tampa Pride All Star Youth Sports. I agree that for the safety of my child and all others that any inappropriate behavior by my child and/or his teammates or myself may result in suspension of my child or his team, forfeiture of some or all games or dismissal from the team for any portion of, or the entire season.

I understand that football is a violent sport in which sportsman-like conduct must be displayed at all times. I consent to my child's participation in tackle football organized by the North Tampa Pride All Star Youth Sports.

If physicians are made available, I hereby consent to any and all medical treatment, which may be deemed necessary by the attending physicians. It is my intent to grant authority to administer and perform any and all examinations, treatments and diagnostic procedures which may be deemed advisable and necessary during the course of my child's care and I understand that the North Tampa Pride All Star Youth Sports does not intend to have physicians available.

GENERAL RELEASE AND WAIVER

In consideration of the undersigned participant ("Participant") being allowed to participate in various North Tampa Pride All Star Youth Sports activities and game and understanding and acknowledging that the North Tampa Pride All Star Youth Sports is a non-profit company which is receiving no monies or other monetary benefit for providing support of said events, we, the Participant and the parents and/or legal guardians of the Participant jointly and severally and intending to legally bind ourselves and on behalf of our respected spouses, ex-spouses, grandparents, family members, guardians, heirs, executors, personal and legal representatives, estates, beneficiaries, administrators, successors and assigns, (all of the ongoing, collectively the "Releasor") do hereby waive, release and discharge and covenant not to sue the North Tampa Pride All Star Youth Sports its members and the owners, lessors, lessees and/or managers of any public and/or private facilities used for the North Tampa Pride All Star Youth Sports events, all North Tampa Pride All Star Youth Sports sponsors, advertisers, officials, and all of the respective officers, directors, trustees, shareholders, managers, partners, employees, members, staff volunteers, agents, contractors, and supervisors and their successors and assigns (collectively the "Releasee") from any and all liability and/or claims for illness, injuries, disability, death and/or damages that may arise directly or indirectly as a result of Participant's participation in the North Tampa Pride All Star Youth Sports events, including, without limitation, any rights, claims, causes of action, suits, liabilities, negligence, damages, personal or bodily injury, disability, death, property damage, loss of consortium, cost and expenses whatsoever, whether arising at law or in equity, and where arising before, during, or after and North Tampa Pride All Star Youth Sports event, and whether caused by the sole or joint negligence or tortious act or omission of the Releasee or any of them or any third party (collectively the "Claims"). The Releasors hereby agree to indemnify and hold the Releasees harmless from all such Claims. The Releasors acknowledge this General Release is contractual and not a mere recital. The Releasors hereby knowingly and voluntarily waive to the fullest extent permitted by law, the benefits of any statute, law, rule, or common law, which may limit the scope of the covenant and releases contained herein.

In the event that this waiver and release is found to be invalid, unenforceable or void, in whole or in part, for any reason whatsoever, then the Releasor acknowledge and agree that in no event, including without limitation, the negligence, gross negligence or willful misconduct of the Releasees, or any of them shall the Releasees' aggregate liability to Releasors, or any other person, exceed \$300,000.00 and in no event shall Releasees or any of them be liable to any person for special, incidental or consequential or punitive damages and/or any indirect damages such as, but not limited to, exemplary damages or lost earnings, lost revenues or loss of consortium or companionship (even if the Releasees have been advised of the possibility of such damages) where based upon statute, contract, tort, negligence, strict liability or otherwise.

The Releasors are aware of, and understand fully, the potential risks involved in connection with football, understand that football is a violent sport and that serious injury and death have occurred, and each of them assume full, sole and complete responsibility for and risks of death, personal or bodily injury, disability and/or property damage resulting from, in connection with, or in any way related to, Participant's participation in the North Tampa Pride All Star Youth Sports events.

by their execution below, understanding that the Releasees are relying hereon in allowing Participant to participate in the North Tampa Pride All Star Youth Sports events, the Releasors hereby represent and warrant to the Releasees that (i) all the Participant's living parent(s) and/or legal guardian(s), as applicable, have duly signed this General Release and Waiver and (ii) Participant has no medical condition (physical or mental) which would or could impact on the Releasees allowing Participant to participate in the North Tampa Pride All Star Youth Sports events and that the Participant is physically able to participate in the North Tampa Pride All Star Youth Sports events and (iii) the Participant is not taking any herbal or medicinal supplement or prescription that could impact on Participant's participation in the North Tampa Pride All Star Youth Sports events.

Furthermore, the Releasors acknowledge that the Releasors have received the opportunity (and been strongly encouraged) to review this General Release and Waiver with an attorney in connection with the effect of the execution and delivery of this General Release and Waiver, that the Releasors have carefully read and fully understand the content of this General Release and Waiver and have asked and received answers to all questions he/she/they may have and that the Releasors have fully executed this General Release and Waiver freely and voluntarily, intending and agreeing to be fully bound by the terms hereof. The Releasors hereby grant full consent to the North Tampa Pride All Star Youth Sports the free use of the Participant's picture or name in any broadcast, telecast, print media, or other on account of any of the North Tampa Pride All Star Youth Sports events for any purpose whatsoever.
