**Construction Traffic Update for Weeks of August 2 and August 9**

**1. Eastern Linglestown Area- Mini Basins BC-2A,2B,2C,5B**

- **Project Location:** [See map](#)
- **Impacted Streets (this period):** Balthaser Street between Blue Ridge Avenue and Catherine Street. Blue Bell Avenue between Pine Street and Catherine Street. Locust Street between N. Blue Ribbon Avenue and Balthaser Street.
- **Contractor(s):** DOLI Construction Corporation
- **LPT Field Contact:** Eric Morgan (717-554-9052) or Tim Nolt (717-278-5423).
- **Nature of Work:** Sanitary sewer replacement. Yard restoration.
- **Additional Notes:** Lateral sewer replacement will continue in areas of Pine Street and Balthaser Street during this period. During the week of August 9, mainline replacement will continue on Locust Street between N. Blue Ribbon Avenue and Balthaser Street. All work will take place Monday through Thursday 6:30 am to 4:30 pm. DOLI will maintain access to properties and allow refuse trucks through the work zones.

**2. Devonshire Area- Mini Basins BC-7A,7B,7C,7D,8C,8D**

- **Impacted Streets (this period):** Palmer Drive
- **Contractor(s):** Lower Paxton Township I/I Crew.

- **Nature of Work:** Sanitary sewer testing, building sewer replacement.
- **Additional Notes:** Private sewer testing and replacement work will take place on Palmer Drive. All work will take place Monday through Friday from 6:30 am to 2:30 pm. The Crew will maintain access to properties on Palmer Drive and allow refuse trucks through the work zone.

**3. Twin Lakes-Union Deposit Road- Mini Basin SC-2B**

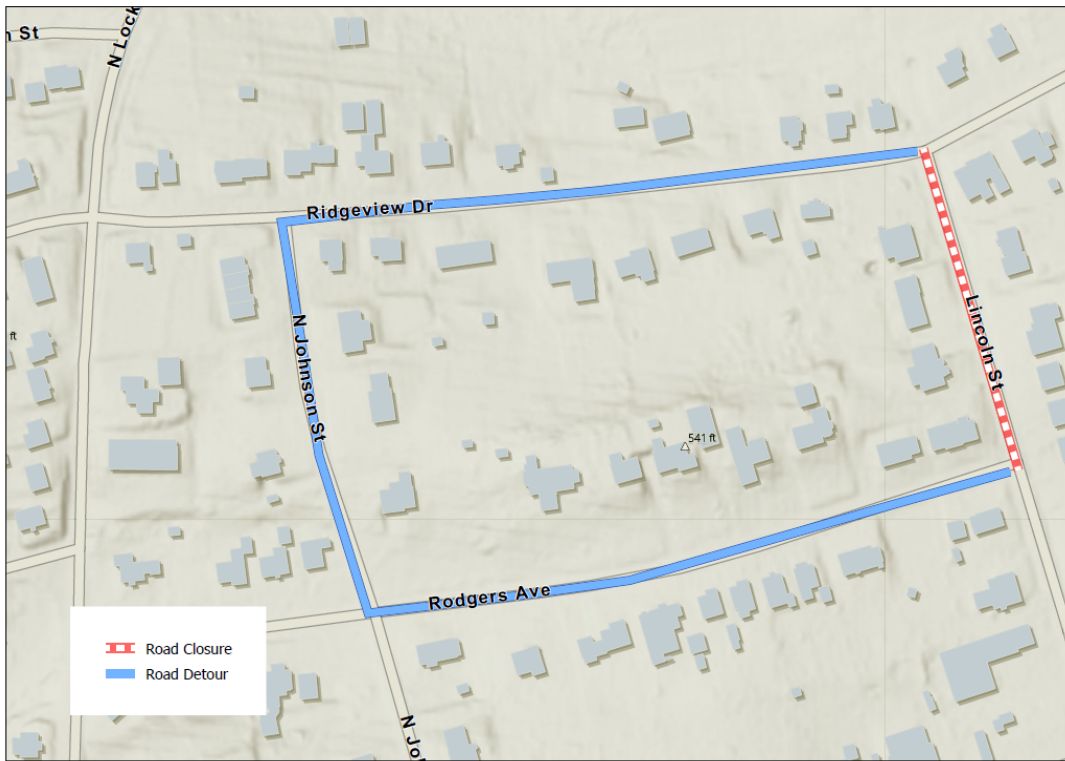
- **Project Location:** [See map](#)
- **Impacted Streets (this period):** Pleasant Road and Blue Ridge Avenue.
- **Contractor(s):** Granite Inliner LLC- Musson Brothers Inc.

- **Nature of Work:** Sanitary sewer trenchless lining
- **Additional Notes:** Lane restrictions are anticipated on the roads above during this period. Work will generally take place Monday through Friday from 7:00 am to 4:00 pm (9 am to 3:00 pm on Blue Ridge Avenue). The Crew will maintain access to properties and allow refuse trucks through the work zone.

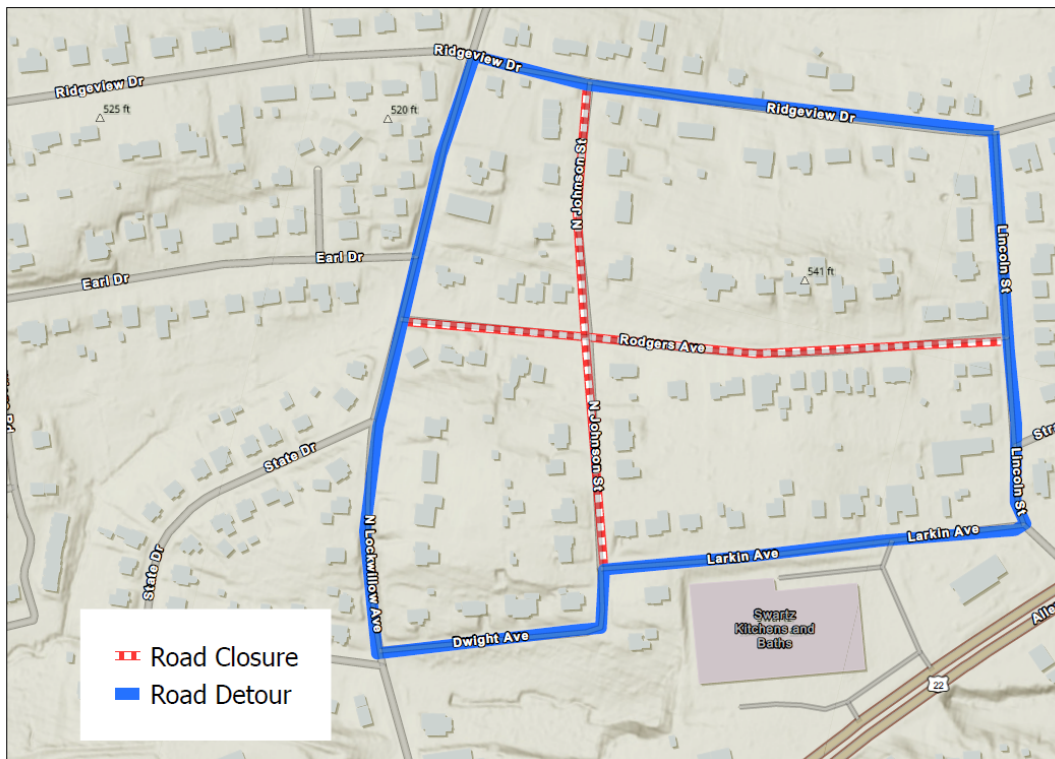
**4. Non-Consent Order/Miscellaneous Sewer Rehabilitation**

- **Project Location:** Lincoln Drive, Ridgeview Drive, Rodgers Avenue.
- **Impacted Streets (this period):** Lincoln Drive between Ridgeview Drive and Rodgers Avenue. Rodgers Drive between near its intersection with N. Johnson Street. Ridgeview Drive at its intersection with Stradford Drive.
- **Contractor(s):** DOLI Construction Corporation
- **LPT Field Contact:** Eric Morgan (717-554-9052) or Tim Nolt (717-278-5423).
- **Nature of Work:** Sanitary sewer replacement.
- **Additional Notes:**
  - Lincoln Drive- Work should start on or after Tuesday August 3 and be completed in 1 day. See figure 1 for detour.
  - Rodgers Avenue- Work should start on or after Wednesday August 4 and be completed in 1-2 days. See figure 2 for detour.

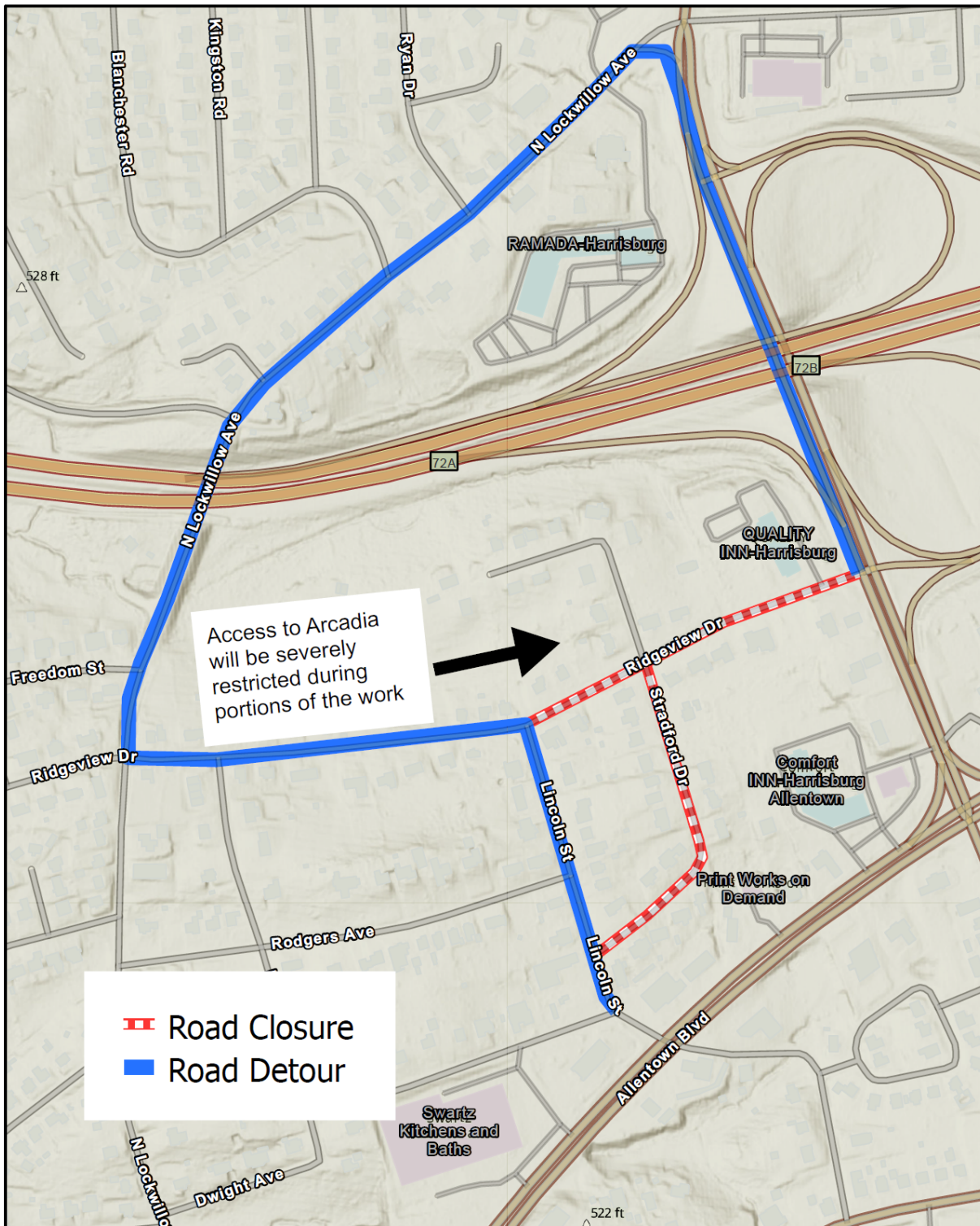


Figure 3: Ridgeview Drive Detour (August 9, tentative)

  - Ridgeview Drive- Work should start on or after Monday August 9 and be completed in 1 day. See figure 3 for detour.
  - All work will occur between 6:30 am and 4:30 pm, and all roads will be reopened at the end of the workday. DOLI will maintain access to all properties during construction to the maximum extent feasible. There is a pocket of properties on Arcardia Street and Stradford north of Ridgeview (a no outlet street) that will have very limited vehicular access to their properties during the work on Ridgeview Drive. These residents have been notified by letter and provided the opportunity to respond with their contact information for Civic Ready so we can notify them the day before the actual date of work.
  - Social media posts are scheduled, and Civic Ready notices will be issued starting on August 2.
