Meeting held at the Alki Masonic Temple in Seattle, WA

Acting President/Director Conrad Berthold opened the meeting at 10:00 a.m. with the introduction of the Board of Directors: Dale Wakem, OR Vice-President, Vince Bogard, OR Secretary, Tim Gray, WA Secretary and Tom Brown, Treasurer. Volunteers were recognized and an appeal for members to apply for open positions on the board and volunteers to assist in the BITW was made. New members and guests were recognized and warmly welcomed by the membership.

Treasurer's Report: General Fund \$12,680.99 Scholarship Fund \$14,468.65 BITW Fund \$1992.40 The 2022 budget proposal was made available to the attending members and will also be available to attending membership in December meeting in Oregon. Discussion, modifications and adoption will take place in Jan.-Feb. meetings in 2022. *Editors Note: See proposed budget below.*

Announcements: The passing of the wives of Doug Gillette and Rudy Pineau was announced. Both are named Kathi. Table rent is \$5.00 and will be collected by the treasurer.

Scholarship: Annamarie Schmidt (scholarship chairperson) informed the membership that she had two tables of merchandise and books available for sale to benefit the scholarship program. It was also announced that one recipient had postponed his education and as a result only one scholarship will be awarded this year.

Old Business: The BITW for 2022 continues to move forward with the dates of August 26 thru 28. Volunteers are needed to help with the event and should see Conrad to schedule. Conrad will meet with the Monarch management in December and will have more details.

By-Laws: Jim Gillis and the Board continue to work on rewriting the by-laws. Still a lot of research and discussion in progress and will keep the membership informed.


