

1. Equipment Use:

2. Personal Property:

o I understand that Privé Pilates is not responsible for loss, theft, or damage to personal belongings.

Children and Play Area Policy

1. Children in Designated Classes:

- o For classes offering access to the kids' play area, I acknowledge that all responsibility for the supervision, safety, and well-being of children lies solely with the parent or guardian.

2. Parental Responsibility:

I acknowledge that if my child disrupts the class in any way, I may be required to leave the studio immediately to address the situation.
- o I am solely responsible for my child(ren)'s safety and well being and accept full liability for any injuries, accidents, or incidents involving my child(ren) while on the premises.

- o I assume all risks associated with my child(ren)'s presence in the studio and play area, including any accidents, injuries, or incidents that may occur.
- o I release Privé Pilates, its owners, staff, and affiliates from any liability or claims arising from my the use of the facility.
- o I agree to ensure my child(ren) treats the play area and studio premises with respect. Any damage caused by my child(ren) will be my responsibility to repair or compensate.

1. Compliance with Studio Policies:

2. Class Cancellation and Refund Policy:

- o I understand that cancellations must be made at least 24 hours in advance to qualify for a refund or reschedule.
- o Failure to attend or late cancellations will forfeit the session fee.

CCTV Policy

1. CCTV Usage:

- o I understand that CCTV cameras are installed on the premises for the safety and security of clients, staff, and studio property.
- Recorded footage is strictly monitored by authorized personnel only. No male individuals will have access to view or review the footage at any time.
- The CCTV system is not intended for personal monitoring and will only be used for safety, security, and incident resolution purposes.
