## The Principal/Superintendent report from Dr. Lindeman included:

- Completed the purchase of a new CTE Digital Graphics Machine. Possible course offering next school year.
- Talked regarding current and future weather cancellations and changes.
- Bus bidding for a new school bus will begin in January, the RFP will be published at the start of the year for delivery by the end of the school year.
- Spoon River CEP Program and presentation by Jacob Green and Ryan Baker.
- The high school students had a hands-on activity with a professional engineer to learn more about the diverse field.
- All 16 Paraprofessionals will be attending a full day of training on January 5<sup>th</sup>,2026 at the ROE in Macomb. The training will cover the following topics regarding classroom and behavior management: Prevention strategies (forming relationships with students, offering choices, communicating with students, brain breaks, equity), the "why" behind behaviors, how to address behaviors based on the "why" (exploring specific strategies), and role-playing.
- On January 5<sup>th</sup>, the certified staff will join VIT staff at VIT for a collaboration of training. The presenter is Susan Nichols, and the topic is Staff & social media the do's & don'ts. If time allows, we will also have a PowerPoint from the TRS team providing some updates and information.
- Matt Seaton, head of financials at ISBE has provided his projections for Reimbursements for FY 26. Transportation at 75%, Special Education at 60%, Private facilities at 64% and ILL Free breakfast and lunch at 34%.
- The Christmas Program will be held on December 19th and kicks off the holiday break. Staff will return January 5<sup>th</sup> and students will return January 6<sup>th</sup>.

## The Principal report from Mr. Crouse included:

- Map testing concludes tomorrow. We are looking forward to seeing the improvement our students have made from the beginning of the school year.
- The Junior High Boys Basketball 7th graders are 3-12, while the 8th graders are 3-10

- Christmas Concert is scheduled for 1:15 on Friday December 19th.

- I attended IASB conference and the RSAC conferences. I learned a lot of useful information from both.
- Map testing is this week for the Elementary and Junior High. High School will complete their testing after Christmas break.
- Continued work on the school improvement plan.
- Rural teaching Education Pathways is a grant funded program that will provide dual credit opportunities for those interested in going into teaching as a career.
