	5.1. Failure to abide by and adhere to one or more of the requirements, upon review of the Refe Disciplinary Committee, may result in a Letter of Reprimand in accordance to US Soccer Phearing conducted within 30 days. Disciplinary action to include the following:								
	5.1.1. Suspension from assigning in the state of Nevada for a minimum of 30 days and year. Suspension status will be communicated to all Nevada clubs, leagues and so they can find a replacement assignor.
