The mission of the Johnson City Police Department is the safeguarding of all citizens' lives and property, the preservation of their constitutional rights, and to maintain a high standard of quality of life for all of Johnson City's residents and visitors. The police department will strive to develop a police service that meets unique neighborhood needs by combining law enforcement activities with progressive crime prevention strategies.



## UNIFORMED PATROL DIVISION

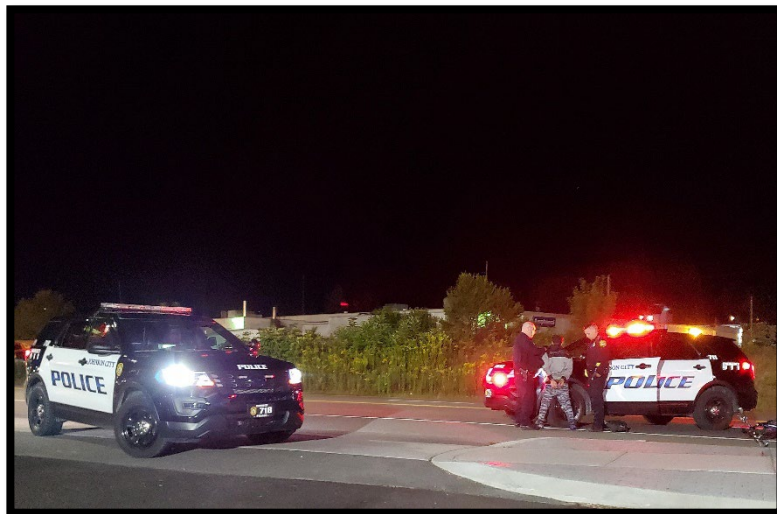
The Uniform Patrol Division functions as the primary enforcement and crime prevention branch of the Police Department. The Patrol Division is the largest branch of the Department, and serves as the backbone of all police functions.

The Patrol Division is overseen by the Captain and is comprised of 2 Lieutenants, 3 Sergeants, 25 Patrolmen, and 1 School Resource Officer. In 2021, the Patrol Division handled over 10,200 calls for service, 4,247 officer-initiated services, and made nearly 1,000 adult arrests resulting in over 1,400 charges.

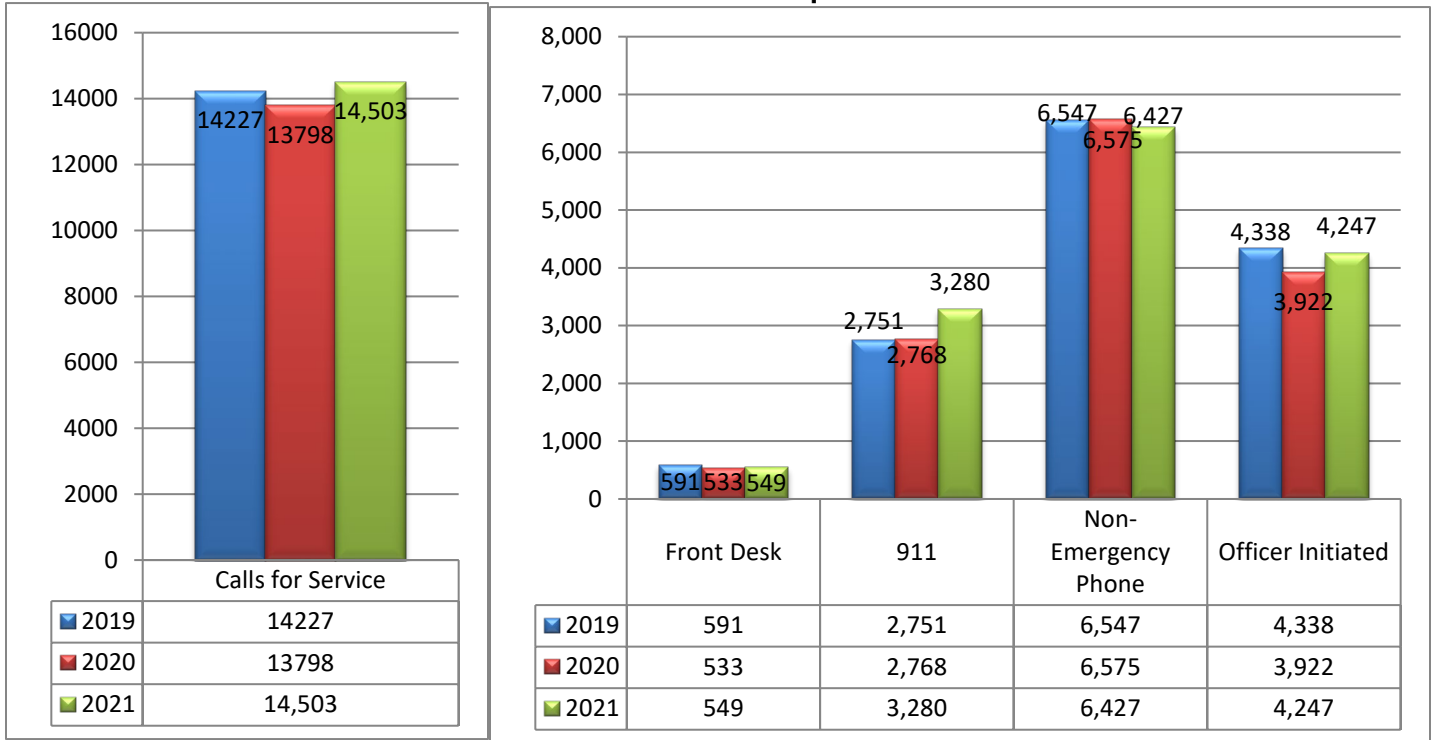
The Uniform Patrol Division is first to respond to citizens' calls for assistance, and usually first to arrive at the scene of an occurrence requiring police action. The Patrol Division is deployed 24 hours a day divided into three 8 hour shifts.

Most citizens' only contact with the police is with a member of the Patrol Division. The public's perception of the effectiveness and professionalism of the Department is largely shaped by these contacts.

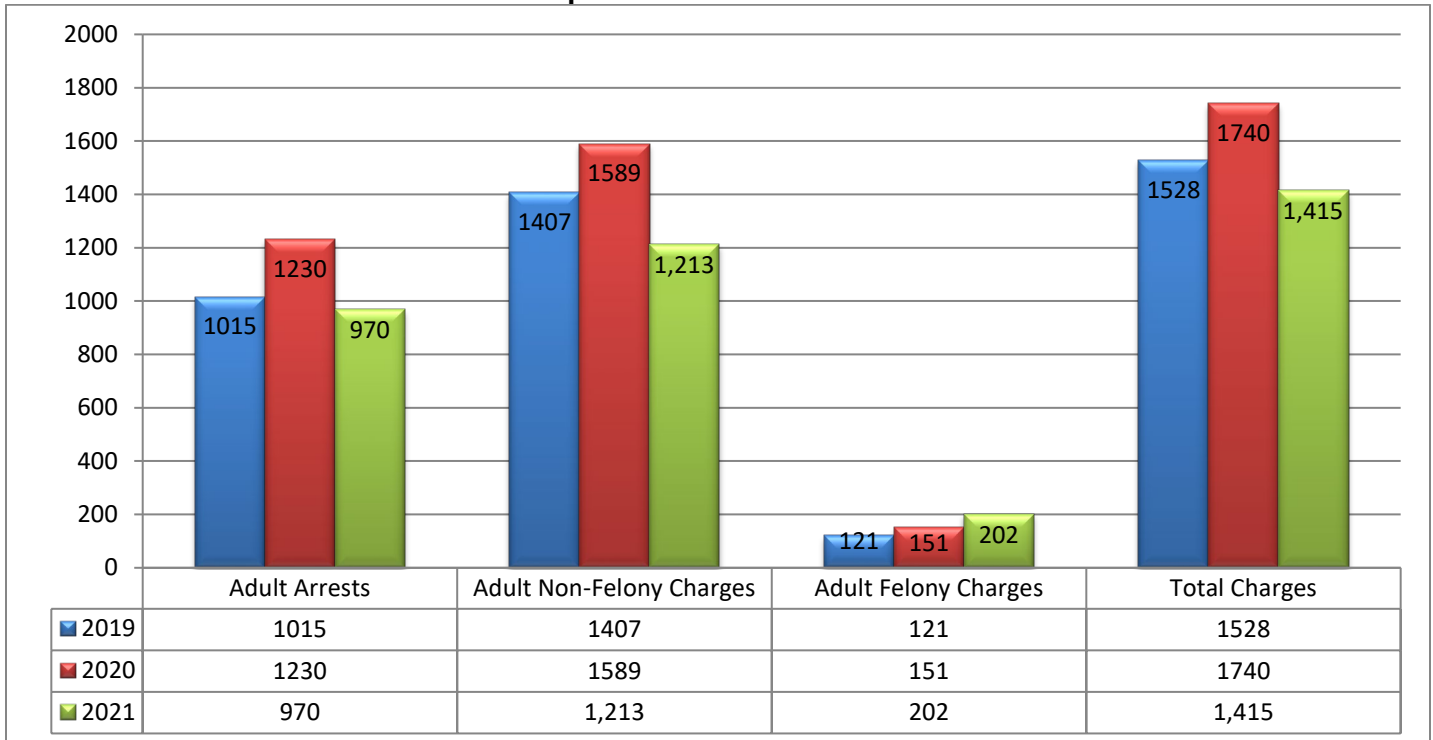

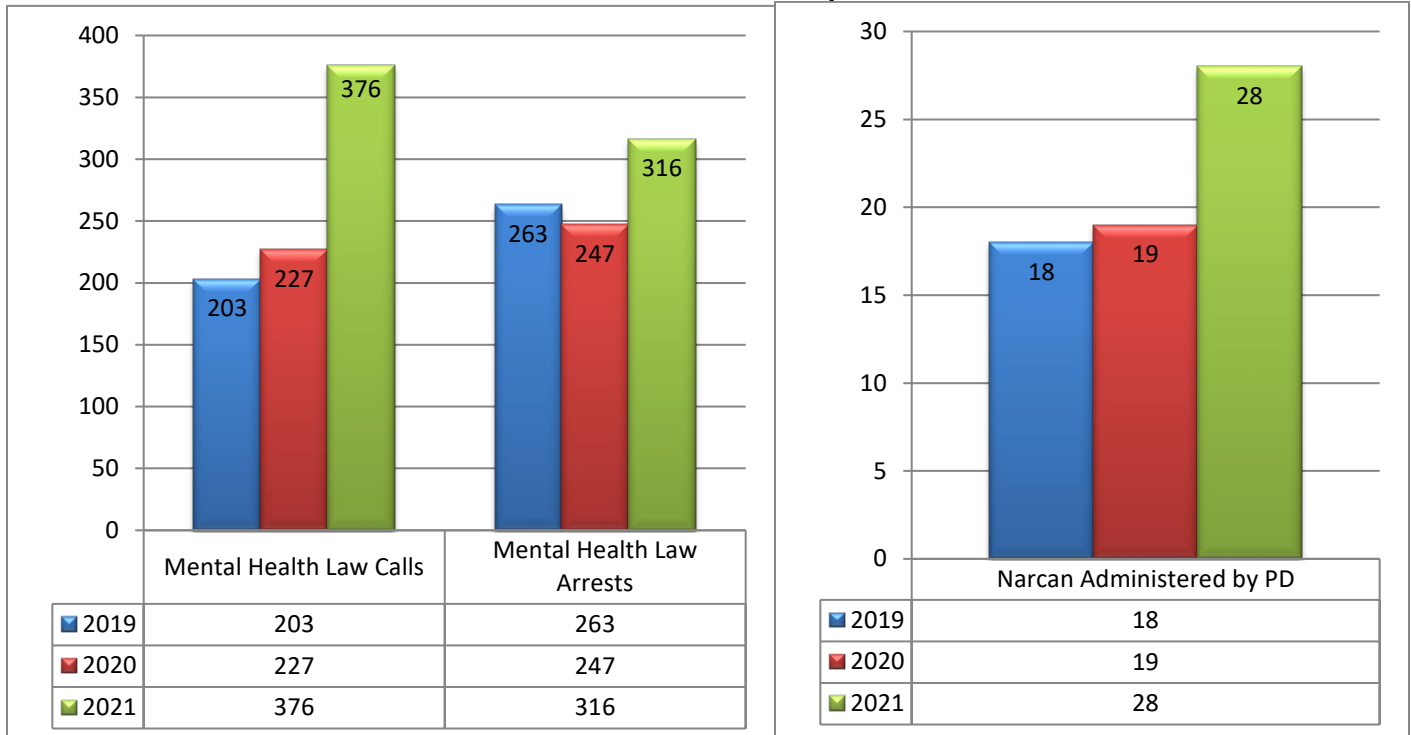
## CALLS FOR SERVICE & SOURCE OF CALLS | Patrol Division



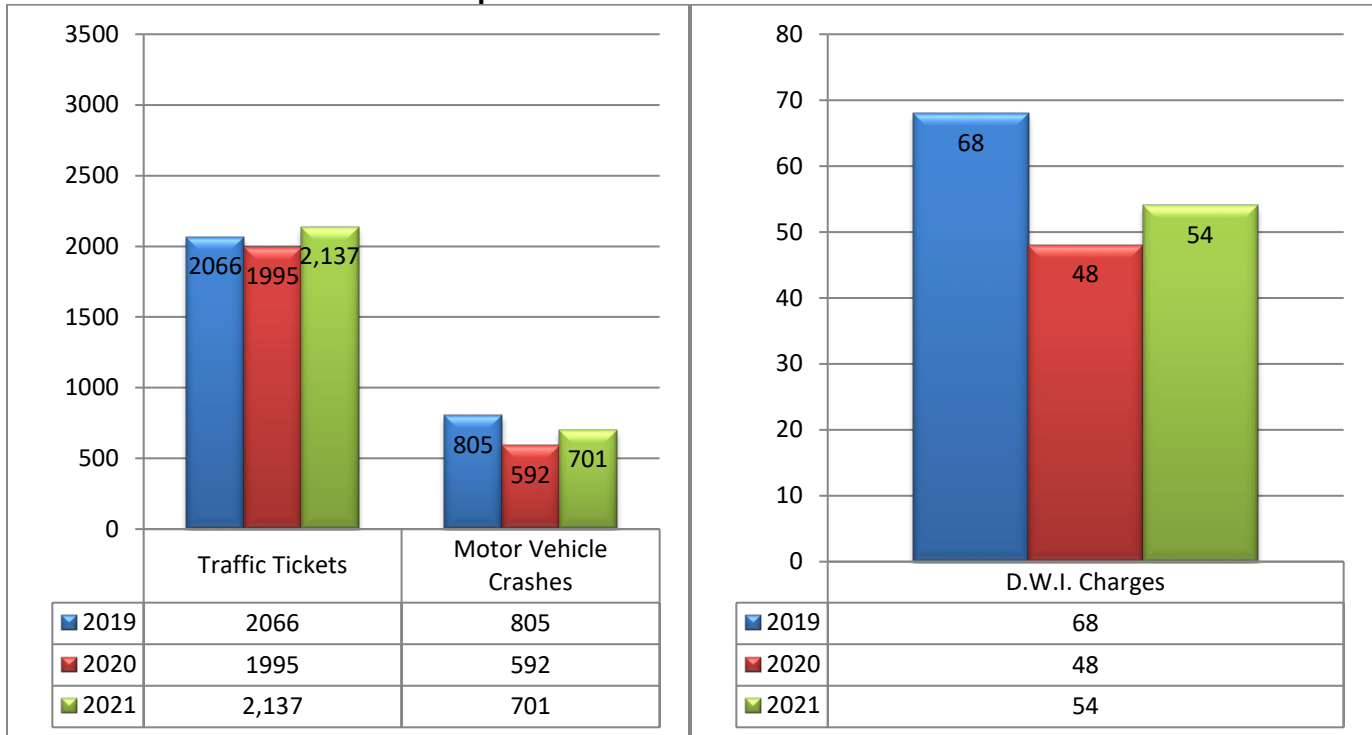

## NOTABLE PATROL DIVISION ACTIVITY

### **MAY, 2021** | Patrol officer observes man with gun on Main St

On 5/19/2021, a JCPD Officer on patrol observed a male walking west in the 300 block of Main Street carrying in-hand what appeared to be a handgun. Officers stopped the male and identified him as Tremain L. Hill, age 30 of Baltimore, MD. Hill was found to be in possession of an unregistered loaded 9mm handgun. Hill had been walking down Main Street after visiting bars in downtown Binghamton and appeared intoxicated when an officer spotted him carrying the handgun. Hill was walking to an area hotel where he was staying while working in the area from out of town.

### **AUGUST, 2021** | Man captured during burglary in progress

On 8/27/2021 at about 7:15 AM, the Johnson City patrol officers quickly responded to a report of a burglary in progress at an occupied residence on CFJ Blvd. Officers arrived and surrounded the house and ultimately made entry into the residence and located a male hiding inside and took him into custody without incident. The male appeared to be under the influence of a narcotic and was also found to be in possession of a quantity of methamphetamine. The male was identified as Ian T. Mason, Age 30 of Johnson City, NY. Mason was charged with Burglary in the second degree, a Class C Felony and Criminal Possession of a controlled substance 7th, a misdemeanor.

### **DECEMBER, 2021** | Male armed with knife threatens officers

On 12/21/2021, patrol officers responded to a residence on Endicott Av for a report of a male trespassing at the residence and was possibly having a mental health issue. The male was identified as Travis J. Cornell. Upon officer's arrival, the male barricaded himself inside a 2nd floor bathroom and armed himself with a knife, threatening officers. Officers tried to get Cornell to unarm himself and exit the bathroom. Cornell escalated the situation by refusing officers commands and then jumped from a 2nd story window. Once on the ground, Cornell was still armed with a knife and threatened police officers. Cornell then fled on foot and officers chased Cornell for several blocks. Cornell then tried to hide behind a vehicle on Burbank Av. Cornell refused to show his hands and refused to comply with officer's commands. At this time, pepper balls were deployed, which incapacitated Cornell and he was able to be safely taken into custody with further incident.

Cornell had self-inflicted injuries that were sustained prior to his contact with police and he also suffered a leg injury after jumping from the 2nd floor window.



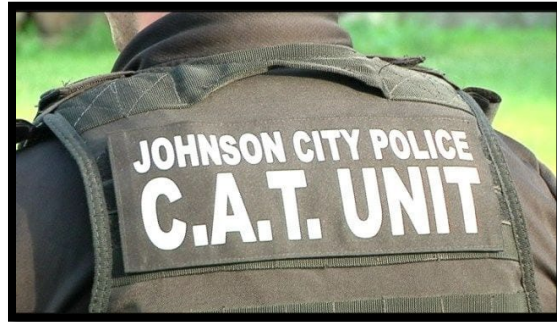
Cornell was transported to Wilson Memorial Regional Medical Center where he was treated for his injuries.

At the time of this incident, Cornell was being supervised by NYS Department of Corrections and Community Supervision. A Parole warrant was also lodged against Cornell.

Charges:

- Menacing a Police Officer 1st Degree, D Felony PL 120.18
- Criminal Possession of a Weapon 3rd, D Felony PL 265.02 subdivision 1

## COMMUNITY ACTION TEAM (C.A.T. UNIT)



The Johnson City Police Department instituted a new patrol initiative in 2018 called the Community Action Team, or CAT unit. The Unit is comprised of 2 Officers who are not part of the regular patrol function so its officers are not tied to a particular zone and do not respond to routine calls. This leaves them free to focus on community policing and enforcement issues in our most troubled neighborhoods. The main focus of the CAT unit is to utilize community policing practices and active enforcement of laws and statutes to positively impact the quality of life and safety factors in neighborhoods of need.

The CAT unit's goal is to work in partnership with neighborhood residents, Village Hall, and Code Enforcement to address on-going quality of life issues in the Village through community policing practices and proactive enforcement of state and local laws.

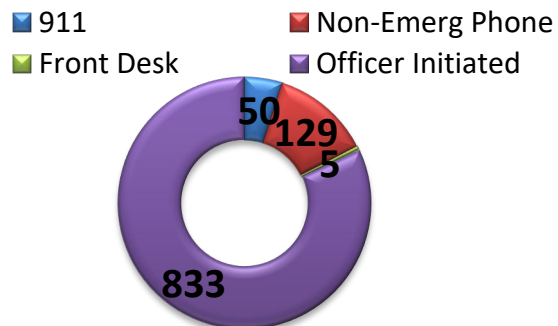
### *Partnered with our Community*

The C.A.T. Unit's effectiveness requires information about neighborhood problems from the residents in order to identify on-going problems and formulate solutions as quickly as possible.

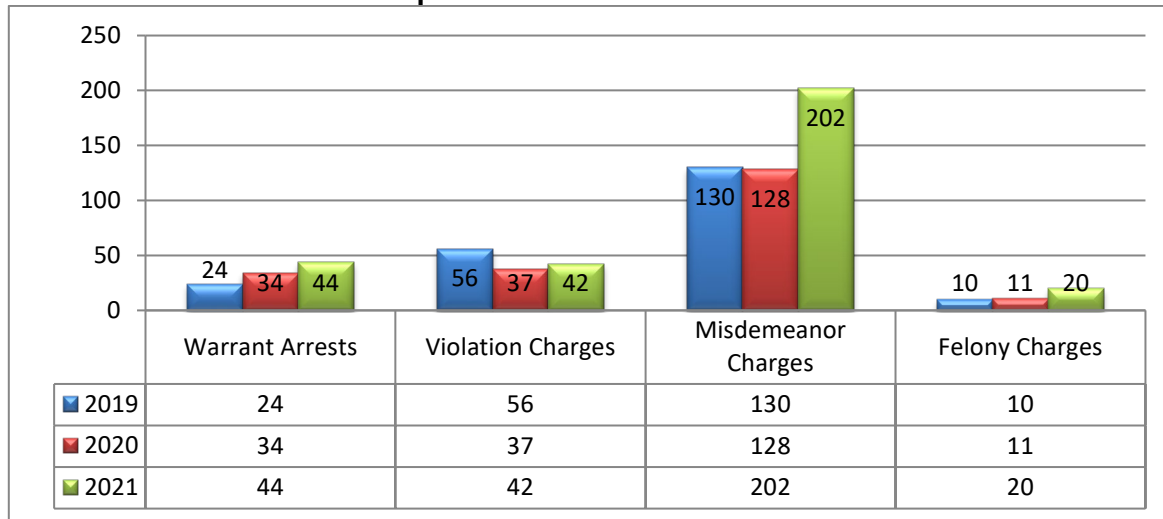

### Notable C.A.T. Unit Activity:

#### JANUARY, 2021 | Gun & Drugs discovered during traffic stop

On January 19, 2021, at about 9:25pm CAT Unit officers were on patrol and observed a vehicle driving erratically on route 201 and stopped the vehicle for a traffic violation.

The operator, MARK A. MONGILLO, age 31, of Unadilla, NY had a suspended driver's license. While speaking with Mongillo officers observed several drug paraphernalia items throughout the vehicle and a black handgun in the door pocket. Mongillo was placed in custody.

The following items were located in the vehicle and on his person:

- A loaded Glock 9mm semi-automatic handgun with the serial number defaced.
- (3) plastic bags containing a total of 1.4 pounds of Methamphetamine.
- Drug Paraphernalia including -Drug packaging materials, a glass pipe, and a digital scale.
- \$4468 in cash.



Mongillo was charged with the following:

1. Criminal Possession of a Weapon in the 2nd Degree, a class C Felony
2. Criminal Possession of a Weapon in the 3rd Degree, a class D Felony
3. Criminal Possession of a Controlled Substance in the 2nd Degree, a class A-II Felony
4. Criminal Possession of a Controlled Substance in the 3rd Degree, a class B Felony
5. Criminal Possession of a Controlled Substance in the 4th Degree, a class C Felony

6. Criminally Using Drug Paraphernalia in the 2nd Degree, a Misdemeanor
  7. Aggravated Unlicensed Operation of a motor Vehicle in the 3rd Degree, a Misdemeanor
  8. Driving on the shoulder of the roadway, a traffic infraction.

**MARCH, 2021 | Significant drug arrest following traffic stop**

On March 9, 2021 at about 8:45pm, officers of the JCPD C.A.T. Unit observed a vehicle committing several traffic infractions in the Reynolds Rd area and stopped the vehicle. Blatchford was the operator of the vehicle, Murray and Robinson were passengers. Robinson was observed with an open container of alcohol. After further investigation a quantity of Fentanyl was located on Blatchford's person. Blatchford's driver's license was suspended.

Several pills identified as Oxycodone Hydrochloride and Alprazolam were located on Murray's person. Two baggies containing white powder were located on Robinson. One baggie contained 8.8 grams of Fentanyl, and the other contained confectioner's sugar. Robinson also had a digital scale with a white powder residue on it.

**MARCH, 2021 | Felony drug arrest after traffic stop**

On March 10, 2021 at about 7:40pm, officers of the JCPD C.A.T. Unit observed a vehicle committing several traffic infractions in the Reynolds Rd area and stopped the vehicle. Mattucci was the operator of the vehicle. After investigation, 4.3 grams of methamphetamine was located in the vehicle.

**OCTOBER, 2021 | Convicted felon armed with stolen handgun resists arrest**

On 10/22/2021 at approximately 8:00 PM, officers with the C.A.T. Unit stopped a vehicle on Main Street near Avenue D because the vehicle's registration was suspended for not having valid insurance. The officers identified the driver as Kennard D. Wellington, age 39 of Endwell, NY. Wellington refused to exit his vehicle so that the vehicle could be towed from the scene. The officers attempted to negotiate, but Wellington ultimately refused to cooperate with officers. The officers were forced to physically remove Wellington from his vehicle while he continued to be uncooperative and resisted arrest. During the struggle, officers discovered that Wellington had a handgun concealed in his waistband. The



struggle continued and officers were able to safely take him into custody and secure the handgun. Once in custody, the officers were further able to determine that Wellington was a convicted felon and that the concealed .40 caliber handgun he illegally possessed was fully loaded with a high capacity magazine and had been reported stolen out of South Carolina.

- Criminal possession of a Weapon 2nd Degree – PL 265.03 sub 3 – C Felony
- Criminal possession of a Weapon 3rd Degree – 2 counts – PL 265.02 sub 1 & 8 – D Felonies – (Safe Act Violation for possessing a high capacity magazine)
- Obstructing Governmental Administration 2nd Degree – A Misdemeanor
- Criminal Possession of Stolen Property 4th – Stolen Firearm – PL 165.45 sub 4 – E Felony



## RE-ACCREDITATION

Chief Brent Dodge is proud to announce that in 2021, the Johnson City Police Department received re-accreditation by the New York State Division of Criminal Justice Services. The JCPD has been an accredited agency continuously since 1996, and will now be accredited through 2026. Of about 500+ police agencies in New York State, only about 165 are accredited.

The Accreditation Program is comprised of 132 standards providing a progressive and contemporary way of helping police agencies evaluate and improve their overall performance. Receiving Accreditation acknowledges the implementation of policies that are conceptually sound and operationally effective.



**NEW YORK STATE  
POLICE REFORM  
AND REINVENTION  
COLLABORATIVE****POLICE REFORM**

On June 12th, 2020, NYS Governor Andrew Cuomo issued an executive order mandating that all NY municipal law enforcement agencies establish a group of community stakeholders to convene a series of meetings to examine the policies and practices of the police department and formulate a written plan to reform the department in order to increase trust and respect between them and their community, and to address any racial bias and disproportionate policing of communities of color.

Chief Dodge convened the process of fulfilling the Governor's order. In his order, the Governor mandated that certain specific positions are represented in the group of stakeholders. These positions include: a representative from the District Attorney's Office, a representative from the Public Defender's Office, local elected officials, police officials, and community members.

The members of our group that were elected or appointed officials included District Attorney Michael Korchak, Assistant Public Defender Jonathan Rothermel, Johnson City School Superintendent Mary Kay Roland, Mayor Gregory Deemie, Deputy Mayor Clark Giblin, and Chief of Police Brent Dodge.

The group members from the community were Terrell Shell, Matthew Cunningham, Afaidin Boldiis, Andre Hankey, Rafael Nunez, Bernardo Cruz, Amanda Lewis, and Christopher Scott.

Together, the group members held a series of meetings to discuss and review topics such as JCPD's community involvement, the importance of JCPD's focus on Johnson City's minority youth, review of personnel complaints, and ways to increase trust with between minorities and the police department. A public survey was developed by the group and was disseminated to the community. The results of the survey were reviewed and discussed by the group. All of the group's meetings, discussions, survey results, and actions plans were compiled into a collaborative report for public release.

## METRO S.W.A.T.

The Johnson City Police Department is part of a multi-jurisdictional SWAT Team, Metro SWAT which is comprised of members of the Johnson City, Binghamton and Vestal Police Departments.

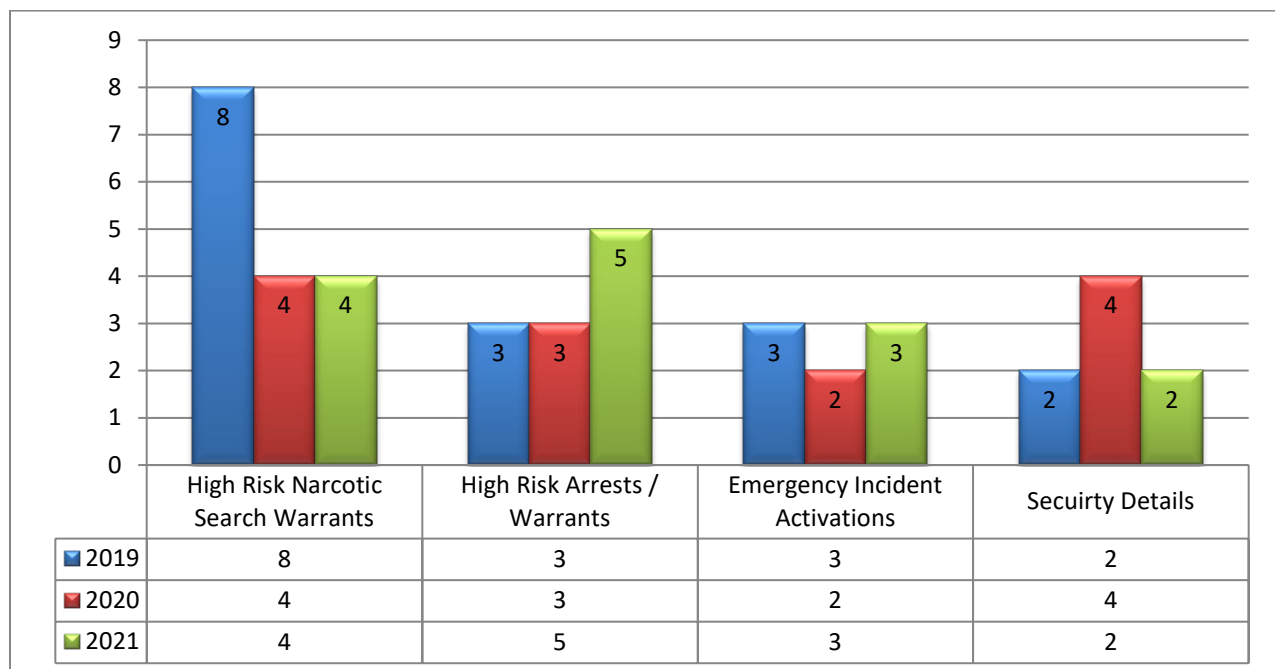
The members are highly trained and receive ongoing special training in tactics and weapons and work as a team to counter special situations. The SWAT Team has the responsibility of responding to any situation that requires specialized weapons and tactics. These situations include, but are not limited to, the following: hostage situations, barricaded suspects, violent civil unrest, and the execution of high risk search warrants. The team training involves specialized tactics to enable them to end critical situations with non-lethal force if at all possible. The team members are very dedicated and are on call 24 hours a day, seven days a week.

This multi-jurisdictional SWAT team is one of only a handful of teams in New York State that is accredited by the New York State Division of Criminal Justices Services.

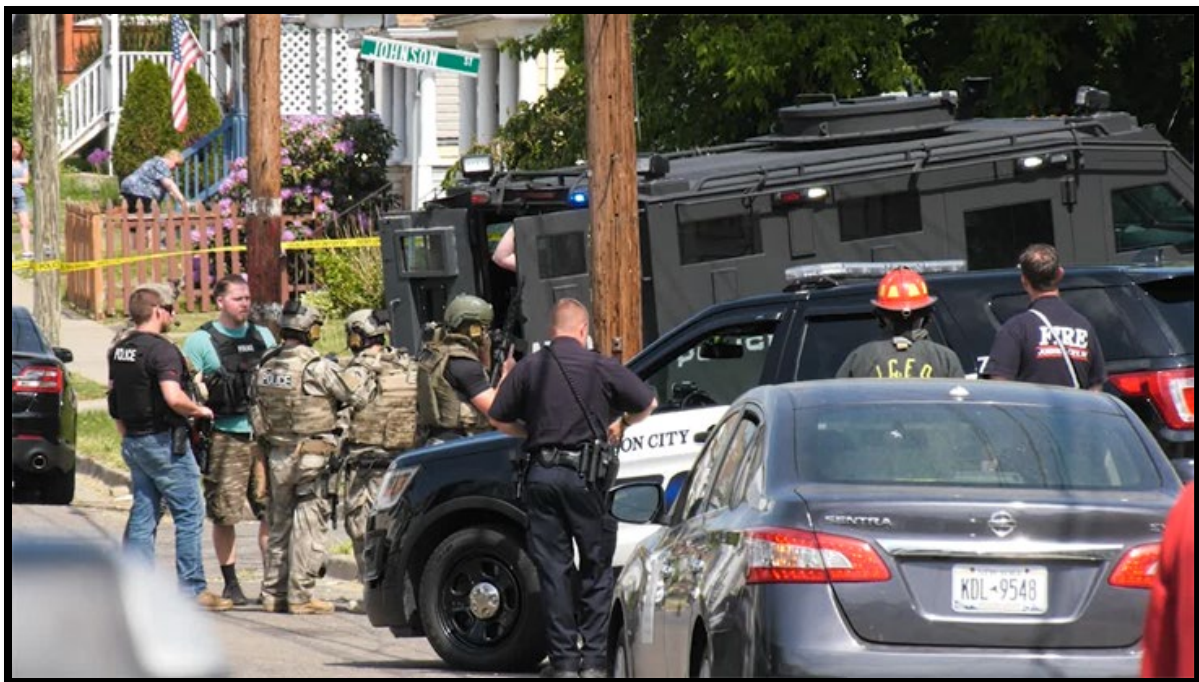


**Notable 2021 SWAT Incidents:****MAY, 2021 |** Barricaded subject with knife surrenders after lengthy negotiations

On 5/25/2021 the Johnson City Police Department responded to Endicott Av in Johnson City, NY for a report of a domestic dispute between a male and a female. Officers arrived on the scene and encountered a male who was experiencing a mental health crisis. To further complicate this situation the male began to barricade the lone egress point to the building. Based on the male's behaviors and actions, mental health professionals were summoned to help as well as the Metro SWAT team and 2 crisis negotiators.

During this event the male threatened the use of a knife and handgun on himself and officers. Officers did observe the male to be armed with a knife. Crisis negotiators talked with the male for approximately 7 hours and were finally able to convince the male to surrender peacefully. The male was transported to a local hospital for a mental health evaluation.

The male suffered from non-life-threatening self-inflicted injuries from this incident.





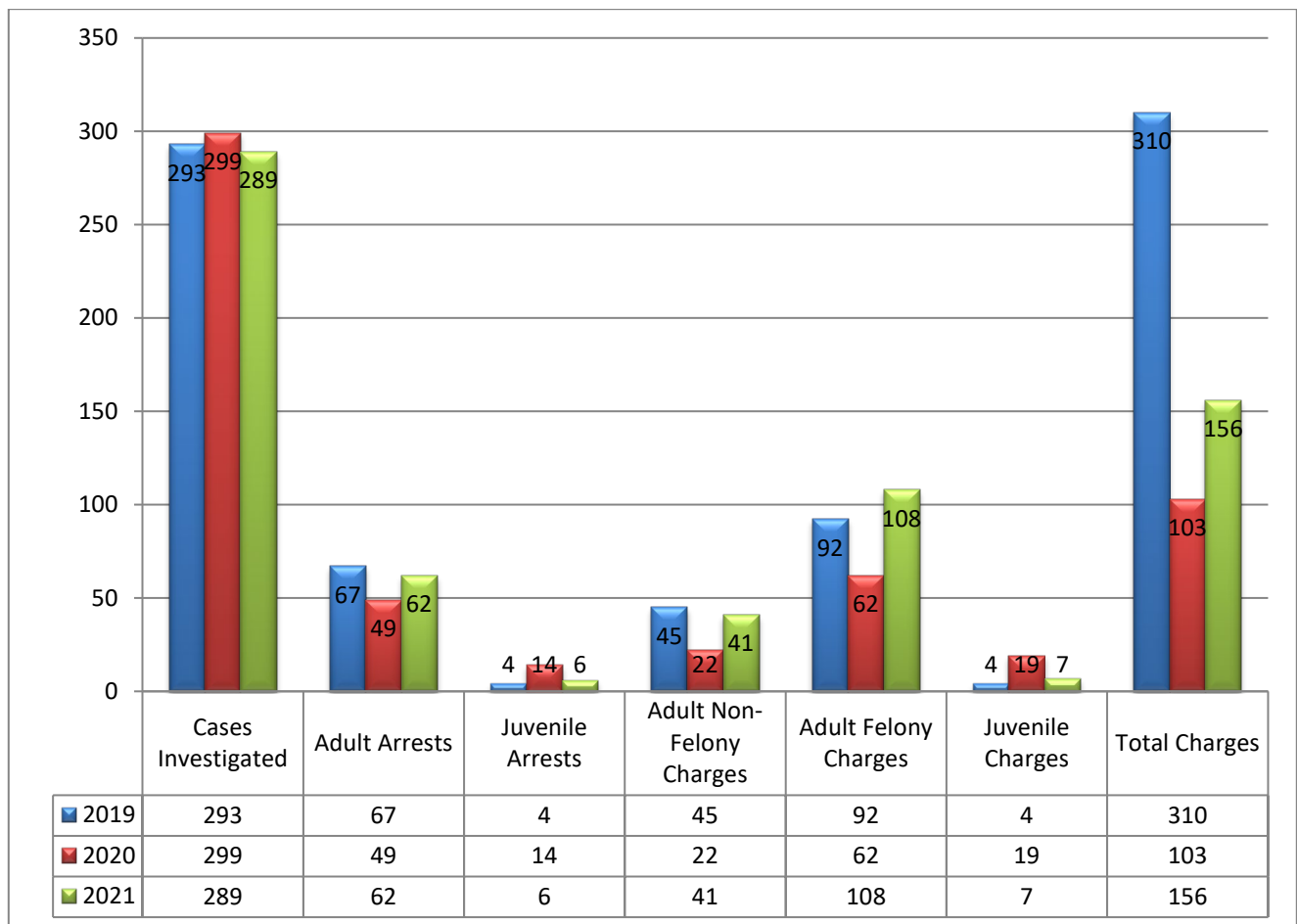
## DETECTIVE DIVISION

Criminal Investigations | Narcotics | Juvenile | Evidence

The Johnson City Police Department's Detective Bureau is comprised of a Detective Lieutenant who oversees the Criminal Investigations Division, the Narcotics Division, the Juvenile Division, and the Evidence Division.

### Criminal Investigations:

The Criminal Investigation Division consists of three Detectives, and an administrative assistant all overseen by the Detective Lieutenant. The Division is responsible for a wide range of tasks. Detective duties include the investigation of all serious felonies including homicides, felony assaults, white collar crimes, sex crimes, and felony property crimes. The division also investigates misdemeanor crimes and offenses that require more investigative time and manpower that can be fulfilled by the Patrol Division. The Detective duties also include subpoena service, background investigations, internal investigations, warrant service, and other ancillary duties.



**Notable 2021 Criminal Cases:****JANUARY, 2021 | Arson arrest**

On 1/11/2021, the Johnson City Police Department responded to a house fire located at 307 Deyo Hill Road Johnson City, NY. A 911 caller reported a fully engulfed house fire at this location. When police arrived, they located a male at the scene who fled the area. Officers quickly located the male and determined he had sustained injuries from the fire.

The residence sustained extensive damage and loss of personal property. An investigation into the cause of the fire determined that it was intentionally set and was part of a domestic dispute.

Detectives arrested the following individual as a result of this investigation:

Nicholas Richard, age 32 of Johnson City, NY with:

- Arson in the 3rd Degree, a class C Felony
  - Criminal Mischief in the 2nd Degree, a class D Felony
- 

**JUNE, 2021 | Rape investigation leads to drug arrests**

On 6/24/2021 Johnson City Police Detectives investigated an alleged rape of a 14-year-old female and executed a search warrant at a residence located on Brown Street within the village. While executing the search warrant, 2 males attempted to flee by exiting a rear second story window onto a roof top. When the males were approached by detectives the males retreated back into the residence. As detectives entered the residence, the 2 males were holding items in their hands which were identified as illegal narcotics. Detectives recovered the following contraband and over \$12,000 in US currency:

- 17 Suboxone strips
- Over 16 grams of Methamphetamines
- Over 200 grams of cocaine
- Over 10 grams of Fentanyl
- Large amounts of drug packing material and several other items of evidence related to the sexual offense.

Johnson City Police charged the following individuals:

### **JULY, 2021 | Bank Robbery**

On Friday, July 2, 2021 the Johnson City Police Department responded to a report of an armed robbery at the NBT Bank located at 331 Main St Johnson City NY. During the robbery, the suspect made off with an undisclosed amount of US Currency and fled the scene on a mountain bicycle.

Following an investigation, Johnson City Police Detectives identified the robber as Nyquan C. Williams of Endicott, NY. Williams was charged with:

- Robbery 1st Degree – B Felony
  - Criminal of a Weapon 4th – D Felony
  - Criminal Use of a Firearm 1st – B Felony
- 

### **SEPTEMBER, 2021 | Stabbing / Robbery**

On September 3, 2021, Johnson City Police responded to a check the welfare complaint at 11 Main St. in the village. Officers located a male who had sustained injuries while being the victim of a robbery. Officers determined that the suspect and the victim had engaged in an earlier dispute which then resulted in the suspect forcibly stealing property from the victim. During the struggle, the victim sustained minor stab wounds from a bladed object. Officers were able to recover evidence from the scene and identified a suspect. Later that evening Johnson City Police Detectives assisted by the Johnson City Police C.A.T. team took the suspect into custody without incident. The defendant in this case was identified as 51 year old Robert Green of Johnson City.

Green was charged with:

- Robbery in the first degree, a class B Felony.

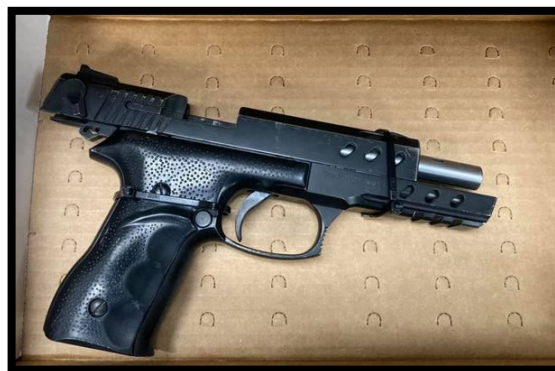
Greene was processed and taken to the Broome County Correctional Facility for arraignment at C. Greene was subsequently remanded to the Broome County Jail.

---

**NOVEMBER, 2021** | Shots fired during domestic dispute, firearms seized

On Sunday November 7, 2021 the Johnson City Police were called to an address on Endicott Avenue, for a domestic incident with a report that a gun had been fired by a male at the residence. Officers arrived and located 26-year-old Ryan Button, who resides at the address. Button was detained by officers and detectives were contacted. Based on information obtained by patrol officers, detectives obtained a search warrant for the location.

Upon executing the search warrant, officers located a high-capacity Zigna Sport Zoraki 9mm handgun, a 9mm blank gun, and a .22 rifle inside of the residence. Detectives further located evidence that a gun had been fired from inside of the residence toward the street.



Ryan Button was charged:

- Two counts of Criminal Possession of a Weapon in the 2nd degree (a class C Felony); and
- Two counts of Criminal Possession of a Weapon in the 3rd degree (a class D Felony); and
- Reckless Endangerment in the 1st degree (a class D Felony).

---

**DECEMBER, 2021** | Homicide

On Friday, December 31, 2021 at about 6:38 PM, patrol officers responded to a suspicious incident call at a residence on Floral Avenue in Johnson City. Upon arrival, officers found 55-year-old Scott Groover with critical injuries consistent with being caused by a sharp-edged weapon. EMS transported the victim to the hospital where he died a short time later.

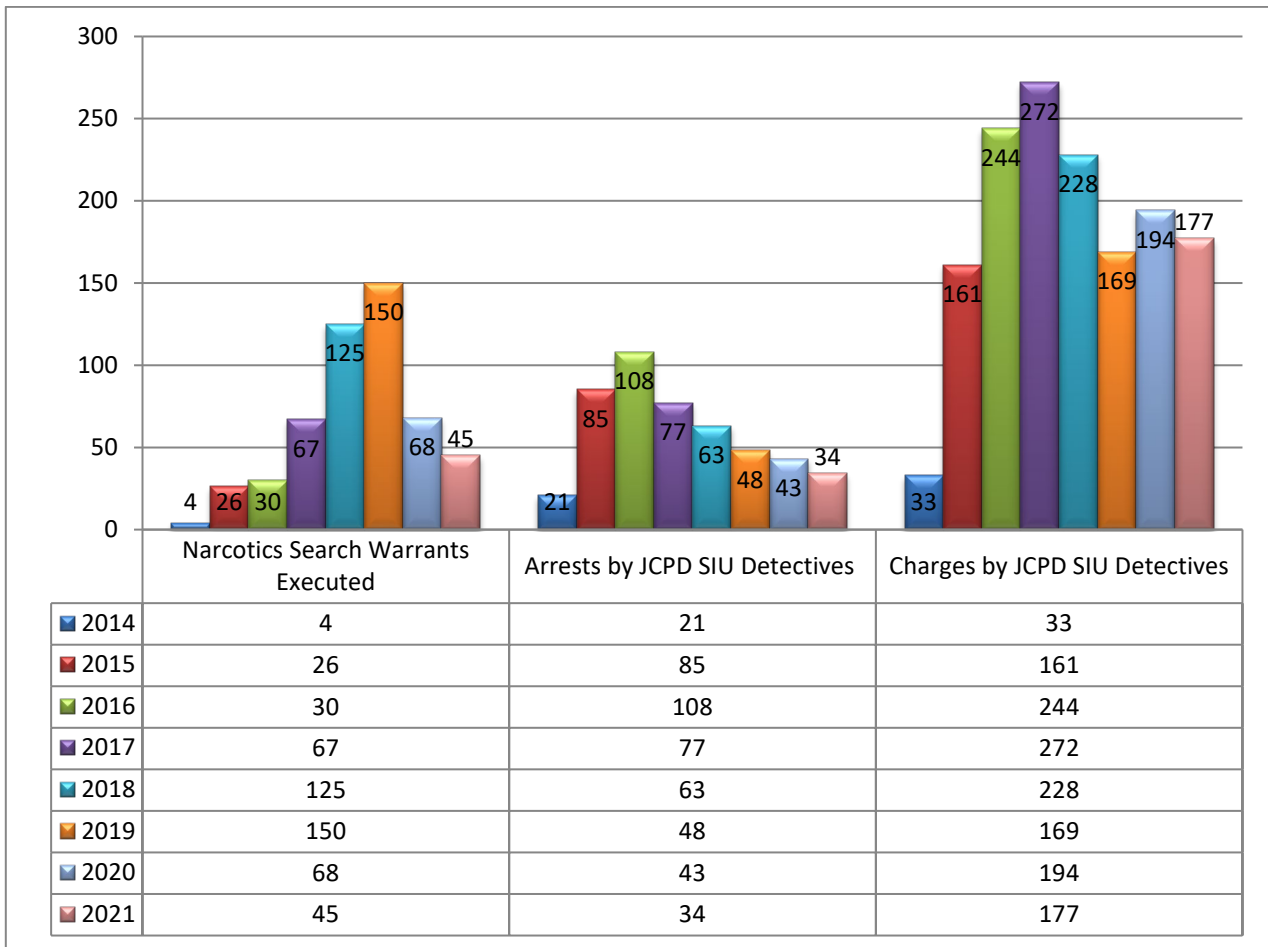
That same evening, a suspect was developed and was taken into custody by detectives at an address on Helen St. The weapon believed to have been used was also recovered.

The suspect was identified as Kyle Babola, age 33 of Johnson City NY. Babola and the victim were known to each other. Detectives charged Babola with Murder in the 2nd degree, a class A-1 felony.



## NARCOTICS DIVISION Special Investigations Unit Task Force

The Johnson City Police Department is partnered with the Broome County Special Investigations Unit Task Force (BCSIUTF). The JCPD employs a Detective Sergeant and a Detective on the Task Force who join members of the Broome County Sheriff's Office, Binghamton Police Department, and the Endicott Police Department. Together, the investigators work to combat narcotic crimes and to conduct other special investigations.



**Notable 2021 Narcotics Cases:****MAY, 2021 | Gun & drugs recovered after search warrant**

On May 18, 2021 the Broome County Special Investigations Unit along with the Metro SWAT team executed a search warrant on Grand Ave in the Village of Johnson City. As a result of the search warrant Haven Strong was taken into custody after investigators located a “sawed-off” 12 gauge shotgun, crystal methamphetamine, drug paraphernalia items consisting of packaging, digital scales and cutting agents. Haven Strong was transported to the Johnson City Police Department where he was processed and then held for arraignment on the following charges:



- Criminal Possession of a Firearm
- Criminal Possession of a Weapon in the 3rd Degree-Prior Conviction
- Criminal Possession of a Controlled Substance in the 3rd Degree-Intent to sell
- Criminally Using Drug Paraphernalia in the 2nd Degree (3 Counts)
- Endangering the Welfare of a Child

**SEPTEMBER, 2021 | Weapons & Drugs seized after Search Warrant**

On September 23, 2021, the Broome County Special Investigations Unit Task Force executed a search warrant at 242 Grand Ave Johnson City, NY following an investigation into the sale of narcotics. As a result of the search warrant officers recovered the following:

- an illegally possessed loaded 9mm Ruger handgun
- components to manufacture a “ghost gun” handgun
- two high capacity magazines
- a switchblade knife
- two metal and plastic knuckles
- approximately 7.5 grams of Crystal Methamphetamine
- approximately 7.5 grams of Fentanyl
- drug paraphernalia items consisting of digital scales, packaging materials and cutting agents

The subject of the investigation, Edward G Fuller, was charged with:

- Criminal Possession of a Firearm, a Class E Felony
- Criminal Possession of a Weapon in the 3rd degree (two counts), a Class D Felony
- Criminal Possession of a Weapon in the 4th Degree (two counts), a Class A Misdemeanor
- Criminal Possession of a Controlled Substance in the 3rd Degree (two counts), a Class B Felony

- Criminal Possession of a Controlled Substance in the 4th Degree, a Class C Felony
- Criminally Using Drug Paraphernalia in the 2nd Degree (two counts), a Class A Misdemeanor

Additionally, Jessica L Hoover, was located at the residence and found to be in possession of a quantity of Fentanyl. Jessica L Hoover was charged with:

- one count of Criminal Possession of a Controlled Substance in the 7th Degree, a Class A Misdemeanor.



## JUVENILE CASES

Crimes committed by a suspect under 19 years old are considered juvenile cases which are handled in a different manner and with other processes than that of an adult.

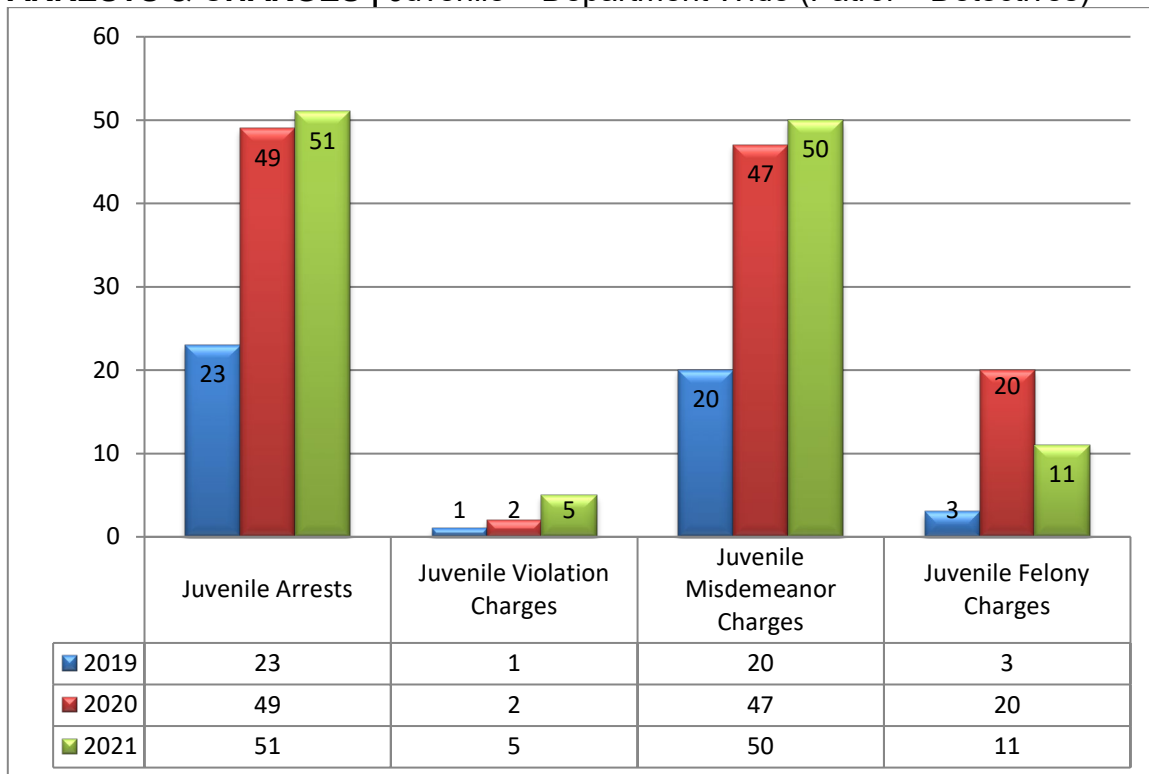
A child over 7, but under 18 years of age (effective 10/1/19), who commits an act that would be a crime if it had been committed by an adult is a Juvenile Delinquent. Cases involving Juvenile Delinquents are handled in Family Court. Juvenile Delinquents do not go to adult jails. Instead, the court decides if they need supervision, treatment or placement through the local department of social services or the New York State Office of Children and Family Services.

A child who is 13, 14, or 15-years-old and is charged with committing a serious or violent felony offense listed in Penal Law 10.00 (18) is a Juvenile Offender. These cases are heard in the Youth Part of the Supreme or County Court. Juvenile Offenders who are convicted after a plea or a trial are subject to less severe sentences than adults.

A 16 or 17-year-old who commits a felony is an Adolescent Offender (effective 10/1/19). This means that the case is originally heard in the Youth Part of the Supreme or County Court. However, the case may be transferred to the Family Court, where the youth will be considered a juvenile delinquent and will be eligible to receive all the services and programs available to all juvenile delinquents.

All Johnson City Police Officers receive training on juvenile procedures so that juvenile cases are handled and processed within the guidelines of the laws.

### ARRESTS & CHARGES | Juvenile – Department Wide (Patrol + Detectives)



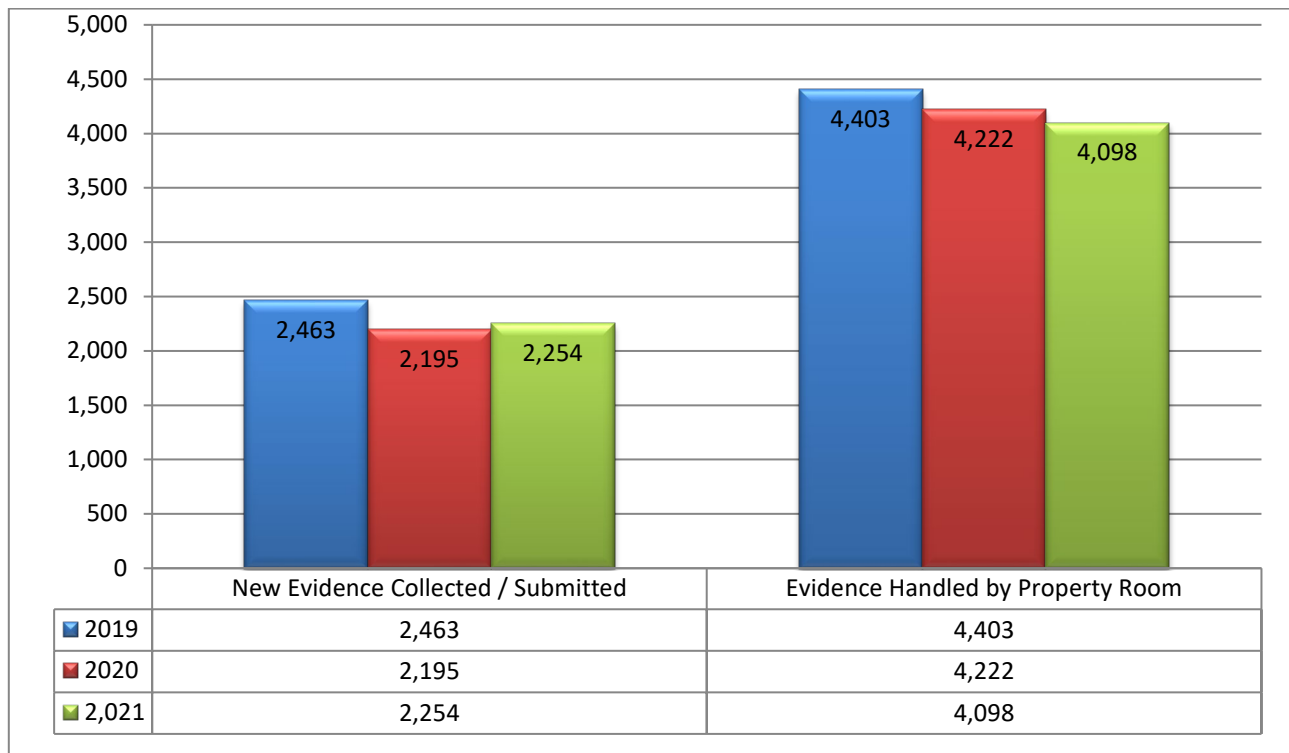


## EVIDENCE & PROPERTY DIVISION

The Evidence Division primarily consists of a part-time Property Clerk/Evidence Technician who carries out the day-to-day functions but is also backed up by two other members of the Department who are cross trained and able to fulfill duties in the Evidence/Property room in the absence of the Property Clerk/Evidence Technician.

The Evidence Technician has been involved in numerous investigations and processed forensic evidence which resulted in several arrests based on fingerprint and/or DNA identification.

The Evidence Technician is responsible for handling and maintaining the submission of thousands of new evidence items collected by JCPD Officers. In addition to the handling of newly submitted evidence, the Evidence Technician has also reviewed thousands of items of evidence from previous years to determine if the items need to be retained or disposed of properly. As a result of the extensive research, in 2021, the Evidence Technician was able to return 191 items to the lawful owners, destroyed 998 items of illegal contraband, donated 20 unclaimed items to social programs, and auctioned 33 items of unclaimed property. This process is crucial in the ongoing maintenance of the Property Room to be able to purge evidence and property from older cases in order to free up storage space for new incoming evidence and property.





## TRAFFIC DIVISION & PARKING ENFORCEMENT

The Traffic Division is responsible for:

- Radar Units - ordering, maintenance, and calibration
- DataMaster (breathalyzer) – weekly tests, maintenance, & calibration
- Fleet Vehicles – purchasing, maintenance, upfitting, auctions
- Street Striping – ordering annual road markings / evaluate any needed changes
- Traffic Signs - posting and monitoring
- Traffic Signals – ordering, maintenance
- Special Events
  - Annual Holiday Parade
  - Memorial Day Parade
  - Local 5K events
- Traffic Grants – application, grant reporting
  - Stop-DWI grant
  - Police Traffic Safety grant

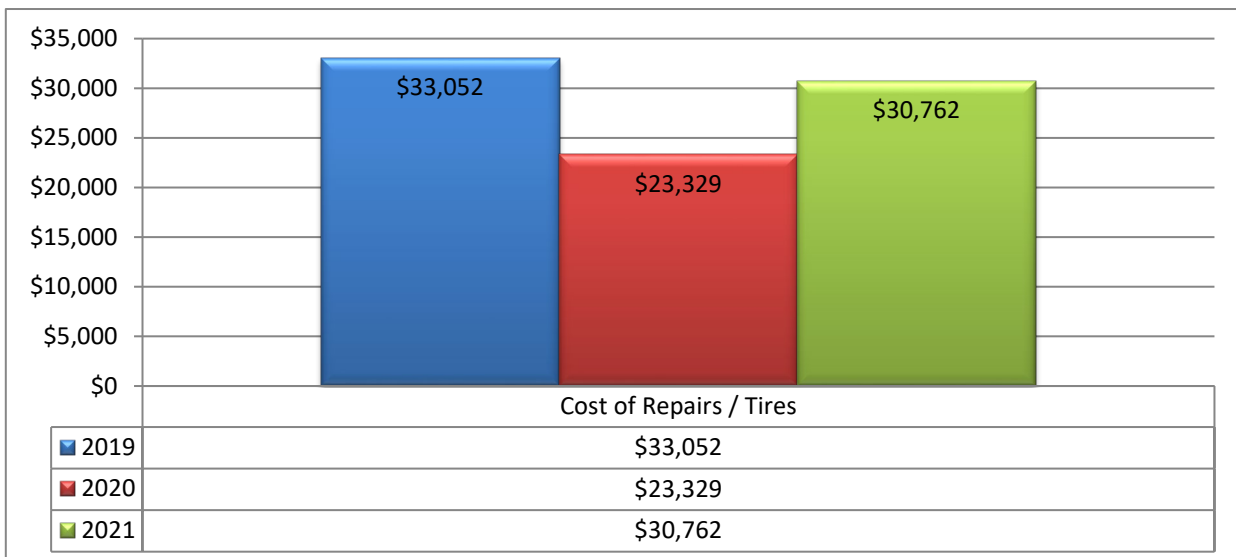
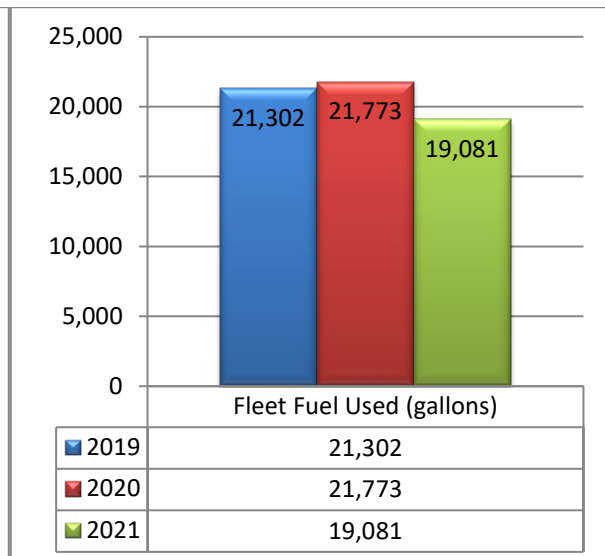
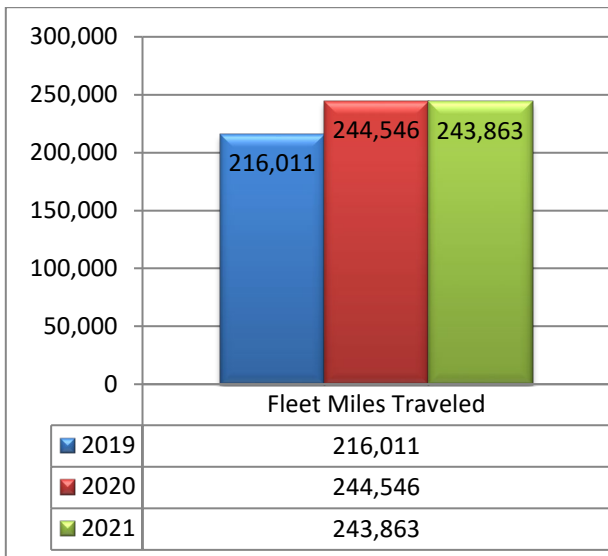

## PARKING ENFORCEMENT

The Parking Enforcement Division is primarily responsible to ensure that motorists comply with local parking laws and ordinances and issue tickets for violations on all Johnson City streets and municipal parking lots. In addition to monitoring violations, parking enforcement is also responsible for maintenance of the parking meters and meter money collection.

Parking Enforcement Officers monitor parking and address violations by issuing warnings or parking tickets. Effective parking enforcement provides for the safe and efficient flow of traffic and turnover of parking spaces in the downtown business district. Enforcement also helps to enhance the safety of pedestrians by keeping crosswalks clear and street corners clear of parked cars which inhibit the line of sight between pedestrians and motorists.

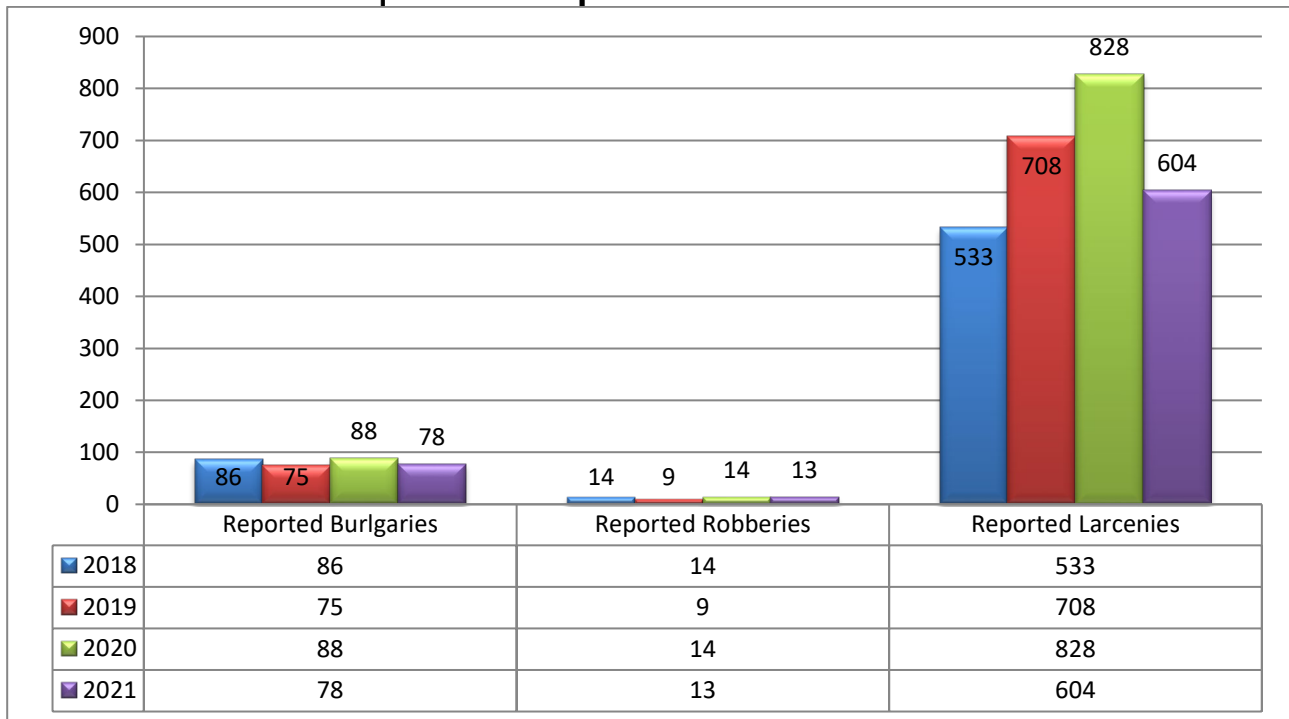

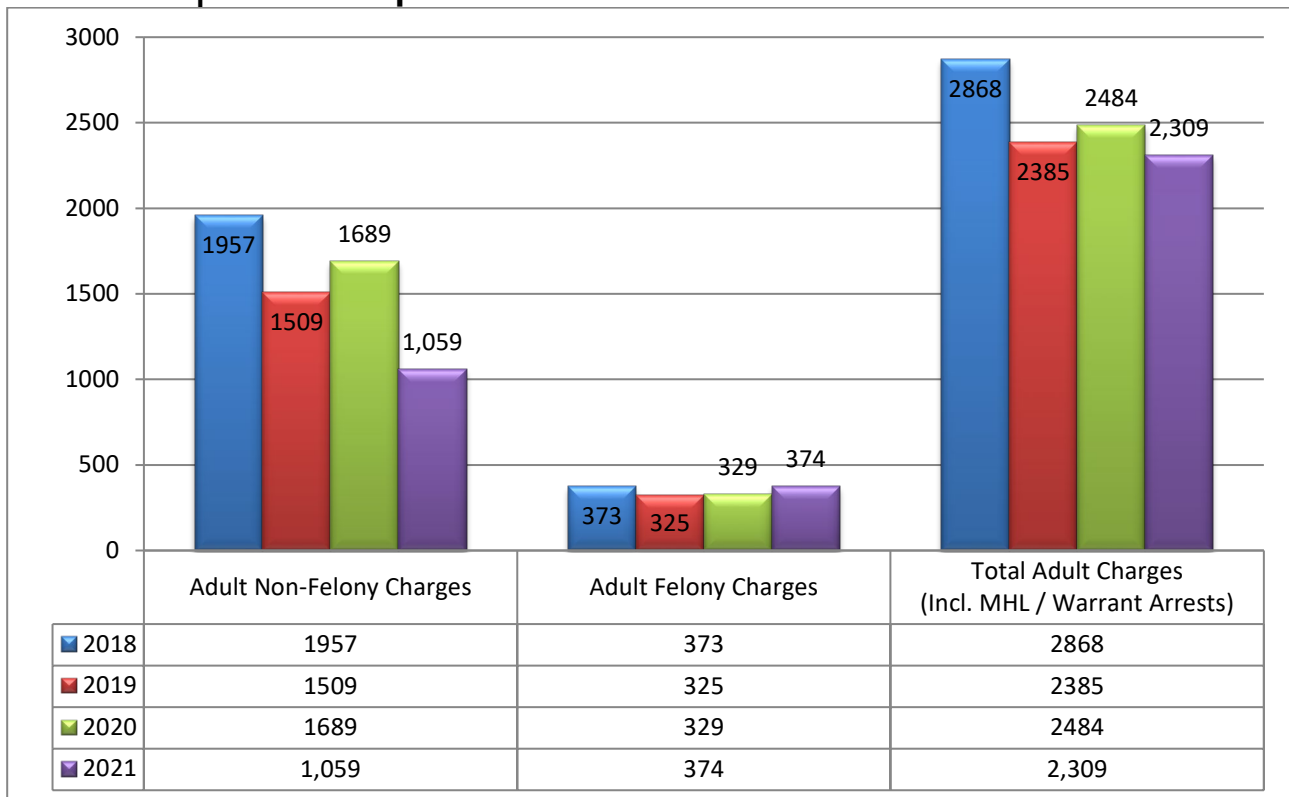
The civilian support staff is responsible for:

- Staffing of the front desk

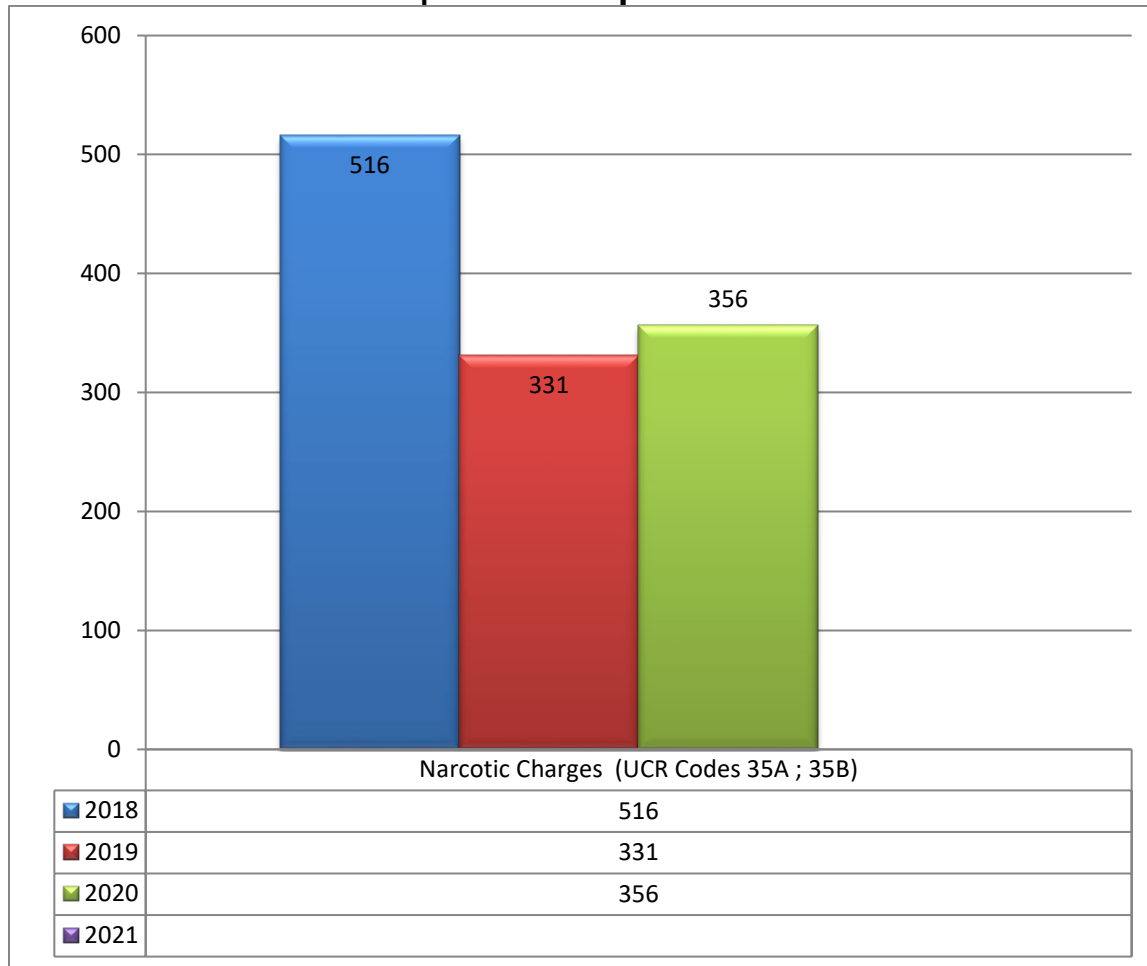
## PROPERTY CRIMES | Total – Department Wide
