

## 2<sup>nd</sup> Annual Artisan Art Walk Judged Art Show Ector County Coliseum Grounds – Building G (4201 Andrews Highway, Odessa, TX 79762) April 5, 2019

**Awards:** Cash prizes will be awarded as follows: Best of Show (\$300); First Place (\$150) in <u>each category</u>, Second Place (\$75) in <u>each category</u>, Third Place (\$50) in <u>each category</u>. Ribbons will be awarded for Best of Show, and 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place in each category.

Eligibility: This is a competition open to all artists/students and all are encouraged to submit their best work(s).

Format & Size: All artwork must be original and not previously shown in this exhibition. 2D exhibition pieces should be framed. 3D work cannot exceed 6 feet tall in height or 100 pounds in weight.

**Mediums:** Artists may use any of the following mediums:

Sculpture Drawing, colored pencil, pastel Painting – watercolor, mixed media, oil, acrylic Glass, wood, fiber, paper Pottery Graphic Arts Photography Jewelry

Categories: 2-Dimensional and 3-Dimensional

Artists must indicate on the entry forms the medium and category for each item entered.

**Sales:** All accepted entries should be noted if available for purchase during the event and have a sales price determined by the submitting artist. Artisan Art Walk will not retain a commission or be liable for any sales.

**Liability:** Although reasonable care will be taken in handling and displaying artwork, Artisan Art Walk and its directors and volunteers will not be responsible for damage or loss. Due to lack of storage space, artists must pick up their work at 1:00 pm on April 7, 2019. Artists may arrange for artwork to be picked up by another party but must notify an Artisan Art Walk director. Work left after 1:00 pm on Sunday, April 7, 2019 will be removed to an offsite location; work left for longer than 7 days becomes the property of the Artisan Art Walk.

## **Entry Procedure:**

Complete the attached entry form. A maximum of 3 pieces may be submitted. Entry fee: \$35.00 (U.S. Funds) Non-Refundable entry per art piece. Artwork must be submitted between the hours of: 2:00 pm and 7:00 pm on Thursday, April 4, 2019 8:00 am and 10:00 am on Friday, April 5, 2019. All entries are to be dropped off with an application form to: Ector County Coliseum Grounds – Building G, 4201 Andrews Highway, Odessa, TX 79762

**Important:** No changes to size or sales price of judged-in artwork will be permitted. Be sure frame size and sales price are correct on your Entry Form. Keep a copy of your Entry Form for your reference.

Artisan Art Walk reserves the right to refuse any artwork deemed unsuitable.

Artwork will be displayed on easels (hanging, standing/table top, or simply lying on tables) dependent on space and size of work entered. 3D artists are encouraged to provide pedestals to display their work.
