Summary of Events

Burglary Vehicle:

5 Minor Accidents (Non-Life Threatening Injuries)

Deputies conducted welfare checks to ensure the safety of vulnerable residents, park checks to maintain safe recreational spaces, and contract checks to reinforce security in designated areas. Public infrastructure and MUD building checks were performed to protect facilities from vandalism and unauthorized access. Neighborhood checks facilitated routine patrols and engagement with community members, while vacation checks provided an additional layer of security for unoccupied residences.

Traffic safety was also emphasized through traffic stops and enforcement efforts, aimed at reducing hazardous driving behaviors and promoting roadway safety. These collective measures enhanced community safety, deterred crime, and reinforced public confidence in law enforcement.
