4200 Spring Stuebner Rd. (Vale apts.) - Complainant contacted the Police due to observing her ex-husband at her apartment grounds and thought she had an active Protective Order against him. Deputy researched the ex-husband with no active Order in place.

3800 FM 2920 (MeadowHill MUD) - A traffic stop was conducted, and the driver was found to have an expired driver's license and no proof of financial responsibility, the vehicle was towed and impounded. During the inventory of the suspect's vehicle a small amount of marijuana was located, contraband was seized, and tagged with an order for destruction.

21700 Grassy Hill Ln. (MeadowHill RUN) - Complainant was involved in a verbal disturbance with a known male suspect, Police arrived, and a criminal trespass was issued on the male and removed from the residence.

3800 FM 2920 (7-11) - Complainant/Mgr. reported that a known male comes into the store and uses vulgar language in the presence of customers, at the Mgr.'s request contact was made with the suspect, and a criminal trespass warning was issued.

3800 FM 2920 (MeadowHill MUD)- A traffic stop was conducted on FM 2920, during a Tcic/Ncic check of the driver he was found to have an active warrant out of Louisiana and was arrested.
