Vacation Checks provided an added layer of security for unoccupied residences, reducing the risk of property crimes. Traffic safety initiatives and enforcement efforts were also key focus areas. Deputies conducted traffic stops to ensure compliance with regulations, mitigate hazardous driving behaviors, and enhance the safety of both pedestrians and vehicles throughout the neighborhood. These collective efforts aimed to uphold public safety, deter crime, and reinforce community confidence in law enforcement.
