November 11, 2025
Monthly Meeting Minutes

The monthly meeting of the Atlanta Township Board was held November 11, 2025, at the Atlanta Township Building. The meeting was called to order at 7:30 P.M. by Supervisor Julie Osborn. Those present were Supervisor Julie Osborn; Clerk Shellie Reed; Trustees Georgia Green, Chuck Van Hoorn, Bruce Compton and Joshua Koonce; and Highway Commissioner Wes Green. Cemetery Manager Shelly Brooks was absent. The guests present were Harold Green and Martha Green.

The Pledge of Allegiance was led by Supervisor Julie Osborn.

The following items were discussed:

PUBLIC COMMENTS: There was no public comment.

MINUTES OF PREVIOUS MEETING: The minutes of the October 14, 2025 meeting were reviewed by each member. Trustee Green made a motion to approve the minutes as presented. Trustee Compton seconded the motion. A vote was taken, and the motion passed to approve the minutes of the October 14, 2025 meeting as presented.

SUPERVISOR'S REPORT: Supervisor Osborn reported the following: We have not received the completed Comptroller's or AFR from Striegel Knobloch, so she will be reaching out for status update. Supervisor Osborn also explained the purpose of the Multi-Township Board and how it is run for assessing purposes of the real estate taxes for Trustees Compton and Koonce.

CLERK'S REPORT: Nothing to report.

HIGHWAY COMMISSIONER REPORT: Highway Commissioner Green reported the following: new windows have been put in with less work than anticipated, only had to replace a 2x6 on east wall under the window in the meeting room which had rotted; he mowed ditches getting ready for winter.

He received a call last week from county dispatch that someone hit a bridge guard rail on 2400th and 2275th which was moved into road. The guard rail has been moved back and county is aware of it to see what the outcome is on what we have to do to fix it. The Logan County Sheriff did a report but there is no idea who did it. There were two posts damaged and some concrete damage - a barricade is up so no one hits it.

CEMETERY REPORT: Supervisor Osborn read Cemetery Manager Brook's report: a cremation burial for Roslie and Homer Hamblin is the 14th; a restitution check was received from Logan County Circuit Clerk's office for the cemetery damage; repairs have been done for stones selected for the annual repair.

OLD BUSINESS: 2025-2026 Tax Levy - no comments were received on the tax levy – Trustee Compton made a motion to file the levy for Road and Bridge Levy as posted; Trustee Green seconded the motion. A roll call vote was taken: Ayes: 5; Nays: 0. The motion carried to file the 2025-2026 Road and Bridge Levy as posted.

Trustee Compton made a motion to file the levy for the Atlanta Township as posted. Trustee Green seconded the motion. A roll call vote was taken: Ayes: 5; Nays: 0. The motion carried to file the 2025-2026 Atlanta Township Levy as posted.

NEW BUSINESS: There was no new business.

FINANCIAL REPORT & PAYING OF BILLS: Board Members reviewed the bills to be paid. Trustee Van Hoorn made a motion to approve the financial report and paying of the bills. Trustee Koonce seconded the motion. A roll call vote was taken: Ayes: 5; Nays: 0. The motion carried and bills were authorized for payment.
