ATLANTA TOWNSHIP ROAD DISTRICT 2025 TAX LEVY ORDINANCE – 2025-01

This is an ordinance levying taxes for all purposes for **ATLANTA TOWNSHIP ROAD DISTRICT**, Logan County, Illinois, for the tax year 2025, collectable in 2026.

BE IT ORDAINED by the Board of Trustees of Atlanta Township Road District, Logan County, Illinois, as follows:

SECTION 1: That the Road Commissioner of Atlanta Township Road District on October 11, 2025, does hereby determine and declare that the sum of: **One Hundred Thousand Three Hundred Sixteen and 15/100 Dollars** (\$100,316.15) is levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as: Personnel Expenses, Contractual Expenses, Commodities Expenses, Capital Outlays and Other Expenditures for the year 2025-2026.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
