

**RESOLUTION 2024-02**  
**SETTING COMPENSATION OF TOWNSHIP OFFICIALS**  
**FOR THE FOUR-YEAR TERM BEGINNING MAY 19, 2025**  
**ATLANTA TOWNSHIP, LOGAN COUNTY, ILLINOIS**

**WHEREAS**, according to 60 ILCS 1/65-20, the compensation of township officers shall be set by the township board at least 180 days before the beginning of the terms of office;

**WHEREAS**, according to 60 ILCS 1/65-20, the compensation for the road district treasurer shall be fixed by the township board and shall not be less than \$100 or more than \$1,000 per year;

**WHEREAS**, according to 605 ILCS 5/6-207, the compensation for the highway commissioner shall be fixed by the township board at an annual salary of not less than \$3,000 to be paid in equal monthly installments or a per diem amount for each day he or she is necessarily employed in the discharge of official duties;

**NOW, THEREFORE, BE IT RESOLVED BY** the Board of Trustees of Atlanta Township that the compensation of the township officials for the four-year term beginning third Monday in May starting May 19, 2025 and ending May 21, 2029 (60 ILCS 1/50-40):


