### Campbell County Conservation District Annual Report July 1, 2015 - June 30, 2016

The Campbell County Conservation District reviewed and revised their Long Range Plan during this fiscal year. They formed various committees to focus on several areas of work included in their 2015-16 Annual Plan of Work.

#### **Executive Committee**

This committee is comprised of Board Chair Ron McCormick (also the committee chair,), Vice Chair Dennis Walter, and Secretary/Treasurer Ken McCormick. Annual staff reviews were completed on time, memorandum of agreements were reviewed annually and edited as needed, and the entire board reviewed the 2015-16 Annual Plan of Work quarterly.

#### **Budget Committee**

This committee is comprised of Secretary/Treasurer Ken (committee chair), Vice Chair Dennis, and Administrative Secretary Linda Grizzell. This committee prepared the draft 2016-17 Annual Budget for the board's approval, reviewed the 2015-16 Annual Budget quarterly, presented any recommendations to the board, and monitored the receipt of compensating tax information from the Kentucky Department of Local Government. Invoices were approved at each meeting and Ken and Field Representative Linda Hunter reviewed and signed the credit card statement, bank statements, and bank reconciliations. Dennis declared the District's 2015 tax rate to Campbell County Fiscal Court at their meeting on September 2, 2015. The committee also monitors financial reporting deadlines entered on the District in Good Standing Report for state direct aid calculations. The District achieved a 100% rating and received bonus dollars as well as the calculated direct aid dollars.

The District's revenue is provided through a county tax on real property and funding from the Kentucky Division of Conservation. Financial reports are available at the district office or can be viewed on the Kentucky Department for Local Government website under Special Purpose Government Entities.

#### **Legislative Committee**

This committee consists of supervisor Pete Garrett and Field Representative Linda Hunter. Pete monitored bills in the House or Senate as they related to the District or county landowners and presented recommendations to the Board. In July Linda Hunter presented resolutions for the board to consider at the Soil & Water Commission meeting at the KACD Convention. Pete is keeping abreast of the eastern by-pass proposal being studied to relieve traffic on the Brent Spence Bridge. If passed, this proposal with take many acres of land and affect agricultural districts. Pete also brought HB 576 to the attention of the board. This bill related to agricultural and horticultural value for property tax assessments. This bill never left the Appropriations and Revenue Committee.

#### **Farmland Work Group**

This committee consists of all the board members and staff as well as the partnering organizations of the Campbell County Cattle Association, Campbell County Farm Bureau Federation, Campbell County Cooperative Extension Service, the Northern Kentucky Horse Network, and the Campbell Conservancy, Inc. A few Campbell County citizens sit on the

committee, too. Supervisor Dennis Walter is the chair. Their main objective is to carry out the elements as outlined in the Farmland Work Group Strategic Plan, developed in 2005 and updated in 2015.

**Backroads Farm Tour-** The seventh annual Campbell County Backroads Farm Tour was held

on July 18, 2015. Visitors enjoyed the warmth and generous hospitality of 14 Campbell County farm owners. The tour attracted more than 1,064 visitors with 3,719 farm visits at all locations. Most of the visitors were from Northern Kentucky and Cincinnati with seven states and 64

cities represented. The tour showcased communitysupported agriculture, vegetable and produce growers, four vineyards, a museum, horse farms, and beef and grain farms. Visitors were directed along some of the county's most scenic back roads while stops along the way offered the opportunity to purchase fresh produce, honey and wine, and learn from some of our best farmers about the farming process.

The third environmental grant is the **Dead Farm Animal Disposal Program** to assist landowners with proper disposal of fallen livestock. This year 52 producers participated in the program. The program also assists the county animal shelter with costs for proper disposal of animals. A total of \$3,863.36 was awarded this fiscal year.

#### Soil Erosion and Water Quality Cost Share Fund -

Two applications from Campbell County were received and approved through the "managing poo" RCPP's (Regional Conservation Partnership Program). Funding for conservation practices under this program will come from two main sources, State Cost Share and the Federal Environmental Quality Incentives Program (EQIP).

#### County Agricultural Investment Program (CAIP)

The District has two representatives on the County Agricultural Development Council who may serve up to two two-year terms. They are Randy Haas and Ron Steffen. The Council is responsible for setting guidelines for KY Agricultural Development Fund programs in Campbell County; the District administers the CAIP program. This fiscal year 28 producers were awarded a total of \$60,083 from Kentucky Agricultural Development Phase I tobacco settlement funds. Projects were completed from ten available investment areas; Campbell County producers completed the large animal, forage and grain improvement, fencing and onfarm water, and farm infrastructure investment areas.



Technical assistance for the District is provided by John Stork, Kenton County Conservation District Manager through a memorandum of agreement with the Kenton County Conservation District, Ian Young-NRCS Supervisory Natural Resource Manger, and Kevin Bryan-NRCS Soil Conservation Planner. NRCS staff currently provides ongoing assistance for five contracts under the 2008 and 2014 Farm Bills. These contracts cover 582 acres of land and are valued at \$48,977. An additional nine EQIP applications were not funded valued at \$50,000.

#### **Rental Equipment**

Board member Ron McCormick houses and maintains

the District's **Cricket 3-ton Lime Spreader**; Ken is a backup. It is available for rent to Campbell County farmers for \$25/day for spreading lime to improve productivity by increasing the soil pH. Before using the lime spreader farmers must attend a safety training program offered by the Campbell County Extension Service. The spreader was purchased as a cooperative effort of the Campbell County Farm Bureau, Campbell County Extension Service, Campbell County Cattle Association, and the Campbell County Conservation District. It was rented by seven farmers this fiscal year and brought in revenue of \$175.

#### **Equipped to serve the community**

The Campbell County Conservation District is a member of the National Association of Conservation Districts, Kentucky Association of Conservation Districts, and Kentucky Association of Conservation Districts Employee Association (KACDE). The employee association helps provide training and support for district employees. District Coordinator Amy Winkler is the KACDE Area 5 Representative.

#### **Kentucky Association of Conservation Districts**

(KACD) –The state convention was held at Bowling Green. Board members Rick Simon, Ron McCormick, and Ken McCormick, attended the meeting as well as staff members John Stork and Linda Grizzell. Ron McCormick, Rick Simon, Ken McCormick, Linda Bray-Schafer, John Stork, Amy Winkler, and Linda Grizzell attended the KACD Area 5 meeting in Owen County at the Owen County Cooperative Extension Service. Board members serve on statewide KACD committees, which meet annually via conference calls: Natural Resources, Rick Simon and Ron McCormick; and Education and Youth, Ken McCormick.

The Conservation District participates in the **10-minute Supervisor Trainings** provided by Division of Conservation Field Representative Linda Hunter during district board meetings.

Board member Ken McCormick is the District's representative on the **Northern Kentucky Urban & Community Forestry Council.** Ken attended their annual dinner at the Plantation Club at Twin Oaks in Covington.

Board Member Linda Bray-Schafer is the District's representative on the Campbell County Economic Progress Authority Board and Green Umbrella's Regional Trails Alliance.

**District Office** - The Campbell County Conservation District office is located in the Campbell County Courthouse in Alexandria through a lease with Campbell County Fiscal Court.

**District Grants** - This fiscal year the District awarded Tree Planting and Urban Forest Enhancement Grants to the Ft. Thomas Tree Commission, the City of Silver Grove, and the Taking Root Northern KY Action Team. The District has been giving matching grants for Tree Planting and Community Beautification since 1993 to help cities and communities establish programs or develop projects to protect and conserve our natural resources. The project must be accomplished on lands located in Campbell County that are owned, leased, or otherwise controlled by city, county, state, or federal government and must include funding or in-kind contributions in an amount equal to the grant request.

#### **Public Relations and Marketing Committee**

staff Amy Winkler make up this committee. Their focus is to promote all District programs and events via the District's website, by increasing our presence on social media, or through other applicable means as recommended by the committee. The District created a new website in house this fiscal year and the address is www.campbellkyconservation.org. It was designed and is maintained by Amy. Amy also maintains the District's Facebook page, which is also very popular and can be found by searching Campbell County Conservation District Kentucky. On YouTube you can see videos from our Right to Farm forums, our Backroads Farm Tours, and our annual awards dinners. These videos are provided through services by Campbell County Media Central.

In August, Ken, Ron, Linda Bray-Schafer, and staff Linda Grizzell and Amy Winkler attended the OKI-**RCC annual tour** hosted by Hamilton County SWCD. Board members participated in the Alexandria Fair & Horse Show by purchasing a fair book advertisement featuring "God Made A Farmer" supporting Campbell County farmers. They also purchased animals at the 4-H/FFA Livestock Sale, in partnership with several other organizations, and sponsored the 4-H Forestry Award (a check for \$25) at the Alexandria Fair and Horse Show. Board member Supervisors Linda Bray-Schafer (chair) and Debbie, and Linda B-S attended the livestock show. There were no forestry entries at the fair for this fiscal year.

#### **Cost Share Programs**

Rick is chair of this committee: others include staff members John and Linda. One of the main duties of this committee is assisting landowners in complying with the Kentucky Agriculture Water Quality Act and to encourage participation in state and federal cost share programs. A total of 617 landowners currently have a self-certification form filed with the District stating that they have developed and are implementing a water quality plan for their operation.

The District offers three types of **environmental grants** from the Kentucky Soil Erosion and Water Quality Cost Share Fund:

Farm Dump Removal Grants assist landowners in cleaning up farm dumps. The District approved three applications this fiscal and awarded three landowners a total of \$9,121.

#### Non-Traditional Agriculture Grants assist

landowners who are not eligible for traditional Farm Bill cost share programs to install practices for the control of sediment and erosion. One application was approved and two landowners were awarded a total of \$2,993 this fiscal year.

#### Right to Farm: Local Buyer Grower Connection-

Our forum on March 14, 2016 was a step in facilitating great new local connections. We wanted to encourage buyers to source local, and we want our local growers to be able to grow their farm business right here at home. Effective discussions were held during the meeting and connections were made between the buyers and growers, A section of the St. Anne Wetlands on Anderson Lane but nothing in whole sale at this time.

**SAE Placement Program-** The Supervised Agriculture Experience Program is a part of the agriculture education curriculum at the Campbell County High School. The Conservation District's Farmland Work Group is partnering with the High School Ag Teachers to assist students in getting handson experience with Campbell County farmers. A placement program was created; it will hopefully be implemented next fiscal year.

Agricultural Districts - There are fourteen agricultural districts in Campbell County with a total of 12,171 acres and 249 landowners.

In April board member Dennis gave a presentation to the Community Leaders Action Group (CLAG). He covered topics that included the purpose and mission statement of the Farmland Work Group, the cost of services study performed by the District, farm business in the County, and other activities and events the committee is doing to promote the value of farming and educating the public on where their food is grown.

#### **Hawthorne St. Anne Advisory Team**

A joint advisory team for the Hawthorne Crossing Conservation Area and St. Anne Woods and Wetlands. composed of members from the District, Conservancy, Fiscal Court, and county citizens researches and discusses issues affecting the Heritage properties. The District now owns two properties acquired through

Grants from the Kentucky Heritage Land Conservation Fund Board; the state holds the conservation easements on them.

District members include supervisors Ken (chair), Rick, Pete (also representing The Campbell Conservancy), and staff Amy Winkler.

#### **Hawthorne Crossing Conservation Area**

The Final Resource Management Plan was completed and submitted to the Kentucky Heritage Land Conservation Fund. Hawthorne Crossing will continue to be monitored in the future and corrective action taken as necessary. Efforts to preserve a log cabin home site continue and a suitable parking area is being pursued to have the property open in the future for hiking, bird watching, nature study. The area will also be designated as a stop along the Licking River for canoeing and kayaking.

#### St. Anne Woods and Wetlands

on Melbourne, KY is open to the public from dawn to dusk each day. Kiosks developed by the St. Anne Wetlands Education Center will help guide you along the established trail. Research is encouraged at this site and visitors are asked to ensure that the research is undisturbed. The northern portion is open by appointment only. The Woods is located adjacent to the St. Anne Retreat Center. This area will be open to the public following the establishment of a public entrance and parking facility.

**Biological Inventory**- The biological inventory for St. Anne Woods and Wetlands was completed and is on file in the Campbell County Conservation District office.

**NKU CER-** The Northern Kentucky University's Center of Environmental Restoration has been approved to complete restoration and preservation work in the St. Anne Woods and Wetlands including invasive species removal.

#### **Education Committee**

Supervisor Ken is the chair of this committee. Other members include supervisors Rick, Debbie, and staff Linda Grizzell. The District holds an annual awards dinner to honor the winners from the Jim Claypool Art and Conservation Writing Contests, scholarship recipients, grant recipients, and either a master conservationist or cooperative of the year is honored. The topic for this year's **art and writing contest** was *The* Wild Side of Kentucky. In the Writing Contest, we had 149 entries from five schools and 809 entries from seven schools in the Jim Claypool art contest. From the Campbell County Conservation District, the art winners received the books Rabbits, Squirrels, and Chipmunks and Birds, Nests, and Eggs. The writing winners received the book Birds of Kentucky Field Guide. All winners received a t-shirt and a certificate of achievement. In Campbell County, the art entries from grades K-2 are judged separately, and that winner received a \$25 check. All teachers received a t-shirt and the book Birds of Kentucky Field Guide. Students also received Legislative Citations from Representatives Joe Fischer, Thomas Kerr, Dennis Keene, and Senator Wil Schroder.
